Interest 8.5% pre- and post-retirement.

Mortality

Pre-retirement: None.

Post-retirement: 1994 Group Annuity Reserving, projected to 2002, blended 50% Male / 50% Female.

§417(e) Stability period is plan year; lookback month is third month preceding plan year.

Top-Heavy Provisions

In the event the plan becomes top-heavy, certain provisions will apply. Generally, a plan is top-heavy if more than 60% of the total present value of accrued benefits and account balances are held for key employees, as defined in the Internal Revenue Code.

Minimum Accrual

Each non-key participant who does not receive a minimum top-heavy allocation in a defined contribution plan of the sponsor shall receive 2% of top-heavy monthly compensation for each year of top-heavy service, up to 10 years.
