Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of the Laminate Technologies, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 – Description of Plan

The following description of the Laminate Technologies, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan document for more complete information.

General

The Plan is a defined contribution plan sponsored by Laminate Technologies, Inc. (the Plan Administrator and Company) and participating affiliates, as defined in the Plan document. Generally, all employees who have one month of service and have attained the age of 18 are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participant Accounts

Each participant's account is credited with the participant's contributions, Company contributions, and an allocation of the Plan's earnings (losses) based upon participant account balances. Participants direct the investment of their contributions among the investment funds offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the vested value of the participant's account.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms of the loan are based on the terms of the individual promissory note. The loans are secured by the balance in the participant's account and bear a reasonable rate of interest. Principal and interest are paid through payroll deductions over a term not exceeding five years unless for loans issued for the purchase of a personal residence.

Contributions

Participants may elect to defer as contributions, on a pre-tax basis, an amount up to the maximum percentage allowable, as defined in the Plan document. Participants over age 50 may also defer catch-up. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company may elect to contribute discretionary matching contributions to the Plan. There were no matching contributions made for the years ended December 31, 2024 and 2023. The Company may also elect to contribute a discretionary profit sharing contribution to the Plan. The discretionary profit sharing contribution is allocated to those eligible participants employed on the last day of the Plan year. Each participant is their own group. For the years ended December 31, 2024 and December 31, 2023, a discretionary profit sharing contribution was made to the Plan. The contribution is allocated to each group in a manner determined by the Company.

Payment of Benefits

On termination of service, death, disability, or retirement, a participant will receive a payment in the amount equal to the value of the participant's vested interest in his or her account. The Plan provides for normal retirement at age 65. The total vested portion of a participant's account balance is distributed in the form of a lump sum payment.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Company matching contributions and profit sharing contributions are fully vested after completing five years of service:

Forfeitures

Forfeited amounts are used to reduce the Company's future contributions. In the event there are no Company contributions, such amounts are otherwise allocated to participant accounts. For the years ended December 31, 2024 and 2023, forfeitures totaling \$31,083 and \$24,368, respectively, were used to reduce Company contributions.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their accounts.

Administrative Expenses

Certain administrative expenses are paid by the Plan, as described in the Plan document. The Company paid for other costs of administering the Plan including professional fees. The services are rendered by parties-in-interest to the Plan.

Note 2 – Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America. Benefit payments to participants are recorded upon distribution.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In contrast, contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. There have been no changes in the valuation methods used. The Plan's investments are held by John Hancock Life Insurance Company (U.S.A.), the Plan's custodian.

The value of the units held in pooled separate accounts are fair valued at the net asset value (NAV). The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liability. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

The John Hancock Guaranteed Interest Account is a guaranteed interest account valued at contract value, which represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement.

Purchases and sales of the investments within the Plan are reflected on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent outstanding loans and are measured at their unpaid principal balance plus accrued interest.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that could affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

Management has evaluated subsequent events through July 28, 2025, the date the financial statements were available to be issued.

Note 3 – Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, interest income, and net appreciation (depreciation) of investments for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by John Hancock Life Insurance Company, the Plan's custodian.

Note 4 – Guaranteed Investment Contract

The Plan holds a traditional investment contract that meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. The guaranteed investment account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a monthly basis for resetting.

Participants may ordinarily direct the withdrawal of all or a portion of their investment at contract value without adjustment. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer. The guaranteed interest account may be terminated under certain circumstances as described in the contract.

Note 5 – Fair Value Measurements

The various inputs that may be used to determine the value of the Plan's investments are summarized in three broad levels within the fair value hierarchy. The three levels are described below:

Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly; and

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Plan's investments valued at fair value in the statements of net assets available for benefits are all pooled separate accounts, which are valued using NAV as described previously, and therefore not required to be categorized within the fair value hierarchy.

Note 6 – Restrictions on Net Assets

Certain investments may be subject to restrictions and/or may charge redemption fees, as defined by the John Hancock short-term trading policy. In addition, in each reporting year, a participant may transfer, at book value, a total of 20% of the account balance of the guaranteed investment contract to any funds available under the contract except a money market or stable value fund.

Note 7 – Income Tax Status

The Internal Revenue Service ruled on June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan with CODA (the underlying document upon which the Plan is based) qualifies under Section 401 of the Internal Revenue Code (IRC) and the related trust is, therefore, not subject to tax under present income tax law. Subsequent to this ruling, the Plan was amended. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan Administrator believes the Plan is currently designed in compliance with the applicable requirements of the IRC and has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that, more likely than not, would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.
