Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedule Required by ERISA

The supplemental schedule, Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For



information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

Notes to Financial Statements

1. Description of Plan

The following description of the ShelterLogic Corp. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a complete description of the Plan's provisions.

General

The Plan is a contributory defined contribution plan sponsored by ShelterLogic Corp. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Principal Trust Company (Principal) is the trustee and Principal Financial Group is the recordkeeper of the Plan. The Company is responsible for oversight of the Plan, determining the appropriateness of the Plan's investment offerings, and monitoring investment performance.

Eligibility

The Plan is available to all employees of the Company who have completed three months of service and are at least 21 years of age. Employees subject to a collective-bargaining agreement, non-resident aliens, and leased employees are excluded from participation in the Plan. Prior to January 1, 2024, part time, temporary, and seasonal employees who generally work fewer than 1,000 hours per year were also excluded from participation in the Plan.

In accordance with the Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0, the Company expanded Plan eligibility to include long-term, part-time (LTPT) employees beginning January 1, 2024. Such employees were identified as those who worked at least 500 hours in each of the three consecutive preceding years.

Contributions

Each year, participants may contribute from 1% to 60% of their pre-tax annual compensation, as defined by the Plan, up to Internal Revenue Code (IRC) limits. Participants may also designate some or all of their contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

The Company makes non-discretionary safe harbor matching contributions to the Plan equal to 100% of elective deferrals, up to a participant's first 4% of eligible compensation deferred. All contributions are subject to certain Internal Revenue Service (IRS) limitations. The Company contributed safe harbor matching contributions of \$624,800 and \$631,176 for the years ended December 31, 2024 and 2023, respectively.

Contributions are invested by Principal according to the options elected by the participants. All participant and Company contributions are directed by the participant among the available investment options. Investment earnings are automatically reinvested into the fund or portfolio from which they were derived.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, rollovers, and the safe harbor matching contributions plus actual earnings thereon. For participants who received employer contributions prior to January 1, 2010, vesting in the Company contribution portion of their account is based on credited years of service. For such contributions, a participant is 100% vested after three years of credited service.

In the event of termination due to death, disability, or upon reaching normal retirement age, participants shall become 100% vested in the Company contribution portion of their account.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the vested balance in the participant's account. The loan interest rate, determined at the time of the loan, is set at 2% above the prime rate. The interest rates on notes outstanding at December 31, 2024 and 2023 were between 4.25% and 10.50%. Repayments are made through weekly payroll deductions with a payback period of five years, unless purchasing a primary residence for which the loan will have a maximum payment of 20 years. No more than two notes are allowed at any time and repayment of the entire balance is permitted at any time.

Payment of Benefits

Participants' benefits under the Plan are payable to participants or their beneficiaries upon termination of employment, normal retirement, disability, financial hardship, or death. Benefits are payable in one lump-sum payment or in installments. Partial or installment payments are also permitted to satisfy required minimum distribution rules. Hardship withdrawals are available, as are in-service distributions, to participants who have attained the age of 59½. If a participant's employment terminates with the Company, through December 31, 2023, the Plan permits distribution of the participant's account, not in excess of \$5,000, to be cashed out or transferred to an individual retirement account (IRA) without the participant's consent. Effective in 2024, the threshold was raised to \$7,000.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1 and \$0, respectively. These accounts may be used to pay administrative expenses or reduce future Company contributions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by Principal. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation in fair value of investments includes the Plan's gains and losses on investments bought, sold, and held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Contract administration and recordkeeping fees are paid by the Plan. Investment-related expenses are included in net appreciation in fair value of investments.

The Plan has a revenue-sharing agreement with Principal for the reimbursement of Plan expenses. Revenue earned from this agreement was used to pay Plan expenses and is presented in other income in the statements of changes in net assets available for benefits. For the years ended

December 31, 2024 and 2023, revenue earned from this agreement amounted to \$23,793 and \$21,437, respectively. Plan expenses paid out of this revenue amounted to \$23,768 and \$21,431, respectively, for the years ended December 31, 2024 and 2023. Direct compensation paid by the Plan as administrative expenses totaled \$78,862 and \$70,506 for the years ended December 31, 2024 and 2023, respectively.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the assets or liabilities.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts - The common collective trusts are valued at the NAV of units of a bank collective trust. The NAV, as provided by the trustee of the CCTs, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of a common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There are no redemption fees or notice periods and no unfunded commitments as of December 31, 2024 and 2023. These are direct filing entities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Principal or its subsidiaries and affiliates. Participant loan and distribution processing fees are paid to Principal by participants. The Plan receives revenue credits from Principal. The Plan also issues loans to participants, which

are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA by delivering to the Trustee and third-party administrator written notice of such termination. Upon termination of the Plan, no further contributions will be made to the Plan, and all participants' accounts would become fully vested.

7. Tax Status

The Plan uses a pre-approved plan document sponsored by Principal. Principal received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved document, as then-designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

The Plan has evaluated subsequent events through July 25, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, in accordance with the SECURE Act 2.0, the Company implemented the provision for Super Catch-Up Contributions for participants aged 60 to 63 and eligibility for LTPT employees included those who worked 500 hours in each of the two consecutive preceding years. There were no subsequent events requiring adjustments to additional disclosure to the financial statements.
