NOTE A - GENERAL DESCRIPTION OF THE PLAN

The following description of the Penn Community Bank Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering substantially all employees of Penn Community Bank (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions - Eligible participants may defer up to 90% of their gross wages into the Plan on a pre-tax basis to a regular 401(k) account or on an after-tax basis into a Roth 401(k) account. Participant deferrals cannot exceed the maximum allowable dollar amount per year (\$23,000 for 2024). The Company matches 100% of participants elected deferral that do not exceed 6% of their compensation. Participants who reach age 50 or older and contribute the maximum permitted under the Plan may make an additional pre-tax contribution (a "catch-up contribution") of up to \$7,500. Participants may also contribute amounts representing distributions from other qualified benefit plans (via a rollover into the Plan).

Additional profit-sharing amounts may be contributed at the discretion of the Company not to exceed 4% of participant's compensation. There was no discretionary contribution during 2024.

Participation - An employee may become a participant of the Plan on the first of the month following two consecutive months of service as well as meeting the age requirement of 18.

Participant Accounts - Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings/(losses). Participants have access to their accounts 24 hours a day/7 days per week via a toll-free telephone number and a website. Fund transfers and investment election changes may be elected daily. A participant may stop, start, or change their 401(k) salary deferral rate on the first day of each month.

Plan Loans - Active employees may elect to take up to two loans from the Plan at any given time at a minimum loan of \$1,000. As required by law, a loan amount is limited to the lesser of \$50,000 or 50% of the participant's vested account and must be repaid within five years unless the loan is for the purchase of a primary residence. Loan repayments are processed via payroll deduction on an after-tax basis.

Investment Options - Upon enrollment in the Plan, participants may direct their contributions and Employer contributions in a variety of investment options.

Vesting - Participants are always 100% vested in their own 401(k) salary deferrals including Roth 401(k) deferrals and “catch-up contributions,” safe harbor matching contributions and rollover contributions. Assets merged from First Savings Bank of Perkasio 401(k) Profit Sharing Plan will remain on a 6-year graded vesting schedule for employer discretionary match and profit sharing contributions. For newly eligible participants who enter the plan on January 1, 2016 and after are fully vested in their employer discretionary non-elective (profit sharing) contributions and employer discretionary matching contributions after 3 years of service. For participants who were in the First Federal Savings and Loan Assn. of Bucks County 401(k) and First Savings Bank of Perkasio 401(k) Profit Sharing Plan prior to January 1, 2016, they are 100% vested in the employer discretionary non-elective (profit sharing) and vested in their employer discretionary match based on their years of service (Year 1 - 0%, Year 2 - 50%, Year 3 - 100%). Regardless of the vesting schedule, a participant will become fully vested upon death, disability, and at normal retirement age. Refer to the Plan document for vesting status for participants of the First Federal Savings and Loan Assn. of Bucks County 401(k) Plan and the First Savings Bank of Perkasio 401(k) Profit Sharing Plan prior to January 1, 2016.

Payment of Benefits - Upon termination of service, including instances due to death, disability, or retirement, a participant or their beneficiary may elect to receive an amount equal to the value of the participant’s account as a lump-sum distribution. In the event of a hardship, an active employee may elect a withdrawal from their elective deferral contributions.

Plan Termination - Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become fully vested and the net assets of the Plan will be distributed to the participants in an order of priority determined in accordance with ERISA and its applicable regulations and the Plan document.

Forfeited Accounts - Forfeitures shall be used to supplement employer contributions and pay Plan expenses. The forfeiture nonvested account balance at December 31, 2024 and 2023 was \$59,996 and \$61, respectively. Forfeitures in the amount of \$7,113 for the year ended December 31, 2024 were used to pay plan expenses and to offset employer contributions.

Administration of the Plan - The Plan is administered by a committee of seven members who are appointed and may be removed by the Company’s Board of Directors.

Plan Amendments - On December 29, 2022, the “Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act” was signed into law in the Under States. The Secure 2.0 Act is an expansion of the Secure Act passed during 2019. The Act includes several mandatory and optional provisions that will become effective across several years. The Secure 2.0 Act aims to expand retirement access, increase retirement savings, and simplify plan administration. Plans may choose to operationally implement the provisions of the Secure 2.0 Act, however plan administrators have until December 31, 2026 to officially amend the plan document to reflect the provisions adopted by the plan.

Date of Management’s Review - Management has evaluated subsequent events through July 17, 2025, the date which the financial statements were available to be issued.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Investments - Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds with various investment strategies and a common collective trust.

Valuation of Investments - Plan investments in the common collective trusts and mutual funds (registered investment companies) are stated at fair value. Shares of mutual funds are valued at quoted market prices. The Plan’s investments in the common collective trust are stated at net asset value per share as a practical expedient. Net appreciation or depreciation of investments is reported on the statement of changes in net assets available for benefits and consists of realized gains and losses and the unrealized appreciation or depreciation of these investments. All underlying investments options are valued daily. This daily price is considered the selling price for transfers and withdrawals and is calculated each day the principal market is open and available to any participant in the Plan.

Purchases and sales of mutual funds shares are recorded at end of day net asset value. Dividends are recorded as of the record date. Purchases and sales of common collective trusts are recorded at fair value using net asset value, as a practical expedient.

Participant Loans Receivable - All transactions are measured at their unpaid principal balance plus any accrued but unpaid interest. The Financial Accounting Standards Board believes that any individual credit risk related to participant loans is mitigated by the fact that these loans are secured by the participant’s vested balance. If a participant were to default, the participant’s account balance would be offset by the unpaid balance of the loan, and the participant would be subject to tax on the unpaid loan balance. As such, the participant is the only party affected in the event of a default.

Investment Income Recognition and Method of Accounting - All transactions are recorded on the accrual basis. Purchases and sales of investments are recorded based on the trade date. Interest and dividends are recorded when received. Capital gain distributions are included in dividend income. Realized gains or losses on security transactions are determined using the average cost of securities sold on the trade date. Expenses are recorded as incurred.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

Plan Expenses - Certain administrative expenses of the Plan are paid by the Company. Investment and recordkeeping expenses are paid by the Plan and/or the participants to the extent that such expenses are not paid by the Company. Any investment expenses associated with the Plan's investments are netted with earnings by Charles Schwab Bank, the Plan's custodian, and reported to the Plan as a net amount. Loan and distribution administration fees paid by participants, in combination with administrative fees totaling \$145,499 for the year ended December 31, 2024, are reflected on the Plan's statement of changes in net assets available for benefits.

NOTE C - TAX STATUS OF THE PLAN

The Plan participates in a volume submitter plan. The volume submitter plan received a favorable opinion letter on June 30, 2020, from the Internal Revenue Service (IRS) indicating that the Plan is a qualified plan under Section 401(k) of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator analyzed the tax positions by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or asset or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE D - FAIR VALUE MEASUREMENTS

FASB ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 inputs to the valuation methodology include:
 1. Quoted prices for similar assets or liabilities in active markets;
 2. Quoted prices for identical or similar assets or liabilities in inactive markets;
 3. Inputs other than quoted prices that are observable for the asset or liability;
 4. Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - PARTY IN INTEREST TRANSACTIONS

The Plan issues loans to participants, which are secured by the balances in the participants' accounts. These transactions qualify as party in interest transactions allowable under ERISA guidelines.

NOTE F - RELIANCE ON CUSTODIAN'S REPORT

NOTE G - RISKS AND UNCERTAINTIES

Investments of the Plan are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect investment assets reported in participant account balances and in the statements of net assets available for benefits.

NOTE H - SUBSEQUENT EVENT

Effective January 1, 2025, the Plan was amended to eliminate safe harbor contributions and revise the employer match vesting schedule from a three-year cliff schedule to a three-year graded schedule. All participants employed on December 31, 2024 were 100% vested in employer match contributions received as of that date.
