Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Running Supply Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Running Supply Inc. 401(k) Profit Sharing Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Running Supply Inc. 401(k) Profit Sharing Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule as listed in the accompanying index is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO THE FINANCIAL STATEMENTS

A. Description of Plan

The following description of the Running Supply, Inc. ("Company") 401 (k) Profit Sharing Plan ("Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. **General.** The Plan is a defined contribution plan covering all full-time employees of the Company who have 500 hours of service within the six month period following hire date and are age twenty-one or older, and all long-term part-time employees who have three consecutive years of employment with at least 500 hours of service and are age twenty-one or older (reducing to two consecutive years on January 1, 2025). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees oversees governance of the Plan.
2. **Contributions.** Participants may contribute 75% of their payroll period compensation or the maximum amount of pretax annual compensation allowed by the Internal Revenue Service, as defined in the Plan. The Plan also allows participants who have attained age 50 before the end of the Plan year to contribute catch-up contributions under the Economic Growth and Tax Relief Reconciliation Act (EGTRRA) provisions up to the maximum allowed by the Internal Revenue Service. Participants are allowed Roth Elective Deferrals as an employee contribution option. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan has adopted the Safe Harbor provision under Section 401(k). The Company contributes a matching dollar amount equal to one hundred percent of the first three percent of compensation and fifty percent of the next two percent of compensation. Additional amounts may be contributed at the option of the Company's board of directors. Contributions are subject to certain limitations.
3. **Participant Accounts.** Each participant's account is credited with the participant's contribution and allocation of (a) the Company's matching contribution, (b) Plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. **Vesting.** Participants are immediately 100% vested in their contributions, as well as the Company's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company discretionary profit sharing contributions portion of their account, plus actual earnings thereon, is based on years of continuous service based on the following table.

5. **Investment Options.** Upon enrollment in the Plan, a participant may direct contributions in various investment options. Participants may change their investment options at any time.
6. **Payment of Benefits.** The Plan document allows for partial withdrawals as a distribution option. Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of his or her account or partial withdrawals of at least \$5,000. Participants experiencing serious financial hardship may be entitled to a distribution upon approval by the Plan administrator.
7. **Forfeited Accounts.** Forfeited non-vested accounts totaled \$4 and \$41 as of December 31, 2024 and 2023, respectively. Forfeited non-vested accounts will be used to reduce future Company's matching contributions or Plan expenses. No amounts will be reallocated to participants. In 2024, the Plan reduced employer contributions by \$37 and Plan expenses by \$-0- from forfeited non-vested accounts. In 2023, the Plan did not reduce employer contributions or Plan expenses from forfeited non-vested accounts.

B. Summary of Significant Accounting Policies

Estimates

The preparation of the financial statements requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Reclassifications

Certain amounts in the prior year data have been reclassified in order to be consistent with the current year's presentation. The total amount of Net Assets Available for Benefits did not change.

Basis of Accounting

The financial statements of the Plan are prepared under a modified cash method of accounting, which is a comprehensive basis of accounting other than GAAP. That is, the assets and net changes in assets are reflected on a cash basis except for the value of investments, which are reported at fair value and contract value.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

For further information on fair value measurements, see Note C. For further information on the fully benefit-responsive investment contract, see Note D.

Purchases and sales of securities are recorded on a trade-date basis. Dividends and interest income are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Significant Plan Costs

Significant operating costs of the Plan, including trustee fees, audit fees, and fidelity insurance premiums are paid by the Plan sponsor (Running Supply, Inc.). The sponsor receives no reimbursement from the Plan. Contract administration fees are paid by the Plan.

Subsequent Events

The SECURE Act 2.0 was signed into law on December 29, 2022, and includes various provisions affecting the Plan. The Board of Trustees approved plan amendments to implement automatic enrollment and escalation provisions, modify the definition of long-term part-time worker, and increase catch-up contribution limits in accordance with SECURE Act 2.0. These plan amendments are effective January 1, 2025. Formal amendments to the plan document pursuant to SECURE Act 2.0 are in progress and must be completed by December 31, 2025.

On March 28, 2025, the Board of Trustees approved a plan amendment to allow participants to elect a distribution to a designated Roth contribution account within the Plan (referred to as an In-Plan Roth Rollover Contribution). This plan amendment is effective July 1, 2025.

On July 24, 2024, the Board of Trustees approved a plan amendment to increase the balance required for a terminated employee to postpone distribution from the Plan from \$5,000 to \$7,000. This plan amendment is effective January 1, 2025.

The Plan has evaluated subsequent events through July 11, 2025, the date the financial statements were available to be issued.

C. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: A mutual fund is an investment company registered under the Investment Company Act of 1940 that pools the capital of many investors and invests it in stocks, bonds, short-term money market instruments, and/or other securities. Mutual funds have an observable level 1 pricing input, as the fair value of mutual funds are publicly quoted pricing inputs. Therefore, mutual funds have a readily determinable fair value. The fair value is based on third-party pricing vendors and utilizes observable market information.

Participant Choice Retirement Account: All of the holdings in the Participant Choice Retirement Account are publicly traded securities for which holding detail and pricing are publicly available. The Participant Choice Retirement Accounts is reported as a level 1 asset.

Transfers Between Levels

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

We evaluate the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. There were no transfers between levels during the years ended December 31, 2024 and 2023.

D. Group Annuity Contract with Standard Insurance Company

The plan entered into a traditional fully benefit-responsive guaranteed investment contract with Standard Insurance Company totaling \$1,257,628 and \$1,937,027 at December 31, 2024 and 2023, respectively. Standard Insurance Company maintains the contributions in a general account. The account is credited with actual earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is set by Standard Insurance Company using a process similar to that used by banks or other insurance companies for similar products and may not be less than 1.00%. The guaranteed investment contract permits the insurance company to terminate the contract with 30 days written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification, and failure to adopt the plan in a reasonable period of time.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard Insurance Company, represents contributions made to the plan under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that participants' contract values are not affected. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the plan to transact at contract value with the participants.

E. Certified Investments

The fair value and contract value of the investments held as of December 31, 2024 and 2023 included on the statements of net assets available for benefits-modified cash basis, the net appreciation in fair value, interest and dividends included on the statement of changes in net assets available for benefits-modified cash basis for the year ended December 31, 2024, and the accompanying notes to the financial statements and ERISA-required supplemental schedule, were obtained by management and agreed to or derived from information certified as complete and accurate by Charles Schwab Trust Bank (custodian of the plan), a qualified institution, in accordance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974 (ERISA) Section 103(a)(3)(C). The information certified includes total cash and investments of \$31,559,688 and \$28,108,180 at December 31, 2024 and 2023, respectively. Investment earnings certified for 2024 was \$3,792,288.

F. Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Charles Schwab Trust Bank. Charles Schwab Trust Bank is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Charles Schwab Trust Bank provides certain administrative services to the Plan. Charles Schwab Trust Bank receives revenue from mutual fund service providers for services Charles Schwab Trust Bank provides to the funds. This revenue is used to offset certain amounts owed to Charles Schwab Trust Bank for its administrative services to the Plan. If the revenue received by Charles Schwab Trust Bank from such mutual fund providers exceeds the amount owed, Charles Schwab Trust Bank remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expense or allocated to the accounts of the participants. During 2024, there was \$12,744 in excess amounts which is reported with net appreciation in fair value of investments for the year ended December 31, 2024.

Milliman is the Plan administrator, and therefore, qualifies as a party-in-interest. Milliman provides Plan maintenance to the Plan. Fees paid by the Plan for Plan maintenance amounted to \$97,377 for the year ended December 31, 2024.

Fees paid by the Plan to All-Star Financial for consulting services amounted to \$-0- for the year ended December 31, 2024.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

G. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

H. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by an opinion letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Financial statements prepared in accordance with the modified cash basis of accounting require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

I. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits-modified cash basis.

J. Plan Amendments

Running Supply, Inc. finalized the purchase of 8 stores from Home of Economy on September 4, 2024. On July 16, 2024, The Board of Trustees passed a resolution to modify the Plan document to allow Home of Economy's employees who have met the eligibility requirements with their previous employer to immediately participate in the plan.
