NOTE A – DESCRIPTION OF PLAN

The following description of the Electrical Wholesale Supply Co., Inc. 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan that was established January 1, 1990 for the benefit of employees of Electrical Wholesale Supply Co. The Plan allows for all employees who were at least 18 years of age and have completed ninety days of service to be eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make voluntary tax-deferred or after-tax contributions to the Plan through payroll deductions up to applicable Internal Revenue Service (IRS) limits. Participants may also contribute amounts representing rollovers from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan’s provisions permit profit-sharing contributions to the Plan at the discretion of the Sponsor.

Participant accounts

Participants are allowed to direct how all elective contributions (including rollover contributions) will be invested. Nonelective profit-sharing contributions made by the Sponsor are invested at the Sponsor’s discretion. The Plan provides various investment options that offer a diversity of investment risk and return. Each participant’s account is credited with any contributions made to the account and increases or decreases in the market value of investments. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants are 100% vested in their contributions and related earnings. Profit sharing contributions vest over a period of six years with 100% of the vesting occurring after six years of service as follows:

Payment of benefits

Upon termination of service, death, disability, or retirement, a participant may elect to receive a distribution of their vested account balance in the form of a lump-sum payment, a direct rollover to a traditional individual retirement account (IRA), or in installments.

Administration of the Plan

The Plan is administered by the Sponsor in the form of a trustee committee consisting of management personnel. Empower Trust Company, LLC holds and invests Plan assets in accordance with directions from the participant and plan Sponsor. Records of participant account activity are processed and maintained by Empower Trust Company, LLC which also performs other administrative support services for the Plan.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of significant accounting policies applied in the preparation of the accompanying financial statements follows:

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – CONTINUED

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gain and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Profit sharing contributions from the Plan Sponsor are recorded in the year in which the Sponsor designates the contribution.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Substantially all fees and expenses incurred for administration of the Plan are paid by the Plan.

Subsequent events

The Plan has evaluated subsequent events that occurred after the balance sheet date through June 30, 2025, the date its financial statements were available to be issued and concluded there were no other events or transactions occurring during this period that required recognition or disclosure in the financial statements.

NOTE C – ADMINISTRATION OF PLAN ASSETS

The Plan's assets are held by Empower Trust Company, LLC, the custodian of the plan. Sponsor and participant contributions are held and managed by the custodian, which invests cash received, interest, and dividend income and makes distributions to participants.

NOTE E – PLAN TERMINATION

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE F – TAX STATUS

The Plan obtained its most recent determination letter dated November 14, 2022, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable IRS requirements. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability, asset, or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE H – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE I – FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded. The fair values of mutual funds are based on the closing price reported on the active market where the individual securities are traded.
