### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of MOD-PAC CORP. Profit Sharing/401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### NOTES TO FINANCIAL STATEMENTS AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2024 AND 2023

---

#### 1. PLAN DESCRIPTION

The following description of the MOD-PAC CORP. Profit Sharing/401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

**General** – The Plan is a prototype, non-standardized 401(k) profit sharing plan, sponsored by MOD-PAC CORP. (the “Company” or “Plan Sponsor”). The Plan is funded by employee and employer contributions and covers substantially all full-time employees of the Plan Sponsor who have completed at least four months of service and who are not covered by a collective bargaining agreement or are not non-resident aliens. The Plan has an automatic enrollment feature, in which employees are automatically enrolled in the Plan at 3% of eligible compensation, with automatic increases of 1% annually, up to 7%, effective January 1<sup>st</sup> of each year, upon reaching eligibility. The employee has the ability to opt out of this arrangement prior to entering the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Contributions** – Participants may elect to contribute up to 100% of their eligible Plan defined compensation on a pre-tax basis as well as make Roth contributions to the Plan, limited to the Internal Revenue Code (“IRC”) maximum. Roth contributions are further limited to 10% of eligible compensation. Additionally, participants age 50 or older can elect to make a catch-up contribution limited to the amount imposed by law. Participants may also contribute rollover amounts representing distributions from other defined contribution plans and certain IRAs. The Company matches 100% of the first 2% and 50% on the following 2% up to a maximum of 4% of eligible compensation contributed to the Plan by the participant immediately on becoming eligible to participate in the Plan. The Company, at its discretion, may also make a pro-rata profit sharing contribution to certain eligible participants based on each eligible participant’s compensation for the Plan year. Profit sharing contributions may be made to eligible participants who have completed one year of service, who have completed at least 1,000 hours of service during the Plan year and are current employees on the last day of the Plan year. There were no discretionary profit-sharing contributions for the years ended December 31, 2024 and 2023.

**Participant Accounts** – Individual accounts are maintained for each Plan participant. Participant accounts are increased by participant contributions, Plan Sponsor contributions, and the participant’s share of Plan earnings. Participant accounts are decreased by participant distributions and the participant’s share of Plan expenses and losses. The allocation of earnings and losses to participant accounts is based upon the value of an individual account in relation to the total assets of the Plan. Upon retirement or termination, a participant is entitled to the vested balance in his or her account.

**Vesting** – Participants are immediately vested in their voluntary contributions, rollovers and actual earnings thereon. Vesting in Company contributions and actual earnings thereon is based on years of credited service, with 10% vested per year for the first two years and 20% vested per year for the next four years. A participant is 100% vested after six years of service.

## 1. PLAN DESCRIPTION (continued)

**Forfeitures** – Participants not fully vested in their employer contributions upon termination of employment forfeit their non-vested balances. Forfeitures may be utilized at the discretion of the Plan Sponsor. During the year ended December 31, 2024, \$19,780 of forfeitures were used to pay Plan expenses. During the year ended December 31, 2023, \$7,177 and \$13,959 of forfeitures were used to reduce employer contributions and pay Plan expenses, respectively. There were forfeitures of \$38,483 and \$7,231 available at December 31, 2024 and 2023, respectively.

**Notes Receivable from Participants** – Participants may borrow from their fund accounts a minimum of \$1,000 or up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A loan is secured by the balance in the participant's account and bears interest at rates commensurate with local prevailing rates, as determined by the plan administrator. Notes bear interest at rates ranging from 4.75% to 10.00% and mature through September 2033. Principal and interest are paid through regular payroll deductions.

**Administrative Expenses** – Costs of administering the Plan are paid by both the Plan Sponsor and the participants.

**Payment of Benefits** – On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of his or her vested account balance, or annual installments over various terms. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

**Withdrawals and Distributions** – The Plan allows for in-service withdrawals for employees who attain the age of 59 ½ or immediate financial hardship, as defined by the IRC.

**Plan Termination** – Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in the employer's contributions and associated interest and earnings.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting.

**Investment Valuation and Income Recognition** – The Plan determines the fair value of assets and liabilities, which are subject to be reported at fair value based on U.S. generally accepted accounting standards. The standard establishes a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded, on an exchange. Level 2 inputs generally consist of market prices for identical assets, which are not actively traded, or market prices of similar assets or liabilities, which are actively traded, on an exchange.

Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies.

Under the hierarchy, Level 1 inputs are the most preferred followed by Level 2, and Level 3. Level 3 inputs are to be used when neither Level 1 nor Level 2 inputs are available. As of December 31, 2024 and 2023, all of the Plan's assets were valued as Level 1.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

An investment's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for investments measured at fair value as of December 31, 2024 and 2023:

*Registered investment companies:* Valued based on the quoted market price available on an active market, which represents net asset values of the shares held by the Plan at year end (level 1).

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Plan presents in the statements of changes in net assets available for benefits the net appreciation in fair value of investments, which includes the net unrealized and realized gains and losses on those investments that were held or sold during the period.

Purchases and sales of securities are recorded on a trade-date basis. Interest is accrued when earned. Dividend income is recorded on the ex-dividend date.

*Payment of Benefits* – Benefits are recorded when paid.

*Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

*Subsequent Events* – Management has evaluated the effects of all subsequent events through July 25, 2025, the date the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustments or disclosure in the financial statements.

## 3. TRANSACTIONS WITH PARTIES IN INTEREST

All Plan investments are managed by The Vanguard Group. As Vanguard Fiduciary Trust Company ("Vanguard"), the trustee of the Plan, is a member of The Vanguard Group, these transactions qualify as party in interest transactions.

## 4. INCOME TAX STATUS

The Plan has adopted a Prototype Non-standardized Profit-Sharing Plan (the "Pre-approved Plan"). The Pre-approved Plan received an Opinion Letter from the IRS dated June 30, 2020, stating that the form of the Plan is acceptable under 401 of the Code for use by employers for the benefit of their employees. Accordingly, no provision has been made for Federal income taxes in the accompanying financial statements.
