INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Board of Directors
Three Rivers Community Action, Inc. Retirement Plan
Zumbrota, Minnesota

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Three Rivers Community Action, Inc. Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Three Rivers Community Action, Inc. Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

1. DESCRIPTION OF THE PLAN

The following description of Three Rivers Community Action, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution 403(b) plan covering all eligible employees of Three Rivers Community Action, Inc. (the Employer). Employees are eligible to participate in the Plan on their date of hire. The Plan excludes employees regularly scheduled to work less than 20 hours per week.

The Employer is the Plan Sponsor and Plan Administrator. Mid Atlantic Trust Company is the custodian for the Plan. Additionally, Mutual of America is the third party administrator of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Investments were held in mutual funds and a money market fund at December 31, 2024 and 2023.

Contributions - Participants are allowed to make elective, pretax (traditional 403(b)) deferral contributions or elective after-tax (Roth 403(b)) deferral contributions up to Internal Revenue Service limits and not to exceed 100% of pretax annual compensation, as defined in the Plan. The Plan allows participants age 50 and older to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Employer may make discretionary matching and non-elective contributions. Participants are eligible for employer matching contributions once they have completed 1,000 hours of service and have been employed for at least one year. During 2024 and 2023, the Employer made matching contributions of 100% up to 6% of each participant's eligible compensation. During 2024 and 2023, the Employer did not make a non-elective contribution to the Plan.

Vesting - The participant's elective deferrals, rollover contributions, and the Employer's matching and non-elective contributions and earnings thereon are always 100% vested. Notwithstanding the above, a participant's account will be fully vested upon death, disability or retirement.

1. **DESCRIPTION OF THE PLAN (Continued)**

Participant Accounts - Each participant's account is credited with the participant's contributions plus an allocation of (a) the Employer's matching contributions, (b) the Employer's non-elective contributions, and (c) Plan earnings and changes in the value of investments, net of expenses. Allocations are based on account balances or participant earnings as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures - Forfeitures can be used to pay Plan expenses and to reduce employer contributions. There were no forfeitures in 2024 or 2023.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's account in either a lump-sum amount, or in annual installment options as specified in the Plan. For termination of service due to other reasons, participants with vested accounts of less than \$5,000 will have their vested balance distributed as soon as administratively possible. Participants with vested accounts greater than \$5,000 may receive the value of the vested interest in his or her account as a lump-sum distribution, partial withdrawal, or minimum required distribution. The Plan also allows for in-service withdrawals subject to Plan provisions.

Investment Options - Participants are allowed to direct the investment of their contributions among the various investment options offered by the Plan. Employer contributions are allocated on the same basis as employee contributions.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

2. **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

2. **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)**

Estimates - The preparation of any financial statements in accordance with U.S. generally accepted accounting principles may require management to make estimates and assumptions that affect certain amounts reported and disclosed in the financial statements. Actual results could differ from such estimates.

Valuation of Investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded when earned and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the Plan year.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - The Employer pays certain administrative expenses on behalf of the Plan. Expenses that are paid from Plan assets are reflected in the statement of changes in net assets available for benefits.

3. **INFORMATION CERTIFIED BY THE CUSTODIAN**

The following information included in the accompanying financial statements was obtained from data that was prepared and certified as complete and accurate by Mid Atlantic Trust Company, the custodian of the Plan.

In addition, Mid Atlantic Trust Company has certified all data used to derive the information included in the supplementary schedule of assets (held at end of year) as of December 31, 2024, to be complete and accurate.

4. INCOME TAX STATUS

The volume submitter adopted by the Plan obtained its latest advisory letter on March 2, 2020, in which the Internal Revenue Service stated that the volume submitter, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the advisory letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected.

5. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means; and Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement and have the lowest priority.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the methodology used to measure the fair value of the Plan's investments. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market fund: Valued at the daily closing price as reported by the fund. The money market fund held by the Plan is registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their employer contributions and all of the assets will be distributed to the participants based upon the balance in their respective accounts.

7. PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are held by Mid Atlantic Trust Company who is the Plan custodian and, therefore, these transactions qualify as party-in-interest transactions.

Certain investments are managed by the Plan's third party administrator.

Fees paid by the Plan for administrative services amounted to \$40,172 for the year ended December 31, 2024.

The Plan's sponsor pays certain administrative expenses of the Plan.

8. SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan was amended to implement a Safe Harbor provision.

Management has evaluated subsequent events through July 11, 2025, the date on which the financial statements were available for issue.
