

**NOTE 1 – DESCRIPTION OF PLAN**

Nine Energy Service 401(k) Plan (the Plan) is a qualified retirement plan adopted by Nine Energy Service, LLC (the Company), to enable eligible employees to save for retirement. The Plan was originally effective September 26, 2012, and was amended and restated effective January 1, 2023. The Plan is administered by the Company and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The summary of significant provisions of the Plan presented below provides only general information. Participants should refer to the plan document and trust agreement for a more complete description of the Plan's provisions.

Eligibility: All non-excluded employees of the Company are eligible to participate in the Plan on the first day of the month after attaining the age of 18 and completing one month of service with the Company.

Contributions: Participants may elect to defer a percentage (up to 75%) of their eligible compensation to the Plan, not to exceed the dollar annual limit set by law. Participants may make deferrals as a pre-tax or Roth deferral contributions and after-tax contributions to the Plan. Participants who are at least age 50 by the end of a Plan year may make additional catch-up contributions during the Plan year.

The Company provides safe harbor matching contributions to all eligible participants in an amount equal 100% of the first 3% of each participant's eligible compensation, and 50% of the next 2%. Additionally, the Company may make discretionary matching contributions and discretionary nonelective contributions to the Plan. For 2024, the Company did not make any discretionary matching or nonelective contributions to the Plan.

Participants can roll over part or all of an eligible rollover distribution they receive from an eligible retirement plan as rollover contributions into this Plan.

Participant Accounts: Each participant's account is credited with the participant's contributions and an allocation of (a) the Company's contributions, (b) Plan earnings and losses, and (c) forfeitures of employer discretionary matching contributions and is charged with his or her withdrawals and an allocation of administrative expenses. Allocations are based on participant contributions, eligible compensation, participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investment of his or her account to any of the investment options available under the Plan.

Retirement, Death, and Disability: A participant is entitled to 100% of his or her account balance upon retirement, death, or disability.

Vesting: Participants are always 100% vested in their elective deferrals, safe harbor matching contributions, rollover contributions, and any earnings or losses thereon. Vesting in certain other Company contributions is based on years of continuous service. A participant will be 100% vested after six years of credited service.

Payment of Benefits: Upon termination of employment, normal retirement, disability, or death, a participant may receive a distribution of their vested account balance. If a participant's vested account balance is \$5,000 or less, any amount exceeding \$1,000 will be distributed to an IRA for their benefit. If a participant's vested account balance is \$1,000 or less, it will be distributed to the participant as a lump sum distribution without their consent. Prior to such distribution the participant still has the right to request that the amount be distributed directly to them in the form of a lump sum payment or to request that it be rolled over to a different IRA provider or another retirement plan eligible to receive rollover contributions. If a participant's account exceeds \$5,000, the participant must consent to a distribution.

Participants that have reached age 59½ may withdraw all or a portion of their vested account as an in-service distribution. Hardship withdrawals may also be made to satisfy specific and heavy financial needs that a participant may have.

Notes Receivable From Participants: Loans are available to participants on a reasonably equivalent basis. Participants may borrow from their vested accounts a minimum of \$1,000 up to a maximum of \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve-month period or one-half of their vested account balance, whichever is less. Loans are adequately secured and bear a reasonable rate of interest. Principal and interest payments are paid ratably through payroll deductions for a term not to exceed five years, unless the loan is for the purchase of a principal residence.

Forfeitures: If a participant terminates their employment with the Company and is less than 100% vested in their Company account, a participant will forfeit the non-vested portion of their Company account. Forfeitures are retained in the Plan and may be used to pay administrative expenses and to reduce future Company contributions payable under the Plan. At December 31, 2024 and 2023, the forfeited non-vested account totaled \$33,647 and \$47,107, respectively. During 2024, \$33,151 were used to reduce employer contributions.

Plan Termination: The Company has no legal or contractual obligations to make annual contributions to or to continue the Plan. The Company reserves the right to terminate the Plan at any time. In the event the Plan should terminate, each participant affected by such termination shall have a vested interest in their account of 100%. The Company will facilitate the distribution of account balances in single lump sum payments to each participant in accordance with Plan provisions.

Administrative Expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through July 15, 2025, which is the date the financial statements were available to be issued.

Effective January 1, 2025, the Company amended the Plan to suspend safe harbor matching contributions. This change was communicated to participants in a formal notice dated October 25, 2024. The 2025 Plan restatement reflects this change by eliminating the safe harbor match election and retaining discretionary matching provisions. No other material changes were made to eligibility, vesting, compensation, or distribution provisions.

**NOTE 2 – SUMMARY OF ACCOUNTING POLICIES**

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value as further described in Note 4. Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits: Benefits are recorded when paid.

Risks and Uncertainties: The Plan holds various investments. Investments are exposed to various risks such as interest rate, market, liquidity, credit and risks resulting from global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the fair values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 3 – CERTIFIED INFORMATION**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company.

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1:* Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2:* Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3:* Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following presents the valuation methods and assumptions used by the Plan to estimate the fair values of investments.

Mutual Funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Money Market Account: Fair value is estimated to approximate the cost basis of the deposit account balance, based upon the liquidity of the account and the credit quality of the issuer (Level 1 inputs).

**NOTE 5 – PARTY IN INTEREST TRANSACTIONS**

Parties-in-interest are defined under Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company. The Plan holds certain investments managed by Fidelity Management Trust Company. Fidelity Management Trust Company is a service provider to the Plan and, therefore, these transactions qualify as party-in-interest transactions. Notes receivable from participants also reflect party-in-interest transactions.

**NOTE 6 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated June 30, 2020 indicating that the non-standardized pre-approved profit-sharing plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended from the original non-standardized pre-approved plan document, Plan management believes that the Plan is currently being operated in accordance with the IRC.

**NOTE 6 – TAX STATUS** (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
