Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Twin Cities Pain Clinic and Affiliates 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Twin Cities Pain Clinic and Affiliates 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. NOTE 1 DESCRIPTION OF PLAN

The following description of the Twin Cities Pain Clinic and Affiliates 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally established on January 1, 2003. The Plan last restated and amended February 1, 2025. The Plan covers all employees of Andrew J. Will, MD, PA dba Twin Cities Pain Clinic (Employer) and Twin Cities Surgery Center, Twin Cities Anesthesia, PA, Twin Cities Pain Clinic Transportation, Inc., Burnsville Surgery Center, PA, and Solaris Management Group (participating employers) and excludes nonresident aliens, collective bargaining (union) employees, and employees during a merger or acquisition transition period. Effective February 1, 2025, leased employees are also excluded. Employees are eligible to participate on the first day of each calendar year month following the attainment of age 18 and completion of 30 days of service. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA). The Plan administrators are responsible for the oversight of the Plan, determine the appropriateness of the Plan's investment offerings and monitor investment performance.

Contributions

The Plan includes a cash or deferred arrangement allowed under Section 401 of the Internal Revenue Code (IRC). Eligible participants may contribute up to 90% of their eligible compensation to the Plan as pre-tax or after-tax Roth contributions (but not to exceed limits under IRC Section 415). The Plan allows participants aged 50 and over to make catch up contributions.

The Employer will make a safe harbor matching to the Plan. The Employer made safe harbor matching contributions of 100% of the first 3% of participant's compensation deferred plus 50% of the participant's deferrals in excess of 3% but not in excess of 5% of compensation deferred for the year ended December 31, 2024. The Employer may also, at its discretion, elect to make a nonelective contribution to the Plan. There were no Employer nonelective contributions authorized for the year ended December 31, 2024. In order for a participant to share in the Employer nonelective contributions, they must be employed on the last day of the Plan year unless termination is due to death, disability, or retirement.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant's Accounts

Each participant's account is credited with the participant's contributions, the Employer's safe harbor matching and/or nonelective contribution, and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided by the participant's vested account.

Vesting

Participants are immediately vested in their accounts.

Benefit Payments

Upon termination of service, death, disability, or retirement, a participant may receive the value of the vested interest in their account in the form of a lump sum, partial or installment distribution. If a participant terminates employment and the participant's account balance does not exceed \$5,000, the Plan administrator will authorize the participant's account balance be rolled into an individual retirement account without the participant's consent. The Plan also allows for in-service withdrawals at age 59 ½, subject to Plan provisions. Effective November 1, 2023, the Plan was amended to allow for Hardship distributions, subject to Plan provisions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The notes are secured by the balance in the participant's account and bear interest the prime rate plus 1%. Notes are repayable over periods of not more than five years (term can be longer for purchase of a principal residence). Principal and interest are paid ratably through payroll deductions.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and disclosures of contingent net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value of investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Employer and are excluded from these financial statements. Certain fees related to administration and recordkeeping are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Benefit Payments

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable is reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance will be deemed taxable to the participant. The note balance will be reduced, and a benefit payment will be recorded at the time the participant incurs a distributable event.

Subsequent Events

The Plan has evaluated subsequent events through July 17, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, American United Life Insurance Company, the insurance company, has certified to the completeness and accuracy of the investment information and notes receivable from participants reflected on the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023, the related activity on the statement of changes in net assets available for benefits for the year ended December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Pooled Separate Account – Valued daily at the net asset value (NAV) of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur on a daily basis.

Insurance Company General Account – Valued at fair value by the insurance company by discounting the related cash flows based on current yields of similar instruments with comparable durations considering the creditworthiness of the issuer.

NOTE 5 GROUP ANNUITY CONTRACTS WITH INSURANCE COMPANIES

On April 1, 2022, the Plan entered into a deposit contract with AUL that is not fully benefit-responsive. AUL maintains the contributions in a general account and a pooled separate account. The general account is credited with interest at a rate of 0% per year, compounded annually, and charged for Plan withdrawals, any applicable premium taxes, any unpaid net loan interest, and administration expenses charged by AUL. The general account contract is included in the financial statements at fair value because it is nonbenefit responsive. The crediting interest rate is based on an agreed-upon formula with the issuer but cannot be less than zero.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PLAN TERMINATION

Although it has expressed no intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE 8 PLAN TAX STATUS

The prototype plan is placing reliance on an opinion letter received from the IRS on the prototype plan indicating that the prototype plan is qualified under Section 401 of the IRC and is, therefore not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Generally accepted accounting principles in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are held and managed by American United Life Insurance Company, the insurance company of the Plan. Therefore, the investment transactions qualify as party-in-interest transactions.

NOTE 10 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Certain Plan assets as of December 31, 2024 are invested in a Variable Account. This Account is a Pooled Separate Account (PSA) for which AUL serves as the insurance company. The Variable Account, as a PSA, invests in mutual funds of large mutual fund companies. As the sponsor of this PSA, AUL has chosen not to complete and submit an Annual Report (Form 5500) with the Department of Labor as its Sponsor, reporting the investment activity of the PSA as a direct filing entity (DFE) for the Plan year. Therefore, the Plan's interest in the Variable Account will not be reported as an interest in a PSA on the Plan's Annual Return/Report (Form 5500) prepared and submitted for the subject audit year. Accordingly, the financial statement for the Plan reflects its representative value in the PSA.

NOTE 11 NONEXEMPT TRANSACTIONS

During 2024, the Company failed to remit employee 401(k) deferral contributions for certain payroll periods within the timeframe prescribed by the Department of Labor. These are deemed prohibited transactions in accordance with ERISA and the IRC. The Company is in the process of correcting the prohibited transactions in 2025 by depositing lost earnings.
