Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Bilinguals, Inc. Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion



NOTE 1 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

This summary of significant accounting policies of the Bilinguals, Inc. Retirement Plan (the "Plan") is presented to assist in understanding the Plan's financial statements and supplemental information. These financial statements, supplemental information, and notes are representations of Bilinguals, Inc.'s (the "Plan Sponsor") management, who is responsible for the integrity and objectivity of the financial statements. These accounting policies have been consistently applied in the preparation of the financial statements and supplemental schedule.

Basis of Accounting: The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income on investments is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. During the year ended December 31, 2024, the Plan's net appreciation (including gains and losses on investments bought and sold, as well as held during the year) was \$1,743,285.

Participant Notes Receivable: Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are recorded as distributions based upon the terms of the Plan document.

Payment of Benefits: Benefits are recorded when distributed to the Plan's participants.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Events Occurring After Report Date: The Plan Sponsor has evaluated events and transactions that occurred between January 1, 2025 and July 17, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements.

NOTE 2 - DESCRIPTION OF THE PLAN

The following description of the Plan provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan, established on January 1, 2000, and restated on July 1, 2021, is a defined contribution plan covering substantially all employees of the Plan Sponsor. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Plan's trustee, Ascensus Trust Company and Newport Trust Company, LLC ("Trustee"), maintains the Plan's assets and executes investment transactions according to participant's directions. The Trustee uses Ascensus, LLC for its record-keeping services. The Vanguard Group, Inc. is the custodian and record-keeper of the Plan (the "Custodian").

Eligible employees also include the employees of related entities. Effective July 15, 2012, the Plan was amended to include employees of Axiom Link ("AXM"), Global Healthcare Services, Inc. ("GHS"), and Achieve Beyond New York ("ABI"). Effective September of 2017, the Plan was amended to include employees of Achieve Beyond Licensed Behavior Analyst Services, P.C. ("APC"). In May of 2019, the Plan was amended to include employees of Achieve Beyond Pediatrics Speech Therapy Corporation ("APS"). In November 2022, Achieve Beyond entered into a stock sale of APS and the employees of APS are no longer eligible to participate in the Plan. On November 5, 2022, the Plan Sponsor entered into an asset purchase agreement whereby an unrelated entity agreed to purchase predominantly all of the net assets of GHS exclusive of intercompany transactions. This agreement became effective in December of 2022. The Plan Sponsor was acting as a management company for GHS; therefore, the employees of GHS were eligible to participate in the Plan until the Plan Sponsor was fully transitioned out. The Plan Sponsor stopped providing management services in December of 2023. Likewise, on May 31, 2024, the Plan Sponsor entered into an asset purchase agreement whereby the Plan Sponsor agreed to purchase predominantly all of the net assets of an unrelated entity, Up Wee Grow ("UWG"). The Plan Sponsor amended its Plan document effective June 1, 2024 to allow all eligible employees of UWG to participate in the Plan. Pursuant to the agreement and subject to applicable plan provisions and regulatory requirements, participants from UWG were given the option to roll over their account balances into the Plan. A significant number of employees elected to roll over their account balances, and these amounts were successfully transferred into the Plan.

Eligibility: All full-time employees become a participant of the Plan on or after reaching the age of 18 and completing two months of service. In July of 2021, the Plan's eligibility was amended to include part-time hourly employees that work for at least one year and complete 1,000 hours of service. Part-time hourly employees must complete 500 hours of service to avoid a break in eligibility service (i.e. if a part-time employee that incurs a break in service fails to reach 500 hours of service prior to the break in service, the Plan may disregard the employee's service time prior to the break in service and require the employee to reach one year of service and complete 1,000 hours of service after such break in service).

Contributions: Each year, participants may contribute to the Plan a percentage of compensation, as defined in the Plan document, or in specific dollar amounts, up to the maximum amount permitted by the Internal Revenue Code ("IRC"). Employees may elect to defer a maximum amount not to exceed \$23,000, the annual threshold as established by the Internal Revenue Service ("IRS"), for the Plan year ended December 31, 2024. The annual base salary for the purposes of the Plan is limited by the IRC to \$345,000. In addition, participants who attained age 50 by December 31, 2024 were eligible to make an additional catch-up deferral of \$7,500. Participants may also contribute amounts distributed from other qualified defined benefit or defined contribution plans ("rollovers"). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at three percent of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant.

The Plan Sponsor, at their discretion, may make a matching contribution equal to a discretionary percentage, to be determined by the employer, on a uniform basis for all participants each pay period. Eligibility for matching is one year of service with 1,000 hours, and employed on the last day of the Plan year. For the 2024 Plan year, the Plan Sponsor matched 10% of eligible employee deferrals. Total employer contributions amounted to \$112,265.

Participant Accounts: The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited with each participant's contribution and earnings, and an allocation of any employer contributions and administrative expenses. As a participant-directed plan, each participant's investment choices determine his/her share of earnings or losses.

Vesting: Participants are immediately fully vested in their contributions plus actual earnings thereon. Participants become fully vested in the Plan Sponsor's matching contributions plus related earnings according to the following schedule:

Less than 2 years	0%
At least 2 years, but less than 3	20%
At least 3 years, but less than 4	40%
At least 4 years, but less than 5	60%
At least 5 years, but less than 6	80%
6 years.....	100%

Upon the date the participant becomes disabled, deceased, attains the age of 65, the Plan's normal retirement age, or has completed at least six years of service for vesting purposes, participants shall be 100% vested in their accounts.

Notes Receivable from Participants: Effective May of 2018, the Plan was amended to prohibit participants from requesting a new loan. Prior to this amendment, participants could have borrowed from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balances in the participants' accounts and bear interest at the prime rate plus one percentage point at the date of the loan. The interest rates charged on the participant loans range from 4.25% to 4.50% for the year ended December 31, 2024.

Deemed Distributions: When a participant fails to make loan repayments under the terms of the loan agreement, the loan is considered to be in default. Under certain circumstances, a loan that is in default may be considered a distribution from the Plan ("deemed distribution") which could result in taxable income to the participant. All notes receivable from participants as of December 31, 2024 and 2023 have been deemed distributed.

Forfeited Accounts: When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account represents a forfeiture. Forfeitures in each Plan year are used to reduce employer contributions for the Plan year or pay Plan fees. The total forfeitures used to pay plan expenses during the 2024 Plan year was \$5,067. There was an ending forfeiture balance of \$1,330 and \$1,351 at December 31, 2024 and 2023, respectively.

Investment Options: Upon enrollment in the Plan, participants may direct the Custodian to invest contributions in various investment options managed by the Custodian, their affiliates, and other large investment management companies. Participants may change their contribution investment options, transfer part or all of past investments to other funds and change their deferral percentage at any time by giving the Plan administrator advance notice.

In-service Withdrawals: In-service or hardship withdrawals are permitted by the Plan under limited circumstances.

Payment of Benefits: Upon termination of service due to death, disability, or retirement, participants may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments not exceeding the life expectancy of the participant or his or her designated beneficiary. Participants must start receiving required minimum distributions of benefits by April 1st following the year in which they reach the age of 72, even if they are still employed by the Plan Sponsor. If a participant terminates with a vested account balance that does not exceed \$5,000 and did not consent to a distribution, the participant's account will be distributed into a rollover IRA to be established by the Custodian on the participant's behalf.

Administrative Expenses: Certain administrative functions are performed by employees of the Plan Sponsor for which they are compensated by the Plan Sponsor. In addition, the Plan Sponsor pays certain other Plan-related expenditures. Certain investment-related Plan expenses like fees paid to administer and manage the funds are paid from the assets of the funds, and therefore reduce the overall return offered by the funds. During the year ended December 31, 2024, administrative expenses charged to the Plan were \$39,772.

Plan Amendments: The Employer has the right under the Plan to amend the Plan at any time. The Plan was amended in January 1, 2024 to reflect the changes for employer contributions to be remitted on an annual basis.

The Plan was amended on June 1, 2024 to acquire the employees from UWG and remove the waiting period to join the Plan. As a result of this amendment, employees acquired were permitted to contribute to the Plan effective June 1, 2024, instead of January 1, 2025.

Since the enactment of the Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE Act") and the SECURE 2.0 Act of 2022, the Plan has adopted all mandatory and certain voluntary provisions.

Plan Termination: Although it has not expressed any intent to do so, the Plan Sponsor has the right, under the Plan, to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed pursuant to the Plan document.

NOTE 3 - INFORMATION CERTIFIED BY TRUSTEE

Investments and notes receivable from participants disclosed the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Trustee.

NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards establish a framework for measuring fair value, providing a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset and liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual Funds (Registered Investment Companies): Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price.

Money Market: Valued at cost, which estimates fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 - INCOME TAX STATUS

The Plan Sponsor elected to adopt Ascensus, LLC's prototype plan, which received a favorable opinion letter from the IRS dated June 30, 2020, which states that the Plan is designed in accordance with the applicable requirements of the internal revenue code.

Accounting principles generally accepted in the United States of America require the Plan Sponsor to evaluate uncertain tax positions taken by the Plan. The financial statement effects of a tax position are recognized when the position is more likely than not, based on the technical merits, to be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2020.

NOTE 6 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

NOTE 7 - TRANSACTIONS WITH PARTY-IN-INTEREST

At December 31, 2024 and 2023, certain Plan investments were managed by the Trustee and therefore, these transactions qualify as party-in-interest transactions.
