INDEPENDENT AUDITOR'S REPORT

To the Plan Administrators of
National Electrical 401(k) Plan:

Opinion

We have audited the financial statements of National Electrical 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of National Electrical 401(k) Plan as of December 31, 2024 and 2023, and the changes in net assets available for benefits for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of National Electrical 401(k) Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. 1. DESCRIPTION OF THE PLAN

The following description of the National Electrical 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan's provisions.

General

The Plan was established in September 2008, and became effective January 1, 2009, as a result of a collective bargaining agreement between the International Brotherhood of Electrical Workers ("IBEW") and the National Electrical Contractors Association, Inc. ("NECA"), the Plan Sponsors. The Plan is generally available to all bargaining-unit employees of employers who have signed a collective-bargaining agreement with an IBEW Local Union containing the Plan's enabling language, as well as to all non-bargaining employees of employers who have signed a Participation Agreement with the Plan. The Plan is a multiemployer deferred compensation plan, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Administration

The Plan is administered by a Board of Trustees (the "Trustees"). BeneSys Administrators provides third-party administrator services. The National Electrical Benefit Fund ("NEBF") provides day to day administration services. Empower Retirement, LLC ("Empower") provides recordkeeping and custodial services.

Participant Eligibility and Enrollment

Bargaining and non-bargaining employees are eligible to participate in the Plan on the day they become an employee of a covered employer. Employees affirmatively elect to make tax-deferred contributions by enrolling in the Plan and authorizing their employers to reduce their compensation by the amount specified in their election.

Contributions

The Plan allows each participant to defer up to 100% of his or her pre-tax compensation. Participants may also contribute amounts (rollovers) representing distributions from other qualified defined benefit or defined contribution plans provided certain requirements are satisfied.

Participants who have attained age 50 before the end of the year are eligible to make additional pretax elective deferrals to the Plan (catch-up contributions).

Employers may elect to provide profit-sharing and/or matching contributions on behalf of their non-bargaining employees. The Plan offers eight profit-sharing and/or matching contributions options which may be adopted by participating employers.

Contributions are subject to certain Internal Revenue Service ("IRS") limitations.

Participant Accounts

Individual accounts are established for each participant. The Plan offers a variety of investments with varying investment objectives as investment options. Each participant's account is credited with the participant's contributions, any employer or rollover contributions, and the earnings from the participant's investments. The participant's account is reduced by withdrawals, losses on investments and Plan expenses. Each participant may direct his or her account into any combination of several investment funds, depending on his or her desired level of investment risk. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

National Electrical 401(k) Plan Notes to Financial Statements December 31, 2024 and 2023

Vesting

Participants are immediately vested in participant and employer contributions plus actual earnings thereon. Participants must evaluate their own investment goals and choose one or more of the Plan's investment options. Poor investment performance by the investments selected by participants may cause their vested balances to be lower than the amounts contributed to the Plan on their behalf.

Eligibility for Benefits

Normal retirement age under the Plan is age 59-1/2. A participant is eligible to receive a distribution of his or her vested account balance when he or she:

- Retires from employment with covered employers after attaining normal retirement age.
- For non-bargaining employees, terminates employment with covered employers before attaining normal retirement age.
- For bargaining-unit employees, terminates employment with covered employers after attaining age 55.
- For bargaining-unit employees, terminates employment with covered employers before attaining age 55 if he or she has been out of covered employment for the entire preceding six (6) months.
- Has a qualifying disability.
- Dies, in which case the payment will be made to the participant's beneficiary.

The Plan provides for minimum required distributions per the Internal Revenue Code ("IRC") as follows:

- If a participant reaches age 72 before December 31, 2022, distribution of the participant account must begin no later than April 1 following the calendar year in which the participant reaches age 72 or retires, whichever is later.
- If a participant reaches age 72 after December 31, 2022, distribution of the participant account must begin no later than April 1 following the calendar year in which the participant reaches age 73 or retires, whichever is later.

Payment of Benefits

Participants may elect to receive their entire account balance under one or more of the Plan's alternative payment options:

The participant may withdraw any portion of his or her account in a lump-sum payment. The payment may be paid to the participant or directly rolled over into an eligible retirement plan (such as an "Individual Retirement Account "IRA").

If the participant's account balance is in excess of \$10,000, the participant may elect to receive any portion of his or her account in fixed monthly payments, with the option for either a 5-year, 10-year, 15-year, or 20-year payout period.

If the participant's account balance is in excess of \$10,000 and the account has an interest in the Plan's IncomeFlex Lifetime Funds, the participant may elect to receive payment of such interest in monthly payments over his or her life expectancy, or the joint life expectancies of the participant and his or her spouse or designated beneficiary.

If no election is made, the account balance will be paid to unmarried participants in the form of a single-life annuity, and to married participants in the form of a 50% joint-and-survivor annuity.

If a participant's vested account balance is less than \$1,000 and he or she has been out of Covered Employment for the entire preceding six (6) months, the account balance will be "cashed out", meaning that it will either be paid to the participant as a lump-sum distribution or by direct rollover into an IRA or other Eligible Retirement Plan.

Participant Loans

The Plan does not permit loans to participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared using the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments in registered investment companies, pooled separate accounts and the common collective trust are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investment policies, guidelines and procedures have been established by the Trustees of the Plan and may be modified or amended only at the direction of the Trustees. In establishing and determining the reasonableness of investment valuations, the Plan enlists the assistance of fiduciaries and investment managers who review the performance of investments to ensure adherence to those policies, guidelines and procedures.

Investments are monitored by management, as assisted by the Plan's independent fiduciary, to review pricing models and methodologies, to analyze changes in fair value from period to period, to report valuations and changes in valuations to the Trustees and to verify compliance with the presentation of investments in accordance with accounting principles generally accepted in the United States of America. See Note 3 for discussion of fair value measurements. See Note 4 for discussion of investments valued at net asset value ("NAV") as a practical expedient.

The guaranteed investment contract (see Note 5) is a fully benefit-responsive investment contract and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Prudential/Empower represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Purchases and sales of securities are recorded on a trade date basis. Dividend income is recognized as of the ex-dividend date and interest income is recorded on the accrual basis. Net appreciation or depreciation in value (unrealized and realized gains and losses) is reported for investments bought and sold, as well as held, on the statements of changes in net assets available for benefits for the period in which it occurs.

Contributions Receivable

Employer contributions due and not paid prior to year-end are recorded as employer contributions receivable. Management has determined that an allowance for credit losses is considered unnecessary for current contributions receivable. Contributions due as a result of payroll audits have been recorded net of an allowance for credit losses equal to the amount due because collectability is uncertain. Therefore, delinquent contributions are recorded when received.

Payment of Benefits

Benefits are recognized when paid.

Subsequent Events

In preparing these financial statements, management of the Plan has evaluated events and transactions that occurred after December 31, 2024 for potential recognition or disclosure in the financial statements. These events and transactions were evaluated through July 25, 2025, the date that the financial statements were available to be issued, and no items have come to the attention of management of the Plan that require recognition or disclosure.

Accounting Pronouncements Currently Adopted

In June 2016, the FASB issued an Accounting Standards Update (“ASU”) amending the accounting for credit losses on financial statements. This methodology replaced the incurred loss methodology with the expected credit losses using a wide range of reasonable and supportable information. The amendment affects loans, debt securities, trade receivables, net investments in leases, off-balance-sheet credit exposure, and other financial instruments recorded at amortized cost. The Plan adopted the new standard effective January 1, 2024, using the modified retrospective approach. Comparative prior periods were not adjusted upon adoption. Upon adoption, there was no cumulative-effect adjustment to the opening fund balance.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1) and lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs are unadjusted quoted prices in active markets for identical assets or liabilities that the reporting entity has the ability to access at the measurement date.

Level 2 - Inputs are quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active or inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Following is a description of the methodologies used for assets measured at fair value. The valuation methodologies used at December 31, 2024 were not changed from the methodologies used at December 31, 2023.

Registered Investment Companies: Valued at the closing price reported on the active market on which the individual fund is traded.

Pooled Separate Accounts and Common/Collective Trusts: Valued at NAV per share, which is based on the values of the underlying assets. The net asset value is used as a practical expedient to estimate fair value.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

4. INVESTMENTS IN INVESTMENT ENTITIES VALUED AT NET ASSET VALUE

Authoritative guidance on fair value measurements permits the Plan to measure the fair value of an investment in an investment entity that does not have a readily determinable fair value based upon the net asset value per share or its equivalent of the investment. This guidance does not apply if it is probable that the investment will be sold at a value different than NAV.

The Plan's investments in investment entities valued at NAV are subject to the terms of the respective private placement memoranda and governing agreements. Income or loss from investments in these investment entities is net of the Plan's proportionate share of fees and expenses incurred or charged by these investment entities. The Plan's risk of loss in these entities is limited to its investment.

5. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan participates in a fully benefit-responsive investment contract with Prudential/Empower via the Prudential Guaranteed Income Fund. The guaranteed income fund is a stable value fund designed to provide safety of principal, liquidity and a competitive rate of return. Prudential/Empower will attempt to achieve these objectives by investing in a broadly diversified, fixed-income portfolio within Prudential/Empower's general account. The portfolio is primarily invested in public bonds, commercial mortgages and private placement bonds. There are no unfunded commitments related to the contract.

As described in Note 2, because the guaranteed income fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the group annuity contract. Contract value, as reported to the Plan by Prudential/Empower, represents contributions made under the contract, plus earnings, less withdrawals, and administrative expenses. There were no reserves against contract value for credit risk of the contract issuer or otherwise. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The crediting interest rate was 2.25% at December 31, 2024 and 2.10% at December 31, 2023.

The contracts permit termination of the contract with appropriate notice to the Plan. Generally, there are not any events that could limit the ability of the Plan to transact at contract value paid within 90 days or contract value over time.

6. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Empower acts as the recordkeeper and custodian for investments defined by the Plan. The Plan invests in pooled separate accounts and a guaranteed investment contract managed by an affiliate of Empower.

The Plan established a budget account with Empower. In accordance with the terms of the agreement with Empower, Empower agrees to make payments to or on behalf of the Plan to pay administrative expenses of the Plan. The payments are installments based on an asset-based percentage fee and flat per-participant fee. These installments are deducted from participant accounts on a quarterly basis.

The amounts received by the Plan during the years ended December 31, 2024 and 2023 of \$663,826 and \$574,714, respectively, are reported as an offset to administrative expenses on the statements of changes in net assets available for benefits. These amounts are used to pay administrative expenses of the Plan.

The Plan reimburses NEBF for salaries and benefits and other administrative costs that are charged to the Plan based on an allocation of costs incurred. At December 31, 2024 and 2023, the Plan did not have a liability to NEBF for allocated costs incurred in 2024 and 2023, but not reimbursed by year end.

These transactions qualify as party-in-interest transactions that are exempt from the prohibited transaction rules of ERISA.

7. ADMINISTRATIVE EXPENSES

Generally, the expenses of administering the Plan are paid from Plan assets, unless otherwise paid by a covered employer, plan sponsor, third party administrator or recordkeeper. Expenses that are not paid from Plan assets are excluded from these financial statements. Administrative expenses incurred as a direct result of a participants' activities under the Plan are allocated to, and may be deducted, from the participant's account. Generally, other administrative expenses paid from Plan assets are shared among all participants' accounts. During the years ended December 31, 2024 and 2023, administrative expenses were \$541,636 and \$599,978, respectively.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' accounts balances and the amounts reported in the statements of net assets available for benefits.

Financial instruments that subject the Plan to concentrations of credit risk include cash and investments. While management of the Plan attempts to limit any financial exposure by maintaining accounts at high quality financial institutions, investment balances and cash balances exceed the federally insured limits. The Plan has not experienced, and management does not expect the Plan to experience any losses on such accounts.

9. PRIORITIES UPON TERMINATION

It is the intent of the Plan sponsors to continue the Plan in full force and effect. However, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Plan sponsors. All amounts credited to participants' accounts are 100% vested. In the event of termination, the Plan sponsors may direct that either:

- a. Benefits be distributed to participants in any manner permitted by the Plan as soon as practicable; or

- b. The Trust created by the Plan continue and benefits be distributed to participants or their beneficiaries as if the Plan had not been terminated.

10. TAX STATUS

The IRS has advised that the Plan and related trust qualifies under Section 401(a) of the IRC and is, therefore, exempt from federal income taxes under the provisions of IRC Section 501(a). The Plan obtained its latest determination letter dated August 4, 2015, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan administrator believes that the Plan has been operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Management has evaluated the tax positions taken by the Plan and concluded that as of December 31, 2024 and 2023 there are no uncertain positions taken or expected to be taken that would require recognition of a liability in the financial statements. The Plan is subject to routine audits by taxing and regulatory jurisdictions; however, there are currently no audits in progress for any periods. In addition, there have been no tax related interest or penalties for the periods presented in these financial statements.

11. EMPLOYER REMITTANCE OF PARTICIPANT CONTRIBUTIONS

During 2024 and 2023, Plan management identified certain employers who did not appear to have transmitted participant contributions within the timeframe provided under the regulations established by the U.S. Department of Labor. Delinquent contributions totaled \$216,090 and \$254,004, for 2024 and 2023, respectively. For 2024 and 2023, all such contributions have been deposited into the Plan. For 2024, the lost earnings on late remittances have been determined but not yet fully funded. The total estimated lost earnings related to uncorrected 2024 contributions is immaterial to the Plan. For 2023, the lost earnings on all identified late remittances have been determined and funded. Although management of the Plan is unable to determine with certainty that these transactions are non-exempt transactions with parties-in-interest under ERISA, these transactions have been reported as such on the 2024 and 2023 Form 5500 Schedule H, Line 4a as required by ERISA.
