NOTE 1 DESCRIPTION OF PLAN

The following description of the Antilles School, Inc. Defined Contribution Plan (the Plan), a 403(b) plan, provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible participating employees of Antilles School, Inc. (the School). The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA). The Plan was established on October 1, 1971 and was restated as of March 31, 2020. The Plan's service provider is Teachers Insurance and Annuity Association of America and College Retirement Equities Fund (TIAA).

Eligibility

All employees who work greater than 20 hours per week, except for students, are eligible to begin elective deferrals on the first day of the month following their date of hire. Participating employees who complete one (1) year of service and have worked for at least 1,000 hours are eligible to receive School contributions.

Contributions

Employees are permitted to make elective deferrals up to 100% of their salary, not to exceed the maximum amount permitted under IRS sections 403(b) and 415. The School's contributions to the Plan are discretionary each year. The School's contribution was 4% and 2% of eligible employees' salaries and wages for 2024 and 2023, respectively.

Participant Accounts

Each participant's account is maintained separately and is credited with (a) the participant's contribution, (b) the School's contribution, as appropriate, and (c) an allocation of plan earnings or losses based thereon, excluding expenses paid by participants. Participants may direct the investments of their account balances into various investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may borrow funds from their accounts for a minimum of \$1,000 up to the maximum of the lesser of \$50,000 or 50% of their vested account balance for a term no more than five years. The loans are collateralized by the balance in the participants' accounts and have an interest rate of prime plus 1.00%. Interest rates on the loans ranged from 4.25% to 9.50%. Participants repay the loan principal and interest directly to the TIAA. As of December 31, 2024 and 2023, the participant loan balances were \$127,362 and \$149,755, respectively.

Plan Loans

Participants may borrow funds directly from TIAA using the assets of the Plan as collateral for the loans. The minimum loan amount is \$1,000. The maximum loan amount is the lesser of \$50,000 or 50% of the participant's vested account balance for a term of no more than five years. The loans do not reduce the balance of the participants accounts unless the loan is in default and the employee terminates the Plan.

The Plan requires the participant to maintain at least 110% of the loan as collateral within the TIAA Traditional Annuity. The loans have variable rates that are tied to the monthly average corporate yield, published by Moody's Investor Service. Participants repay the loan principal and interest directly to TIAA. As of December 31, 2024 and 2023, the plan loan balances, which were in default and classified as deemed distributed by TIAA were \$67,462 and \$64,186, respectively.

Rollovers

Rollovers represent transfers of eligible distributions from any other qualified plans through a direct transfer from such Plan.

Vesting

Participants are immediately 100% vested.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant (or beneficiary) may elect to receive distributions as either a single lump-sum payment or monthly, quarterly, or annual installments over a period of not more than the assumed life expectancy as set forth by the IRS. Participants have access to their deferrals and vested funds upon terminating their employment with the School, attaining the age of 59½, or becoming disabled.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES***Basis of Accounting***

The financial statements are prepared on the accrual method of accounting, whereby revenues are recognized when earned and expenses when incurred. The Plan adheres to accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Contributions

Employee and employer contributions are recorded in the period when payroll deductions are made from employees' earnings.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value, except for fully benefit responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of the Plan are allocated and charged to participant accounts. Administrative expenses include recording fees and expenses related to purchases, sales, or transfers of the Plan's investments. Fees for loan initiation and maintenance are paid for by the participant. Management and other fees for investment funds offered under the Plan may be subtracted from the investment fund's assets in determining the investment fund's unit or net asset value. Investment related expenses are included in the net appreciation of fair value of investments. Certain expenses of maintaining the Plan are paid directly by the sponsor and are excluded from these financial statements.

NOTE 3 FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Registered Investment Company

These registered investments include those funded through variable annuity contracts. The underlying investments are typically mutual funds that invest principally in equity securities, fixed income instruments, and short-term investments in accordance with each portfolio's investment objectives. Account investments and fund holdings are primarily valued using market quotations or prices obtained from independent pricing sources that may employ various pricing methods to value the investments, including matrix pricing minus contractual charges. Mutual funds included by the Plan are deemed to be actively traded.

Pooled Separate Account (TIAA Real Estate Account)

The pooled separate account of TIAA is invested mainly in real estate and real estate-related investments. The value of the units held in the pooled separate account is based on the market value of the underlying real estate holdings which are valued principally utilizing external appraisals.

Guaranteed Annuity Contract

The annuity contract is a non-benefit responsive contract. The contract is included in the financial statements at fair value by discounting the related cash flows based on current yields of similar instruments.

NOTE 4 FULLY BENEFIT RESPONSIVE GUARANTEED ANNUITY CONTRACT

The Plan has a fully benefit responsive investment contract with TIAA that is reported at contract value. The contract value is the relevant measure for fully benefit responsive contracts because this is the amount participants would receive if they were to initiate permitted contracts under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses.

TIAA is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. TIAA provides a guarantee of principal, a guaranteed minimum rate of interest of 3% and the potential for additional interest if declared. Additional interest, when declared, remains in effect for the “declaration year” which begins each March 1. The declared interest rate on this contract ranged from 4.75% to 4.50% in 2024 and 5.25% to 5.75% in 2023. The contract cannot be terminated before the scheduled maturity date. The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contract is dependent on TIAA's ability to meet its financial obligations. TIAA's ability to meet its contractual obligations may be affected by future economic and regulatory developments. As of December 31, 2024 and 2023, the guaranteed annuity contract value was \$293,709 and \$315,988, respectively.

NOTE 5 INVESTMENT INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 252.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, certain information related to investments from participants disclosed in the accompanying financial statements and supplemental schedule, including investments from participants held as of December 31, 2024 and 2023, and investment income for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator by TIAA (plan custodian), who has certified that the related data included in the accompanying financial statement and supplemental schedule is complete and accurate.

The Plan's independent accountants did not perform auditing procedures on the information noted above, except for comparing such information to the related information included in the accompanying financial statements and supplemental schedule.

NOTE 6 PARTY-IN-INTEREST TRANSACTIONS

Antilles School, Inc. is the sponsor of the Plan, and as such, executes the normal duties associated therewith. Costs incurred for audit and other administrative functions are paid by the Plan sponsor on behalf of the Plan.

Custodial, advisory, and investment management related services provided to the Plan qualify as party-in interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA. For the year ended December 31, 2024, the total amount of administrative fees paid by the Plan for these services was \$27,536.

NOTE 7 TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (Code). The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is exempt. The Internal Revenue Service (IRS) is currently not issuing determination letters to 403(b) plans.

The plan administrator intends to apply for a determination letter on the Plan once the IRS opens such a program. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service.

The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of tax liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PLAN TERMINATION

Although it has not expressed any intent to do so, the School reserves the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will continue to be 100% vested in their accounts.

NOTE 9 RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 SUBSEQUENT EVENTS

The Plan has evaluated events through July 24, 2025, the date the financial statements were available to be issued. This review and evaluation revealed no other material events or transactions that require additional adjustment to or disclosure in the accompanying financial statements.
