Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

A. Description of Plan

The following description of the Gastroenterology Specialties, P.C. Safe Harbor 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. *General.* The Plan is a defined contribution plan covering substantially all employees other than union and non-resident aliens of Gastroenterology Specialties, P.C. (Company or Employer) who have completed one year of service and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Committee is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, and monitors investment performance.
2. *Contributions.* Each year, participants may contribute pretax and after-tax annual eligible compensation, as defined in the Plan, up to the annual limit as defined by law. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Company makes safe harbor contributions of 100% of the first 4% of participant deferred compensation. The Company may also make discretionary matching and profit sharing contributions. Company discretionary matching contributions and profit sharing contributions are contributed at the option of the Company's Board of Directors. During the year ended December 31, 2024, the Company elected to make profit sharing contributions to the Plan. Contributions are subject to certain IRS limitations.

3. *Participant accounts.* Each participant's account is credited with the participant's contributions, Employer contributions, rollovers, and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. *Vesting.* Participants are vested immediately in their contributions, Company safe harbor contributions, and actual earnings thereon. Vesting in the Company's discretionary contributions and earnings thereon is based on years of service according to a 6-year tiered vesting schedule.

5. *Notes receivable from participants.* Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear a rate of interest of Prime plus 1%. Principal and interest is paid ratably through monthly payroll deductions. Participants may only have one loan outstanding at any given time.
6. *Payment of benefits.* On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or partial, non-periodic payments. Distributions after termination of employment for reasons other than the above shall commence as soon as administratively feasible. For distributions of amounts of \$5,000 (increased to \$7,000 effective January 1, 2025) or less, no participant consent is required. In addition, the Plan allows for hardship distributions if certain criteria are met.
7. *Forfeited accounts.* Any available forfeitures will be used to reduce future Employer contributions or pay Plan expenses. In 2024, Employer contributions were reduced by \$37,700 from forfeited nonvested accounts. At December 31, 2024 and 2023, there were no available forfeitures to be used.

B. Summary of Accounting Policies

1. *Basis of accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).
2. *Use of estimates.* The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. *Investment valuation and income recognition.* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisor and trustee. See note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. *Notes receivable from participants.* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.
5. *Payment of benefits.* Benefits are recorded when paid.
6. *Expenses.* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to withdrawals are included with benefits paid to participants in the statement of changes in net assets available for benefits. Fees related to recordkeeping, investment advisory services, and the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation/depreciation of fair value of investments.
7. *Subsequent events.* The Plan has evaluated subsequent events through July 24, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan adopted certain provisions permissible under SECURE 2.0 including increasing the force-out threshold to \$7,000 and adopting the super catch-up.

C. Certified Investments

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations under ERISA. Accordingly, the Plan custodian, Capital Bank and Trust Company, has certified that the following data included in the Plan's financial statements and supplemental schedule is complete and accurate.

D. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Individually directed accounts: Made up of equities, mutual funds, cash, exchange traded funds, bonds, certificates of deposit, private equity investments, and a partnership investment. All investment types (other than the private equity investments and the partnership investment) are valued at the closing price reported on the active market on which the individual investments are traded. The private equity investments are valued at fair value, using the portfolio funds' NAV, as well as certain industry-accepted valuation techniques. The fair value relating to certain underlying investments of the portfolio funds, for which there is no public market, has been estimated by the respective portfolio funds' management and is based upon available information in the absence of readily ascertainable fair values and does not necessarily represent amounts that might ultimately be realized. The partnership investment is valued at the cumulative investment in the partnership, less distributions, plus or minus earnings or losses, and adjusted for impairment based on underlying financial performance.

For the year ended December 31, 2024, level 3 investment activity consisted of purchases of self-directed brokerage accounts, specifically private equity investments, in the amount of \$480,413.

E. Party in Interest Transactions

Certain Plan investments are managed by the Plan custodian (American Funds through its affiliation with Capital Bank and Trust Company) and, therefore, these transactions qualify as party in interest transactions. The Plan also paid fees to parties in interest for recordkeeping, administration, and advisory services during the year ended December 31, 2024.

F. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their entire account.

G. Tax Status

The Plan adopted a prototype non-standardized profit-sharing plan with CODA that has received an opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the non-standardized plan was in compliance with the applicable requirements of the IRC. The Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

H. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.



