**Note 1 - Description of the Plan**

The following description of the MG2 Corporation Profit Sharing Retirement Plan (the Plan) provides general information only. Participants should refer to the plan document for complete information regarding the Plan's definitions, benefits, eligibility, and other matters.

**General** - The Plan is a defined contribution plan available to qualifying employees of MG2 Corporation (the Company). Eligible participants may begin making employee contributions to the Plan the month following meeting the required eligibility criteria. Employees are eligible to begin making contributions to the Plan when they have attained age 18 and completed 90 days of service. In addition, the Plan has discretionary employer matching and profit-sharing contributions for employees who have worked for 12 consecutive months and at least 1,000 hours during that period. Employer contributions to the Plan will begin the first day of the quarter after eligibility has been met. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Plan Administration** - Empower Retirement, LLC (Empower) and certain affiliated companies provide recordkeeping, administrative, and trustee services to the Plan.

**Contributions** - Participants may elect to defer up to 100% of their compensation as pre-tax or Roth contributions. The Plan has adopted an automatic enrollment feature under which new employees are enrolled with a 3% pre-tax deferral unless they formally waive participation or elect a different participation level. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible defined benefit or defined contribution plans (rollover).

Matching contributions are at the discretion of the Company's Board of Directors. For the year ended December 31, 2024, the Company's Board of Directors approved a matching contribution equal to 50% of employee deferrals up to 6% of eligible compensation.

Each plan year, the Company may make a discretionary profit-sharing contribution. There was no profit-sharing contribution for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and matching contributions, as well as allocations of the Company's profit-sharing contributions (if any) and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

**Payment of Benefits** - Upon termination of service, retirement, death, or disability, a participant or beneficiary may elect to receive a lump-sum distribution equal to the value of the participant's vested account or installment payments. Participants who have attained age 59 ½ may also elect to receive a distribution of all or any portion of their account balance prior to termination of employment (in-service withdrawals). The Plan allows for hardship withdrawals in accordance with provisions specified in the plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

**Vesting** - All contributions by participants plus earnings are fully vested at the time of contribution. Employer matching and profit-sharing contributions are vested using the following percentages:

**Forfeitures** - As of December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$62,823 and \$63,483, respectively. During 2024, \$50,450 in forfeited accounts were used in accordance with the provisions specified in the plan document.

**Notes Receivable From Participants** - Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. Loans are secured by the balance in the participant's account. Interest rates are set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions.

**Note 2 - Significant Accounting Policies**

**Basis of Accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition** - Investments are reported at fair value except for fully benefit responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable From Participants** - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction based fees for notes receivable from participants and benefit payments are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements

**Subsequent Events** - The Plan's management has evaluated subsequent events through July 17, 2025, the date on which the Plan's financial statements were available to be issued.

**Note 3 - Fair Value Measurements**

GAAP provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than the quoted prices that are observable for the asset or liability, and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Unobservable inputs that are significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The Plan has entered into a general account backed evergreen (no maturity) group annuity spread contract issued by Prudential Retirement Insurance and Annuity Company which was later renamed Empower Annuity Insurance Company (EAIC). The account is credited with participant contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal at a specified interest rate that is guaranteed to the Plan.

The contract meets the fully benefit-responsive criteria and therefore is reported at contract value. Contract value represents contributions made under the contract, plus earnings at guaranteed crediting rates, less participant withdrawals and fees. Participants may ordinarily direct the withdrawal or transfers of all or a portion of their account balance at contract value within reasonable timeframes.

When establishing interest crediting rates for this product, EAIC considers many factors, including current economic and market conditions, the general interest rate environment and both the expected and actual experience of a reference portfolio within the issuer's general account. These rates are established without the use of a specific formula. Interest crediting rates are reviewed on a semi-annual basis for resetting. The minimum crediting rate under the contract is 1.50% less a variable asset charge rate.

**Note 4 - Continued**

Generally, there are no events that could limit the ability of the Plan to transact at contract value or settle at an amount different than contract value. Upon termination of the contract between EAIC and the Plan, EAIC will initiate termination disbursements the later of A) 90 days after EAIC receives all information necessary to make the disbursement or B) 90 days after the date all outstanding expenses are paid under the contract. Transfers out of this fund must be directed to and remain in a non-competing fund for a period of 90 days before it can be invested in a competing fund.

**Note 5 - Certified Information**

Certain information in the accompanying financial statements and supplementary information related to investments held as at December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company, qualified institutions. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

**Note 6 - Tax Status**

The Company adopted an Empower pre-approved plan document. Empower received an opinion letter from the IRS dated September 16, 2022, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

**Note 7 - Party-in-Interest Transactions**

The Plan entered into a group annuity contract issued by EAIC, an investment product of Empower and its affiliates. Empower is the custodian for the Plan and, therefore, transactions with such investments related to the contract are party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

**Note 8 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. If the Plan is terminated, participants would become 100% vested in their employer contributions.

**Note 9 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 10 - Delinquent Contributions**

The Company determined there was one instance during 2023 in which participant deferral contribution were not deposited by the Company as plan assets within the time limitation stipulated under the Department of Labor's (DOL) regulations. Delinquent contributions are prohibited party-in-interest transactions under ERISA and also represent related party transactions between the Plan and the plan sponsor. In total, \$323 of deferral contributions were identified as delinquent. During 2024, the Company restored lost earnings associated with \$323 of the delinquent deposits.
