Opinion

We have audited the financial statements of A & E Health & Welfare Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits and of changes in plan benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of A & E Health & Welfare Trust as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and plan benefit obligations for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of A & E Health & Welfare Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about A & E Health & Welfare Trust's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

NOTES TO FINANCIAL STATEMENTS

NOTE A: DESCRIPTION OF THE TRUST

The following description of the A&E Health & Welfare Trust (the “Trust”) provides only general information. Participating employers should refer to the Trust Agreement (the “Agreement”) for a complete description of the Trust's provisions.

General

The A & E Health & Welfare Trust is a multiple employer welfare arrangement as defined in Section 3(40) of the Employee Retirement Income Security Act of 1974 (ERISA). The Trust was established in September 2020 as a group purchasing organization through which unrelated participating employers purchase certain health insurance benefits which they make available to eligible individuals. The Trust established a Group Insurance Trust to collect premiums from members and remit payments to insurers. The Trust holds the policies under which benefits are administered and paid; and serves as a conduit for the payment of premiums to insurers. The Trust does not sponsor a group health plan and is not the sponsor of any participating employer plan. The Trust began operations on January 1, 2021.

Each participating employer sponsors a fully-insured group health insurance plan for the benefit of its eligible employees, former employees, and their dependents. Each participating employer serves as the administrator with respect to its own plan including eligibility determinations and enrollment, and the type and amount of benefits to which participants are entitled.

To be eligible for admission as a participating employer, an employer must be an A/E firm (architecture/engineering) and meet certain requirements as defined in the Agreement, including executing a membership agreement.

Participating employer contributions to the Trust

Premium payments

Each participating employer contributes to the Trust the premiums established by the insurer for medical, dental, and prescription coverage provided to individuals enrolled by the participating employers for coverage under the insurance policy, as defined. Upon receipt by the Trust, and as soon as administratively practicable, premiums established by the insurer on behalf of the participating employer are paid to the insurance provider. Broker commissions are included with the respective monthly premiums.

Advance deposits

Effective January 1, 2022, the Trust entered into a minimum premium rider with the insurance carrier for medical coverage. A premium equivalent amount required by the insurance carrier under the insurance contract is deposited in advance, which can be applied against possible future losses in excess of current premiums. These deposits have been included as an asset of the Trust until such amounts are used to pay claims. Any premium equivalent surplus or deficit is carried forward to the next coverage year under the insurance contract.

Member assessments

Each participating employer contributes to the Trust such other amounts for the payment of expenses of administering the affairs of the Trust and determined by the Trustees.

Benefits under the Trust

The Trust serves as a conduit for payment policy premiums. The medical, dental, and prescription insurance coverage available to eligible employees of the participating employers is provided on a fully-insured basis pursuant to a group health insurance contract issued by Excellus BlueCross BlueShield subject to the experience-rated contract described below.

The Trust also provides continuation of certain benefits upon termination of employment through the Consolidated Omnibus Budget Reconciliation Act (COBRA).

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Cash

The Trust maintains its cash in a financial institution located in New York which is insured by the Federal Deposit Insurance Corporation up to \$250,000. The cash account balance at any given time may exceed insured limits. However, the Trust has not experienced any losses in such account and does not believe it is exposed to significant risk in cash.

Pharmacy rebates

The Trust receives rebates from certain pharmacy companies for certain prescriptions. These rebates are accumulated each quarter and credited to the Trust towards future pharmacy claims. Rebates due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Pharmacy rebates totaling \$1,543,128 and \$1,248,759 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, respectively.

Administrative expenses

Expenses incurred in connection with the general administration of the Trust are paid by the Trust and are recorded as deductions in the accompanying statements of changes in net assets available for benefits.

Use of estimates in the preparation of financial statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates and assumptions.

Stop Loss Coverage

Effective January 1, 2022, the Plan entered into stop-loss insurance arrangements in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims). Premiums for stop loss insurance are included in premiums on the accompanying statements of changes in net assets available for benefits. Refunds due as of the financial statement date have been reported as a receivable, with the offset being netted against claims paid. Stop loss refunds totaling \$1,286,791 and \$123,792 have been netted with claims paid in the accompanying statements of changes in net assets available for benefits at December 31, 2024 and 2023, respectively.

NOTE B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES, Cont'd

Experience-rated Contracts

Effective January 1, 2022, certain insurance contracts are subject to experience-rating adjustments. Experience ratings, calculated as the difference between premiums paid and the total of claims paid and fees charged by the insurance company, are determined by the insurance company in the following year and may result in a premium surplus or deficit.

Subsequent events

The Trust has conducted an evaluation of potential subsequent events occurring after the statement of net assets available for benefits date through July 25, 2025, which is the date the financial statements are available to be issued. No subsequent events requiring disclosure were noted.

NOTE C: BENEFIT OBLIGATIONS

The Plan's benefit obligations exceeded its net assets at December 31, 2024 and 2023, primarily due to claims payable and claims incurred but not paid. It is expected that the deficiency will be funded through additional contributions made by the participating employers and future increases in the contribution rates paid by the participating employers.

NOTE D: TAX STATUS

The Individual Trustees believe the Trust is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Trust management to evaluate tax positions taken by the Trust and recognize a tax liability if the Trust has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or other applicable taxing authorities. The Trust is subject to routine audits by tax jurisdictions; however, there are currently no audits in progress.

NOTE E: RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

The Trust allows for transactions with certain parties who may perform services or have fiduciary responsibilities to the Trust. As described in Note B, the Trust paid certain expenses related to trust operations to various service providers. These transactions qualify as party-in-interest transactions. Each participating employer must appoint one Individual Trustee and one alternate Individual Trustee, who are responsible for administering the Trust in accordance with the terms of the Agreement and perform administrative services at no cost to the Trust.

NOTE F: TRUST TERMINATION

The Trust may be terminated with the approval of all of the Individual Trustees as defined in the Agreement. A participating employer may withdraw and terminate its participation in the Trust pursuant to conditions as prescribed in the Agreement.

NOTE G: RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Claims that have been processed and approved for payment at year end, but not paid and claims incurred but not reported, are not considered liabilities under generally accepted accounting principles and are not presented as liabilities or claims paid in the accompanying financial statements, but are recorded on the Form 5500 as a liability.

NOTE H: RESTATEMENT

The Trust's audited financial statements as of December 31, 2023 and for the year then ended has been restated to correct an error. Net assets available for benefits at January 1, 2023 should have included advance deposits totaling \$394,000. These amounts were properly included in premiums received, however, they were included in claims paid when disbursed to the insurance carrier rather than being held by the insurance carrier and remaining a Trust asset. This error resulted in the net assets available for benefits and benefit obligations to be understated.
