## Independent Auditor's Report

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Medvantx 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

#### Note 1. Description of the Plan

The following is a brief description of Medvantx 401(k) Retirement Plan (the Plan) and is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan sponsored by Medvantx, Inc. (the Plan Sponsor and Plan Administrator). The purpose of the Plan is to provide retirement benefits for employees of Medvantx, Inc. and any participating employers (collectively, the Company).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company's Board of Directors is responsible for oversight of the Plan.

**Eligibility:** Eligible employees may begin participation on the first day of the month following their service requirement of three months has been satisfied. This eligibility period applies to all contributions into the Plan. The Plan has an auto-enrollment feature where participants will be automatically enrolled to defer 6% of their eligible compensation, unless they elect otherwise, upon satisfying the eligibility requirements.

**Contributions:** Participants are permitted to contribute up to 100% of their pretax compensation, as defined in the Plan document, or Roth deferral, up to the maximum allowed by the Internal Revenue Code. Participants are also permitted to make rollover contributions from other qualified plans. The Company may make discretionary matching contributions to the Plan which are invested in a manner similar to participant contributions. For the year ended December 31, 2024, the Company contributed a qualified automatic safe harbor matching contributions of 100% of the first 1% and 50% of amounts greater than 1% but that do not exceed 6% of eligible compensation that a participant contributes to the Plan.

Contributions from Plan participants and the respective matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

**Participant accounts:** Each participant's account is credited with the participant's contributions, discretionary employer matching contributions, if any, and Plan investment earnings. Participant accounts are charged with Plan investment loss and an allocation of administrative expenses paid by the Plan (if not paid with forfeitures). Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment options:** Upon enrollment in the Plan, a participant may direct contributions in a variety of investment options offered by the Plan. All funds vary in types of investments, rates of return and investment risk, and are described in more detail in the Plan's literature. Participants may elect on a daily basis to have all or part of their account balances and future contributions transferred from one fund to another, or in any combination.

**Vesting:** Participants are vested immediately in their contributions including actual investment earnings and losses thereon. Vesting in the Company's discretionary and qualified automatic safe harbor contribution portion of their accounts, including investment earnings and losses thereon, is based on a graded scale over two years of participation in the Plan. A participant is 100% vested after two years of credited service. A participant becomes 100% vested upon death or permanent disability.

#### Note 1. Description of the Plan (Continued)

**Notes receivable from participants:** Participants can borrow from their accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000, reduced by the highest outstanding note balance during the prior 12-month period, or 50% of their account balance. Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. The notes are secured by the balance in the participant's account and bear interest at prevailing interest rates charged by persons in the business of lending money for notes which would be made under similar circumstances. The interest rate on outstanding notes at December 31, 2024, ranged from 4.25% to 10.50%. Principal and interest are paid through payroll deductions. The repayment period is no more than five years unless such note is for the purchase of the participant's primary residence, in which case the repayment period is no more than 15 years. Participants may only have one note outstanding at any one time.

**Benefit payments:** Upon death, permanent disability, retirement or other termination of employment, participants, or their beneficiaries, are entitled to receive the vested balance of their account. Vested benefits are distributed in the form of a lump-sum amount. The Plan also allows hardship distributions subject to certain restrictions. Distribution of benefits upon termination is automatic if the participant's account balance is less than \$5,000.

**Forfeitures:** Forfeited nonvested accounts are used to restore previously forfeited balances, pay Plan administrative expenses or fund employer contributions. Approximate unallocated forfeiture balances as of December 31, 2024 and 2023, were \$26,000 and \$10,000, respectively. Forfeitures were used during 2024 in the amount of \$625 to pay for fees relating the plan.

**Plan termination:** Although it has not expressed any intent to do so, the Company has the right, under the Plan, to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of termination, all participant accounts become fully vested.

#### Note 2. Summary of Significant Accounting Policies

**Basis of presentation:** The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

**Use of estimates:** The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Accounting standards establish the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under accounting standards are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the quoted market price of the fund as published on public exchanges on a daily basis.

**Pooled separate accounts:** Pooled separate accounts are valued at net asset value (NAV) per share used as a practical expedient, based on quoted market prices for the underlying securities or similar instruments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Notes receivable from participants:** Participants notes receivable are classified as notes receivable from participants, which are segregated from Plan investments and measured at their unpaid principal balance, plus any accrued interest. If a participant ceases to make notes receivable payments and the Plan Administrator deems the participants note to be in default, the participants notes receivable balance is reduced and a benefit payment is recorded.

Notes receivable from participants have been classified as an investment for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule of assets (held at end of year).

**Payment of benefits:** Benefits are recorded when paid.

**Administrative expenses:** Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are charged against net investment results.

**Risks and uncertainties:** The Plan provides for investment in a variety of investment securities. In general, investment securities are exposed to various risks, such as interest rate, credit and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments have occurred since December 31, 2024, or will occur in the near term, and that such changes could materially affect participants account balances and the amounts reported in the 2024 statement of net assets available for benefits.

**Subsequent events:** The Plan Administrator has evaluated subsequent events through July 28, 2025, the date of the financial statements were available to be issued.

**Changes in fair value levels:** To assess the appropriate classifications of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the beginning of the reporting period.

The Plan evaluated the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3.

#### Note 5. Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments are managed by Empower. Empower served as the trustee for the Plan during the year ended December 31, 2024, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee totaled \$13,379 for the year ended December 31, 2024.

#### **Note 6. Income Tax Status**

The Plan has adopted a nonstandardized form of a pre-approved plan. The pre-approved plan provider, Compass, has received on June 30, 2020, an opinion letter from the Internal Revenue Service (IRS) as to the pre-approved plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the letter. However, the Plan Administrator believes the Plan is operating in a manner that did not jeopardize this tax status.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator evaluated the Plan's tax positions and concluded that the Plan has maintained its tax-exempt status and has taken no uncertain tax positions that require recognition or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 7. Delinquent Contributions**

During the year ended December 31, 2023, the Company inadvertently failed to deposit \$118,913 of participant contributions within the required time frame as stated by the United States Department of Labor (DOL). The DOL considers late deposits to be prohibited transactions. The Company corrected the Plan for lost earnings during the year ended December 31, 2024. Additionally, the Company intends to complete the Form 5330 and pay the applicable excise tax, which will be paid from Plan Sponsor assets and not assets of the Plan.
