Employee Stock Ownership Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Varney, Inc. Employee Stock Ownership Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Note 1 – Plan Description

The following description of the Varney, Inc. (the “Company”) Employee Stock Ownership Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Company established the Plan effective January 1, 1997. The Plan operates as an employee stock ownership plan (ESOP), and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the *Internal Revenue Code (IRC)* of 1986, as amended and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 as amended (ERISA). The Plan is administered by the Plan Administration Committee, comprising at least three but no more than nine persons appointed by the Company’s Board of Directors.

The stock is held in a trust established under the Plan. The financial statements of the Plan present the assets and liabilities and changes therein pertaining to the accounts of employees with vested rights in stock.

Employees of the Company are generally eligible to become participants in the Plan upon the completion of one qualifying year of service and the attainment of age twenty-one. The Plan document excludes employees hired in positions which were expressly designated at the date of hire as being temporary full-time employment for a fixed period of time or the duration of a specific contract. Eligible employees become participants of the Plan on the January 1 or July 1 entry date following the date on which the eligibility requirements are met. Participants who do not have at least 1,000 hours of service and are not employed on the last day of the year are generally not eligible for an allocation of Company contributions for such year, unless their employment ended due to death, disability, or retirement.

Contributions

The Company’s contributions are determined annually by the Board of Directors of the Company and shall not exceed amounts allowable under the *IRC*. Company contributions may be made in cash or in shares of Company stock.

Participant Accounts

Upon the annual adjustment date, the account of a participant who is employed on the last day of the Plan year and completed a year of service during the Plan year, or who retired, died, or became disabled during the Plan year, will be credited with an allocation of Plan earnings, forfeitures, and employer contributions. Employer contributions and forfeited balances of terminated participants’ non-vested accounts are allocated based on the proportion of each participant’s compensation to the total compensation of all participants, as defined in the Plan document. Plan earnings are allocated based on the proportion of each participant’s account balance to the total of all participant account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Vesting in a participant’s account is based on years of service, as defined in the Plan document. A participant is 100% vested upon the completion of six years of service, the attainment of normal or early retirement age, or the occurrence of death or disability while employed by the Company.

Forfeitures

Forfeited non-vested amounts are reallocated to the accounts of remaining participants. Forfeitures from terminated non-vested accounts of \$9,500 and \$6,914 were reallocated to participant accounts for the years ended December 31, 2024 and 2023, respectively.

Payment of Benefits

Distributions from the Plan may be made as in-service withdrawals or when a participant retires, dies (in which case, payment shall be made to his or her beneficiary or other legal representatives), or otherwise terminates employment with the Company. Distributions may be made in lump-sum cash payments or in installments, in accordance with the Plan's Distribution Policy. A participant may elect to receive any portion of his or her account attributable to Company stock, if any, distributed in such stock rather than cash, or may elect to receive any combination thereof. The Plan provides for automatic rollovers of vested account balances greater than \$1,000 but not more than \$5,000 and allows the Plan to make involuntary cash out payments to participants with a vested balance of \$1,000 or less.

Effective January 1, 2023, the Plan document was amended to allow in-service withdrawals for participants upon obtaining Early Retirement Age or Normal Retirement Age, as defined by the Plan.

Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post 1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify receive a cash distribution.

Administrative Costs

Plan administrative expenses may be paid by either the Plan or the Company on a discretionary basis. For 2024, the Company paid substantially all of the Plan expenses.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in Varney, Inc. common stock. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Benefit Payments

Benefit payments are recorded when paid.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of observable inputs other than quoted prices for identical assets; and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements

The fair values of mutual funds are based on the closing price reported on the active market on which the individual funds and securities are traded.

Level 3 Fair Value Measurements

The fair value of Varney, Inc. common stock is determined by an annual independent appraisal. The independent appraiser utilized both the Market Multiple Approach and the Discounted Cash Flow Approach to determine the value of common stock on a marketable, controlling interest basis and then discounting for lack of marketability for the 2024 and 2023 valuation. The appraiser took into account the estimated fair value of Company assets and liabilities.

The significant unobservable inputs used to measure fair value include the Company's projected cash flows, cost of equity and debt, determination of appropriate capital structure, weighted average cost of capital, long-term growth rate, and discounts for lack of marketability of the stock. Significant changes to these inputs could have resulted in a significantly higher or lower fair value measurement for the Company common stock. The following table provides further details of the Level 3 fair value measurements at December 31.

Note 7 – Plan Termination

Although it has expressed no intention to do so, the Company reserves the right to discontinue the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the participants shall become fully vested in the balance in their accounts and the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time as prescribed by the Plan terms and the *IRC*.

Note 8 – Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated August 15, 2016, that the Plan and related trust are designed in accordance with applicable sections of the *IRC*. The Plan has been restated; however, the Plan Sponsor and Administrator believe that the Plan is currently being operated in compliance with the applicable requirements of the *IRC*.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note 9 – Subsequent Events

Subsequent events have been evaluated through July 28, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan document adopted the provision to raise the involuntary cash-out threshold from \$5,000 to \$7,000.
