Note 1: Description of Plan

The following description of the Kernodle Clinic, Inc. Employees' 401(k) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering employees of Kernodle Clinic, Inc (Employer) who complete at least 1,000 hours of service during a 12 consecutive month period. Effective January 1, 2013, those employed as a physician are no longer eligible to contribute to the Plan. The Plan became effective January 1, 1986 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was last amended and restated January 1, 2016.

Contributions - Each year, participants may contribute pretax compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Employer may contribute a matching contribution and/or additional amounts to the Plan. For the plan year ended December 31, 2024, the Employer contributed a matching contribution equal to 100% of the first 5% that a participant contributes to the Plan. No discretionary additional employer contributions were made for the plan year ended December 31, 2024. To be eligible for an employer contribution, participants must be employed on the last day of the plan year and worked at least 1,000 hours during the plan year. Contributions are subject to certain Plan and Internal Revenue Service (IRS) limitations.

Participant accounts - Each participant's account is credited with the participant's contribution, the Employer's contribution and earnings of the Plan. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balances, or specific transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of all contributions into various investment options offered by the Plan. Participants may change their investments at any time. Participant accounts are valued daily.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Employer's contributions plus actual earnings thereon is based on years of service. A participant is fully vested when they attain normal retirement age. Prior to normal retirement age, a participant's interest in the Employer's contributions plus actual earnings thereon are vested 100% after six years of service.

Payment of benefits - Upon death, disability, or retirement a participant may elect to receive his or her account balance in the form of a lump sum payment. Upon separation from service for reasons other than mentioned above, the participant is eligible to receive the value of the vested interest in his or her account. Upon attainment of 50 years of age a participant who is fully vested in his or her account may withdraw all or any portion of his or her employer contribution account balances. A participant may withdraw from his or her after-tax employee contribution or rollover account balances at any time.

Notes receivable from participants - Participants may borrow from their account balances a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance at the time of the loan. The maximum loan term is five years, except for loans used to acquire a principal residence (10 years). The loans are secured by the vested amount in the participant's account and bear interest at market rates prevailing at the time of inception. Principal and interest are paid by payroll deduction.

Forfeitures - Forfeited nonvested amounts on distributed accounts were \$20,584 and \$20,035 at December 31, 2024 and 2023, respectively. Nonvested amounts are allocated first to reinstate previously forfeited account balances of former participants. Any amounts remaining are used to reduce Employer contributions. During the year ended December 31, 2024, the Employer used \$19,064 to reduce Employer contributions.

Note 2: Summary of Significant Accounting Policies

Basis of accounting - The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of accounting estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Employer is the Plan Administrator. The Plan Administrator is responsible for oversight of the Plan and determines asset valuation policies using information provided by investment advisers, custodians and the trustee. Refer to Note 4 for fair value measurements discussion.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits - Benefits are recorded when paid.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Should a participant terminate employment, the outstanding loan principal, plus accrued interest is due immediately.

Administrative expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Transaction based fees are charged directly to the participant's account and are included in administrative expenses. Asset based fees are included in net appreciation or depreciation in fair value of investments.

Subsequent events - The Plan has evaluated subsequent events through July 25, 2025, the date the financial statements are available to be issued for possible recognition or disclosure in the financial statements.

Note 3: Unaudited Certified Information

Certain information related to investments and notes receivable from participants disclosed in the financial statements, including the associated investment income, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Vanguard Fiduciary Trust Company.

Note 4: Fair Value Measurement

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the assets or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. These funds held by the Plan are deemed to be actively traded.

Collective Trusts: The participation units held in collective trusts are based on the net asset value per unit as reported by the fund manager. The collective trusts provide for daily redemptions by the Plan at reported net asset value per share, with no advance notice requirements.

Self-Directed Brokerage Accounts: The self-directed brokerage accounts are invested in mutual funds and common stocks for which the fair values are determined by obtaining quoted prices from a nationally recognized exchange.

The methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5: Party-in-Interest Transactions

Parties-in-interest are defined by Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer, and certain others. Investment activities and certain fees paid by the Plan to parties-in-interest are considered party-in-interest transactions. The Plan engaged in the following party-in-interest transactions which are exempt from prohibited transaction rules defined by ERISA: investment transactions with the trustee; indirect fees included in the net appreciation of investments for investment management and custodial services; direct fee payments to the trustee for record keeping and custodial services.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the account balance of each participant would become fully vested, as prescribed by ERISA and its related regulations, and would be distributed to each participant according to the provisions of the Plan.

Note 7: Tax Status

The Internal Revenue Service has determined and informed the Employer by a letter dated July 21, 2017, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that that Plan is qualified and the related trust is tax-exempt.

Note 7: Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service or Department of Labor. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8: Plan Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.
