Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kravet LLC 401(k) Savings & Profit Sharing Plan (Formerly Known as Kravet Inc. 401(k) Savings & Profit Sharing Plan) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan

The following description of the Kravet LLC 401(k) Savings & Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

Effective November 26, 2024, the Plan changed its name from Kravet Inc. 401(k) Savings & Profit Sharing Plan to Kravet LLC 401(k) Savings & Profit Sharing Plan.

General

The Plan is a defined contribution plan established effective January 1961, as restated January 1, 2020. The Plan covers all employees, excluding leased and mini-shift employees, of Kravet LLC (the Company), formerly known as Kravet Inc., who have completed three months of service and are age 21 or older. In order to be eligible to receive employer matching contributions the participant must complete one year of service (minimum 1,000 hours). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The administrator is responsible for oversight of the Plan. The Plan utilizes a third-party consultant who determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's administrator.

Contributions

Each year, participants may contribute at least 1% of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, however, participant catch-up contributions will not be matched. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company may make matching contributions equal to a discretionary percentage, as it may determine, of the participant's elective deferral, however, participant catch-up contributions will not be matched. In order to be eligible to receive employer matching contributions the participant must complete one year of service (minimum 1,000 hours). For the year ended December 31, 2024, the Company approved a matching contribution of approximately \$420,000 to the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations. The Company may, in its sole discretion and in such amounts as it may determine make a profit sharing contribution on behalf of participants who are eligible, as defined. Any profit sharing contribution shall be allocated in the proportion that each eligible participant's compensation for the plan year bears to total compensation of all eligible participants for the plan year. For the year ended December 31, 2024, there were no profit sharing contributions to the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, Company matching contributions, allocations of the Company's profit sharing contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 20% vested after two years of credited service and continues to vest in increments of 20% until 100% vested after six years of credited service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's vested account. Interest rates are determined by the plan administrator by reference to the prevailing interest rates charged by commercial lenders under similar circumstances on the date the loan is made. Principal and interest are paid ratably through monthly payroll deductions. Terms range up to five years or greater for the purchase of a primary residence.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump sum equal to the value of the participant's vested interest in his or her account. If a terminated participant's vested balance is less than or equal to \$7,000, the amount may be automatically distributed in the form of lump sum cash payment or Individual Retirement Account (IRA), depending on the balance. In addition, the Plan allows for hardship distributions if certain criteria are met.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,488 and \$13,145, respectively. These accounts will be used to reduce future employer contributions or to pay plan administrative expenses. During 2024, employer contributions were reduced by \$1,348 and plan administrative expenses were reduced by \$10,713, from forfeited nonvested accounts, in accordance with plan provisions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Recent Accounting Standards

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Subsequent Events

Subsequent events were evaluated through July 14, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Investments measured at net asset value: Consisting of the Reliance Trust Company Stable Value Fund Collective Investment Trust - MetLife Series 25157 (the Fund), valued at NAV of units of a collective trust. The Fund was formed for the purpose of allowing participating plan sponsors, who maintain qualified defined contribution plans, to invest in the MetLife Group Annuity Contract (the Contract) issued by MetLife to the Reliance Trust Company. MetLife guarantees the contract value of the Fund's investment which represents contributions, plus interest, less participant-initiated withdrawals, or transfers. There are no reserves against contract value for credit risk of the contract issuer or otherwise. MetLife provides a fixed interest rate which applies to the contract that is reset every quarter with consideration of various factors, including capital market developments, the yield-to-worst performance of the benchmark indices of the separate accounts backing the contract, the expected withdrawals of all of the participating plans indirectly participating in the contract through the Fund and all contract charges and fees. The Fund invests in fully benefit-responsive investment contracts with MetLife. Under the contracts, deposits by the Fund are invested by MetLife in separate accounts. The investments held in the separate accounts are owned by MetLife. The Plan's investment in the Fund is not an investment in a fully benefit-responsive investment contract and is therefore measured and reported at fair value. The NAV reported by the Fund is used by the Plan as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported net asset value. The ability to transact at NAV may be limited in certain significant circumstances, specifically employer-initiated events such as plan termination, bankruptcy or reorganization, early retirement incentive programs or tax disqualifications.

Self-directed brokerage accounts: The self-directed brokerage accounts are held at fair value of the underlying investment. Cash, interest bearing accounts are valued at cost, which approximates fair value. Common stocks are valued at the closing price reported on the active market on which the individual security is traded.

4. Concentrations

As of December 31, 2024, the Plan had investments of approximately \$19,361,000 that were concentrated in two funds. As of December 31, 2023, the Plan had investments of approximately \$23,825,000 that were concentrated in three funds.

5. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Vanguard Fiduciary Trust Company (Vanguard), the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

6. Related-Party and Party in Interest Transactions

The Company pays certain administrative expenses of the Plan. Certain plan investments are managed by an affiliate of Vanguard. Additionally, certain fees for the Plan are paid to Vanguard directly from mutual fund companies whose investments are included in the Plan. The charges by Vanguard for its services and charges by other advisors for investment advisory and management fees are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than direct payment. During the year ended December 31, 2024, the Plan made direct payments of administrative expenses to Vanguard in the amount of \$120,429, which were not covered by revenue sharing.

Additionally, the Plan issues loans to participants, which are secured by the participant's account vested balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

8. Insurance Premiums Paid on Allocated Contracts

Certain participants in the Plan have individual life insurance policies for which premiums have been paid from the participant's plan assets. The insurance policies are not reported in the Statements of Net Assets Available for Benefits as they are classified as allocated contracts. Under generally accepted accounting principles allocated contracts are excluded from the Plan's financial statements because the purchase of the contract transfers the obligation to pay the benefit and the related risk to the insurance company.

9. Tax Status

The Plan adopted a prototype plan offered by Alliant Insurance Services, Inc. The prototype plan received an IRS Advisory Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Advisory Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

11. Delinquent Participant Contributions

In connection with three payrolls during the year ended December 31, 2024 and six payrolls during the year ended December 31, 2023, the Company failed to transmit participant contributions and loan repayments to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Delinquent Participant Contributions Disclosure under ERISA. Late payments result in a prohibited transaction inasmuch as a late remittance is deemed to create a loan to the Company. Untimely remittances identified on the Schedule H, Line 4(a) - Schedule of Delinquent Participant Contributions totaled \$1,455 and \$22,736 for the years ended December 31, 2024 and 2023, respectively. The Company made an immaterial contribution to the Plan for lost earnings resulting from late remittances during 2024.
