Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the *CymSTAR Retirement Plan*, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the *CymSTAR Retirement Plan*'s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the *CymSTAR Retirement Plan* and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the *CymSTAR Retirement Plan's* ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the CymSTAR Retirement Plan (the *Plan*) is provided for general information purposes only. The *Plan* covers employees of CymSTAR, LLC and CymSTAR Services, LLC (collectively referred to herein as the “Employer” or “Company”). Participants should refer to the *Plan* Agreement or Summary Plan Description for a more complete description of the *Plan*’s provisions.

General:

The *Plan* is a 401(k) employee savings plan adopted effective September 1, 2005 and a defined contribution plan covering all full-time employees, except union employees and non-resident aliens, of the Employer who have completed three months of service. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Voya Retirement Insurance and Annuity Company (the “Trustee”) serves as the trustee of the *Plan* and hold the *Plan* assets.

Eligibility:

Non-excluded employees are eligible to participate in the *Plan* on the first day of the month coinciding with or following the date after satisfying eligibility requirements.

Employee Contributions:

Participants may contribute up to 100% of their compensation, as defined, as either pretax or Roth deferrals. Participants who have attained age 50 before the end of the *Plan* year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Eligible employees are automatically enrolled in the *Plan* with a 3% deferral rate. Eligible employees who do not wish to participate in the *Plan* may affirmatively elect to opt out, or they may elect a different deferral percentage.

Participants direct the investment of their contributions into various investment options offered by the *Plan*. Contributions are subject to certain limitations of the Internal Revenue Code (the “Code”).

Employer Contributions:

For 2024, the Employer made matching contributions equal to 50% of the employee’s salary deferrals that did not exceed 6% of their compensation. In addition, the Employer makes 4% safe harbor contributions for all active participants. The Employer may also make a discretionary profit-sharing contribution for all active participants.

NOTE 1 - DESCRIPTION OF PLAN (continued)

Participant Accounts:

Each participant's account is credited with participant contributions, Employer non-discretionary matching contribution, and any Employer additional matching contributions and *Plan* earnings, which are allocated proportionately among all participants based upon their investment in each fund. The Employer's discretionary additional contribution allocation is based on the participant's contribution as defined in the *Plan* document. Participant accounts are charged with an allocation of administrative expenses that are paid by the *Plan*. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the *Plan* document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting:

Participants are vested immediately in their contributions and Employer contributions, plus actual earnings thereon.

Notes Receivable from Participants:

Under the terms of the *Plan*, participants may borrow from their account up to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan amount allowed is \$1,000. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%, which is based on prime rate plus 1% on the date of origination. Terms range from one to five years, except loans for the purchase of a primary residence, in which case these loans are payable within a reasonable time commensurate with the repayment period permitted by commercial lenders for a similar loan. Participants may have only one loan outstanding at any given time. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits:

Upon retirement, termination, disability or death, a participant, or his or her beneficiary in the event of a death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, participants may take in-service distributions upon reaching age 59½. Upon termination, automatic distributions are required for balances of less than \$5,000. Generally, certain minimum distributions are required for participants who have separated from service and have reached age 72. Distributions from rollover accounts may be made at any time. The *Plan* allows hardship withdrawals, subject to account balance limits and applicable laws.

Administrative Expenses:

The *Plan* allows certain administrative expenses to be paid from *Plan* assets. Investment expenses netted against investment income represent amounts associated with net expense ratios of the investments in the *Plan*'s fund lineup.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting:

The financial statements of the *Plan* have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the *Plan*.

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires *Plan* management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the *Plan* document.

Investment Valuation and Income Recognition:

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the valuation policies utilizing information provided by the Trustee. See note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the *Plan's* gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits:

Benefits payments are recorded when paid. There were no benefits requested before year-end that were not paid.

Forfeited Accounts:

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,006 and \$3,812, respectively. These accounts will be used to reduce future Employer contributions. During 2024, Company contributions were reduced by \$0 from forfeited non-vested accounts.

Subsequent Events:

The Plan Administrator has evaluated subsequent events through July 22, 2025, the date the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

Accounting guidance provides a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). These three levels of the fair value hierarchy are described as follows:

Level 1 - Unadjusted quoted prices for identical, unrestricted assets or liabilities in active markets that a plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means for substantially the full term of the assets or liabilities.

Level 3 - Significant unobservable inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. There have been no changes in the methodology used at December 31, 2024 and 2023. During the year ended December 31, 2024, there were no transfers of financial instruments into or out of Level 3. Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds – Valued at quoted market prices, which represent the net asset value of shares held by the *Plan* at year-end.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the *Plan* believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 - GUARANTEED INVESTMENT CONTRACT WITH VOYA RETIREMENT INSURANCE AND ANNUITY COMPANY

The *Plan* has entered into a fully benefit-responsive guaranteed investment contract with Voya Retirement Insurance and Annuity Company (Voya). Voya maintains the contributions in its general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the *Plan*.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented at contract value on the face of the statement of net assets available for benefits. Contract value, as reported to the *Plan* by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 1 percent. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the *Plan* to transact at contract value with the issuer. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan); (2) changes to the plan's prohibition on competing investment options; (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that significantly affect the plan's normal operations; (4) the failure of the plan to qualify under 401 (a) of the Internal Revenue Code (IRC) or the failure of the trust to be tax exempt under Section 501 (a) of the IRC; or (5) premature termination of the contract. The Plan Administrator believes that no events are probable of occurring that might limit the ability of the *Plan* to transact at contract value with the contract issuer, and that also would limit the ability of the *Plan* to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the *Plan* and settle at an amount different from the contract value. Examples of such events include the following:

1. An uncured violation of the *Plan's* investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

NOTE 5 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023;
- Net investment activity and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;
- Investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

The *Plan's* independent auditor did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental information.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the *Plan* for these services. Certain administrative expenses, totaling approximately \$53,000, were paid by the Company on behalf of the *Plan* for the year ended December 31, 2024. The Company does not expect reimbursement from the *Plan* for these expenses.

Certain mutual funds are issued by the Trustee. The *Plan* also holds notes receivable from participants. These transactions qualify as party-in-interest transactions. Certain fees incurred by the *Plan* are included in the net appreciation (depreciation) in fair value of investments.

NOTE 7 - TAX STATUS

The Company adopted a Preapproved Plan sponsored by Voya Retirement Insurance and Annuity Company. The Internal Revenue Service has determined and informed the Preapproved Plan sponsor by a favorable opinion letter dated June 30, 2020, that the Preapproved Plan is designed in accordance with the applicable sections of the Code. The Preapproved Plan's opinion letter is being relied on by the Plan. *Plan* management believes the *Plan* is designed and is currently being operated in compliance with the applicable requirements of the Code and, therefore, believes that the *Plan* is qualified and the related trust is tax-exempt.

NOTE 8 - RISKS AND UNCERTAINTIES

The *Plan* invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported on the statements of net assets available for benefits.

NOTE 9 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the *Plan* to discontinue its contributions at any time and to terminate the *Plan* subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the *Plan* of any vested right.
