NOTE 1 - PLAN DESCRIPTION

The following description of Egon Zehnder International, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all eligible employees of Egon Zehnder International, Inc. (the "Company") who are not subject to a collective bargaining agreement or are not a leased employee and have attained the age of 21. Employees must have completed six months of service to be eligible to receive discretionary employer matching contributions. Employees must have completed one year of employment and a minimum of 1,000 hours of service to be eligible to receive discretionary profit-sharing contributions and will enter the profit-sharing portion of the Plan on one of two entry dates, May 1 or November 1. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Participants may contribute pre-tax and Roth contributions up to a maximum of 80% of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code ("IRC"). Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Once an employee is eligible to participate in the Plan, employee deferral contributions are automatically made at the rate of 4% of the employee's eligible compensation unless the employee elects a different deferral rate or affirmatively elects not to participate in the Plan. If a participant does not elect a different rate, the deferral rate automatically increases each year by 2% of eligible compensation.

As of October 31, 2024 and 2023, the Company made a discretionary employer matching contribution of 50% of the participant's contribution, not to exceed 4% of the employee's eligible compensation. Eligible participants must be employed on the last day of the Plan year to receive a discretionary employer matching contribution.

The Company may also make discretionary profit-sharing contributions to the Plan, as approved by the Company's management. The discretionary profit-sharing contribution is a cross-tested allocation based on a participant group allocation method. The Participants must be employed on the last day of the Plan year to be eligible for any discretionary profit-sharing contribution. For the year ended October 31, 2024, Partners received a discretionary profit-sharing contribution equal to 7% of eligible compensation and non-Partners received a discretionary profit-sharing contribution equal to 5% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings and charged with withdrawals, an allocation of Plan losses and administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

Vesting

Participants are immediately 100% vested in employee and rollover contributions and any income or loss thereon. Participants vest in contributions made by the Company 20% after two years of service and 20% each successive year through year six, at which time the participant is fully vested.

Notes Receivable from Participants

Participants may borrow from their accounts subject to certain maximum and minimum amounts prescribed in the Plan agreement and in the IRC. A participant may not have more than one outstanding loan at any time. Notes receivable are collateralized by the participant's account balance and bear interest at 6.25% at both October 31, 2024 and 2023. Principal and interest are paid ratably through payroll deductions over a period not to exceed five years, unless the loan is used to acquire a primary residence in which case the term shall not exceed 10 years.

Benefit Payments

Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum, installments, or partial withdrawals amount equal to the vested balance of a participant's account.

In addition, participants may elect in-service withdrawals of all or a portion of their accounts after reaching age 59½ or in the case of severe financial hardship, as defined in the Plan document. The Company must approve any such hardship withdrawals. Beginning January 1, 2023, the Setting Every Community Up for Retirement Enhancement Act of 2022 (the "SECURE Act 2.0") increased the age to commence required minimum distributions to 73 which will increase again to 75 on January 1, 2033.

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future Company contributions or to pay administrative expenses. During the year ended October 31, 2024, approximately \$563,000 of forfeitures was used to reduce Company contributions. At October 31, 2024 and 2023, the balance in the forfeitures account totaled approximately \$569,000 and \$351,000, respectively.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all benefits would become fully vested and non-forfeitable, and the net assets of the Plan would be allocated to participants, after payment of any expenses.

Party-in-Interest Transactions

Certain Plan assets are in investment funds managed by Fidelity Management Trust Company or its affiliates ("Fidelity" or the "Trustee"). Fidelity is the trustee of the Plan, so these transactions are considered party-in-interest transactions. Notes receivable from participants and other income, which represents revenue sharing credits allocated to participant accounts, are also considered party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and the changes therein. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as those held during the year.

Notes Receivable from Participants

Notes receivable from Participants are recorded at their unpaid principal balances plus any accrued interest. Related fees are recorded as administrative expenses when incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Other Income

Each quarter, Fidelity funds and allocates an annual participant revenue credit to eligible participant. This credit is presented as other income on the statement of changes in net assets available for benefits.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Various administrative expenses were paid by the Company for the year ended October 31, 2024. Additionally, each quarter, Fidelity funds and allocates an annual participant revenue credit to eligible participants. This credit is presented as other income on the statement of changes in net assets available for benefits.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

Subsequent events have been evaluated through July 18, 2025, which is the date the financial statements were available to be issued. The Plan is not aware of any subsequent events that would require recognition or disclosure in the financial statements.

NOTE 3 - INFORMATION CERTIFIED BY THE TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, has certified that the following data included in the financial statements and supplemental schedule are complete and accurate:

- Investments, at fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of October 31, 2024 and 2023.
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended October 31, 2024.
- Schedule H, line 4(i), schedule of assets (held at end of year) as of October 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

- Level 1 - Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.
- Level 2 - Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.
- Level 3 - Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset. The Plan has no Level 3 investments.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds - Mutual funds are valued at quoted prices reported in active markets.

Money Market Fund - Money market funds are valued at quoted prices reported in active markets.

NOTE 5 - TAX STATUS

The Plan has adopted a pre-approved plan. The underlying pre-approved plan has received an opinion letter from the Internal Revenue Service (“IRS”) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and related trust is tax exempt.

U.S. GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the RIS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of October 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax periods in progress.
