INDEPENDENT AUDITORS' REPORT

To the Plan Administrator and Sponsor of the

Opinion on the 2024 Financial Statements

Notes to Financial Statements

December 31, 2024 and 2023

NOTE 1 – DESCRIPTION OF PLAN

The Texas Medical Association Insurance Welfare Benefits Fund (the Fund) was established in January 2018 to purchase and provide insurance for eligible participants through a group insurance arrangement (the Plan) and is subject to the Employee Retirement Income Security Act of 1974 (ERISA), which governs employee benefit plans. The Plan covers any member of Texas Medical Association (TMA); employees, former employees, partners, and certain sole proprietors of (a) Texas Medical Association Insurance Trust (TMAIT) or TMA; (b) Texas county medical societies; (c) Texas state medical specialty societies; (d) employers that maintain a medical residency program; or (e) employers that are members of TMA or are owned in whole by members of TMA, subject to certain restrictions (collectively, the Employers).

The following description of the Fund, as defined in the Fund's trust agreement, provides only general information. Participants should refer to the various program agreements for a more complete description of the Fund's provisions.

Insured Benefit Programs

The Fund provides fully insured death, disability, accidental death and dismemberment, dental, and vision benefits. The Fund is the holder of insurance policies and acts as the conduit for payment of the premiums. The Fund receives contributions from the participating employers and participants and remits the premium payments to Metropolitan Life Insurance Company and Prudential Financial Inc., the insurers.

Contributions

Employers and individual participants submit contributions to the Fund in amounts necessary to fund the benefits provided by the Fund. Contributions rates are established by the Board of Trustees, in conjunction with the insurance carriers.

Termination

In the event the Fund terminates, the Board of Trustees shall apply the net assets of the Fund to pay or to provide for the payment of any and all obligations of the Fund and distribute and apply any remaining amounts for the continuance of the benefits provided by the Plan until the net assets of the Fund are exhausted.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis in accordance with accounting principles generally accepted in the United States of America.

NOTE 2 – SUMMARY OF ACCOUNTING POLICIES – (CONTINUED)

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Concentrations of Credit Risk

Financial instruments that potentially subject the Fund to concentrations of credit risk consist of cash and cash equivalents. The Fund maintains its cash and cash equivalents, which at times may exceed federally insured limits, in highly rated financial institutions. The Fund has not experienced any loss relating to cash and cash equivalents in these accounts.

Contributions

Subscriber contributions are credited to net assets in the period in which the related insurance coverage is in force.

Premiums

Premiums for insurance are recorded in the statement of changes in net assets available for benefits in the period in which the related insurance coverage is in force and are payable to the insurance carrier in accordance with applicable policy provisions based on rates mutually agreed to by the insurance carriers and the Fund. Premiums payable to insurance carriers consists of: (i) amounts received by the Fund from Employers or individual participants on or prior to the respective statement of net assets available for benefits date which are pending remittance to the insurance carriers on the date of the statement of net assets available for benefits; and (ii) overpayments from Employers or individual participants which are subject to future remittance to the insurance carriers or refundable to Employers or individual participants. Overpayments from Employers or individual participants which are subject to future remittance to the insurance carriers or refundable to Employers or individual participants totaled approximately \$18,000 and \$17,000 at December 31, 2024 and 2023, respectively, and reflected in "premiums payable to insurance carriers" on the accompanying statements of net assets available for benefits.

Income Taxes

The Fund is required to operate in conformity with the Internal Revenue Code (the "Code") and ERISA. The Board of Trustees believes the Fund is operating in conformity with the Code and ERISA.

The Fund is a taxable trust, subject to federal income taxes. For the years ended December 31, 2024 and 2023, deductible expenses exceeded income and no federal income taxes were recognized.

Subsequent Events

The Plan has monitored and evaluated subsequent events for footnote disclosures or adjustments required in the financial statements for the year ended December 31, 2024 through July 29, 2025, the date on which financial statements were available to be issued.

NOTE 3 – RELATED PARTY AND PARTIES-IN-INTEREST TRANSACTIONS

ERISA defines parties-in-interest similarly to FASB ASC 850, *Related Party Disclosures*, except that ERISA's definition is broader and includes all entities and individuals that provide services to the Fund, any fiduciary of the Fund, the participating employers, and certain others; however, these entities may not necessarily be related parties. The Fund did not identify any related parties to the Fund that were not also considered to be parties-in-interest. The Fund did not enter into any material related party transactions during the year related to compensation arrangements, expense allowances, or similar items.

TMA and TMAIT provide general and administrative services to the Fund but do not charge the Fund for such services. TMA and TMAIT are parties-in-interest to the Fund, as defined in Section 3(14) of ERISA. The insurance carriers with which the Fund contracts to provide benefits are also parties-in-interest. All transactions with parties-in-interest qualify as exempt party-in interest transactions under ERISA.
