(1) Description of Plan

The following brief description of the Modern Group Ltd. Employee Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, with 401(k) provisions, covering substantially all full-time employees of Modern Group Ltd. (the Company). Employees are eligible to participate in the Plan and to defer wages after 30 days of employment. Employees are eligible to receive matching contributions after working six consecutive months with at least 500 hours of service. Eligible employees are automatically enrolled. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Savings Plan Investment and Advisory Committee (Investment Committee) is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

The Plan is funded by contributions by its participants and discretionary employer incentive contributions. The Plan also permits Roth contributions. In order to share in employer matching incentive contributions, participants are required to contribute to the Plan. The employer is not obligated to make matching incentive contributions. The employer may also authorize discretionary profit sharing contributions. For the plan years ended October 31, 2024 and 2023, the Investment Committee authorized discretionary matching contributions at 5% of participant contributions for each quarter. There were no profit sharing contributions for the years ended October 31, 2024 and 2023.

Under the automatic contribution arrangement provisions, 4% of the participant's compensation will be deferred into the Plan. If an employee becomes a participant in the Plan under the automatic enrollment rules, the participant's salary deferral contribution percentage will automatically increase by an additional 1% each year (up to a maximum of 10%), unless the employee elects to have a different contribution percentage applied.

All contributions to the Plan by participants and the employer, plus any earnings and participant rollover or other transfer contributions, are held in a trust and administered under a written trust agreement. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company discretionary matching contributions, as well as allocations of the Company's discretionary profit sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service. Participants become 100% vested if while employed, the participant dies, becomes disabled, or reaches retirement age.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates that range from 3.25% to 8.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Forfeited Accounts

When a participant leaves the employ of the Company, their unvested balance will be forfeited. Forfeited accounts may be used to pay administrative expenses, used to reduce future employer contributions, or reallocated as additional matching contributions to participants still employed on the last day of the plan year. At October 31, 2024 and 2023, forfeited nonvested accounts totaled \$17,439 and \$14,539 respectively.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and the trustee. See Note 3 for a discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation includes gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent loans are treated as distributions based upon terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of the Plan are paid by the Plan as permitted in the plan document while other expenses are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to participant accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 24, 2025, the date the financial statements were available to be issued.

(3) Fair Value Measurements

Financial Accounting Standards Board (FASB), *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at October 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end funds that are registered with the Security and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common collective trust: Valued at the NAV of units of a collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined that the fund will sell the investment for an amount different than the reported NAV. Participant transactions may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

(4) Financial Information Certified by a Qualified Institution

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year), including investments at fair value and notes receivable from participants held at October 31, 2024 and 2023, and net appreciation in fair value of investments, interest, dividends, and interest income on notes receivable from participants for the years ended October 31, 2024 and 2023, was obtained by management and agreed to or derived from the information certified as complete and accurate by Vanguard Fiduciary Trust Company (Vanguard), a qualified institution.

(5) Asset Diversification

Asset diversification represents funds transferred from the Modern Group Ltd. Employee Stock Ownership Plan (ESOP) to the Plan. A participant in the ESOP who has attained age 55 and completed 10 years of participation in the Plan may direct the investment of a percentage of their accrued benefit each year from the ESOP to the Plan. During the first five years that a participant is eligible for diversification, they may diversify up to 25% of their accrued benefit into one or more investment funds. After five years, they may diversify up to 50% of their accrued benefit. The amount of the diversified investment is transferred to the Plan. Only the value of Modern Group Ltd. company stock may be diversified.

(6) Related Party Transactions and Party-In-Interest Transactions

Certain plan investments consist of a retirement savings trust and registered investment companies managed by an affiliate of Vanguard. These transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules.

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments.

(7) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants would become 100% vested in their employer contributions.

(8) Income Tax Status

The Plan adopted a non-standard form of a pre-approved plan document sponsored by The Vanguard Group. The pre-approved plan document has received a letter from the Internal Revenue Service (IRS) dated June 30, 2020, as to the Plan's qualified status. The pre-approved plan opinion letter has been relied upon by this Plan. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, the plan administrator believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.

(10) Nonexempt Transactions

During the year ended October 31, 2024, the Company failed to remit certain participant contributions within the timeframe prescribed by the Department of Labor's regulations. These transactions are considered prohibited transaction under ERISA. The Company intends to correct these failures by remitting lost earnings to the affected participant's accounts during 2025.
