Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Green Bay Oncology, Ltd. Employees' Profit Sharing 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1 - Description of Plan

The following brief description of Green Bay Oncology, Ltd. (Company) Employees' Profit Sharing 401(k) Plan (Plan) is provided for general purposes only. More complete information regarding the Plan's provisions may be found in the Plan document.

General

The Plan is a defined contribution plan covering all full-time and part-time employees of the Company. All employees who are at least age eighteen are automatically enrolled in the plan at 4% on their date of hire. Employees are immediately eligible to receive the discretionary employer match but need to complete a year of service to be eligible to receive a discretionary profit-sharing contribution. To receive an allocation of the discretionary employer match and profit-sharing contributions, an employee must be employed on the last day of the year. Additionally, the plan has a safe harbor contribution, which has no eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 70% of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Both the employer match contributions and profit-sharing contributions are discretionary. For the years ended December 31, 2024 and 2023, the Company contributed a discretionary employer match of \$1.00 for every \$1.00, up to 4% that a participant contributed to the Plan. There was no profit-sharing amount for either year. Additionally, for the years ended December 31, 2024 and 2023, the Company made a safe harbor contribution of 3% of eligible wages to all employees. During the years ended December 31, 2024 and 2023, the Company contributed \$711,771 and \$666,116 to the Plan, respectively. Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's matching, profit sharing and safe harbor contributions and plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions and rollover contributions plus actual earnings thereon. Vesting in the Company portion of their accounts is based on years of continuous service. A participant is 100% vested in the Company's discretionary contributions after three years of credited services. Participants are immediately vested in the Company's safe harbor contribution.

Payment of Benefits

Active participants may elect a hardship distribution according to the plan document. On termination of service due to death, disability or retirement, a participant may elect to receive a lump sum amount equal to the value of his or her account or a partial lump sum over \$5,000. However, if the value of the vested benefit is less than \$5,000, a lump-sum distribution will be made regardless of whether or not an election has been made.

Forfeited Accounts

Plan forfeitures arise as a result of participants who terminate service from the Company before becoming 100% vested in the Company's non-elective contributions and related earnings. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$10,580 and \$22,526, respectively. These accounts will be used to reduce future employer contributions. Employer contributions were reduced by \$22,160 and \$11,525 from forfeited nonvested accounts for the years ended December 31, 2024 and 2023, respectively.

Administration

The Company is the administrator of the Plan and has appointed Matrix Trust Company as trustee and OneAmerica Retirement Services LLC as recordkeeper. The trustee is responsible for investing and safekeeping all investment assets of the Plan.

Note 2 - Summary of Significant Accounting Policies

This summary of significant accounting policies of Green Bay Oncology, Ltd. Employees' Profit Sharing 401(k) Plan is presented to assist in understanding the Plan's financial statements. The financial statements and notes are representations of the Plan's management who is responsible for the integrity and objectivity of the financial statements. These accounting policies conform to generally accepted accounting principles.

Basis of Accounting

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of the financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value (except for the fully-benefit responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses may be paid either by the Plan or by the Company. Expenses paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 24, 2025, the date the financial statements were available to be issued.

Note 3 - Income Taxes

The Company adopted a volume provider prototype non-standard 401(k) profit sharing plan which has received a favorable opinion letter from the Internal Revenue Service. As such, the plan qualifies under Section 401(a) of the Internal Revenue Service Code and, therefore, is not subject to tax under present income tax laws. The plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and to recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 4 - Fair Value Measurements

The Financial Accounting Standards Board has established a framework for measuring fair value. That framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of other methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - Guaranteed Investment Contract

The Plan holds a traditional fully benefit-responsive guaranteed investment contract with BMO Harris Bank, N.A. totaling \$1,164,519 and \$1,062,137 at December 31, 2024 and 2023, respectively. BMO Harris Bank, N.A. maintains the contributions in a general account. The guaranteed investment contract issuer is contractually obligated to repay principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 4 percent. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the custodian to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by BMO Harris Bank, N.A., represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

Note 6 - Related Party and Party in Interest Transactions

Fees paid by the Plan to One America Retirement Services for investment management, trust services and other administrative services amounted to \$39,965 and \$37,129 for the years ended December 31, 2024 and 2023, respectively. Fees paid by the Plan to Matrix Trust Company for investment advisory services amount to \$5,956 and \$2,911 for the years ended December 31, 2024 and 2023, respectively. All fees are included under administrative expenses on the statements of changes in net assets available for benefits. Certain employees and officers of the Company, who are also participants in the Plan, perform administrative services to the Plan at no cost to the Plan.

One America Retirement Services provides certain administrative services to the plan pursuant to a Master Plan Services Agreement (MSA) between the Company and One America Retirement Services. One America Retirement Services receives revenue from mutual fund service providers for services One America Retirement Services provides to the funds. This revenue is used to offset certain amounts owed to One America Retirement Services for its administrative services to the Plan.

If the revenue received by One America Retirement Services from such mutual fund service providers exceeds the amount owed under the MSA, One America Retirement Services remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During years ended December 31, 2024 and 2023, there were no excess amounts. The Plan or Plan Sponsor may make a payment to One America Retirement Services for administrative expenses not covered by revenue sharing.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 8 - Information Certified by The Plan's Trustee

Certain information related to investments and the guaranteed investment contract disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and guaranteed investment contract held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Matrix Trust Company (the Trustee of the Plan).

Note 9 - Risks and Uncertainties

The Plan invests in various investment securities through mutual funds and an investment contract. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
