To Whom It May Concern,

This is an explanation of why these 5500 SF's are being filed late. I did not realize they are being filed late until I received a "warning" online in the Fast2 system.

For the past 20 years I have filed them in a timely manner every July, which covered the past year for Westminster School. That is what I was intending to do this time.

However during the year in 2024 our school changed from our own plans to a Multiple Employer Plan through the independent school association, VAIS. I knew I was responsible for filing the part of the year that it was under our school plan. In my mind I was filing for "last year." However the changeover to the Multiple plan happened on Oct. 1. So that must be the reason I am filing late. At least that is the reason the FAST2 program must have said I was late. So, the deadline was really for 7 months after the changeover, not the end of the year as I had thought.

It was a surprise to me, and not meant to be intentionally late. I am asking for forgiveness from any penalty if possible. This will be our last filing of these Westminster plans. I have also shown the number of people "at the end of year" on these plans as zero and the ending balance shows the final funds transferring to the new Multiple Employee Plan and documented in Part IV.
