To the Trustees of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Rizza Dealer Group Salary Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 – DESCRIPTION OF PLAN

Rizza Dealer Group sponsors the Rizza Dealer Group Salary Savings Plan (the Plan). The following description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

Effective March 11, 2022, the Plan was restated to reflect required regulatory changes and legislative changes for The Bipartisan Budget Act of 2018 and Final Regulations Relating to Hardship Distributions and Tax Cuts and Jobs Act.

General

The Plan is designed as a qualified cash deferred arrangement, pursuant to Section 401(k) of the Internal Revenue Code, covering all full-time non-union and union employees of Joe Rizza Enterprises, Joe Rizza Ford of Orland Park, Inc., Joe Rizza Orland Park Imports, Inc., Midwestern Financial Group, Rizza Buick GMC Cadillac, Joe Rizza Imports, Inc., and NJRP, Inc (“Rizza Dealer Group”) who are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Participants may contribute up to the 401(k) plan limit set by the IRS which was \$23,000 in 2024. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions up to \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan and may modify or transfer existing balances each business day. Newly eligible participants are automatically enrolled in the plan with a deferral equal to 6% of eligible compensation unless the employee declines to participate or elects a different deferral rate. If a participant does not choose a different percentage, the percentage will automatically be increased each first day of the plan year by 1% up to a maximum percentage of 10%.

At its sole discretion, Rizza Dealer Group may make a matching contribution equal to a discretionary percentage of employee salary deferrals. Matching contributions are invested into investment options in proportion to the participants’ investment selection for elective contributions. No matching contributions were made for years ended December 31, 2024 and 2023.

Also, at its sole discretion, Rizza Dealer Group may make an additional annual profit sharing contribution. The profit sharing contribution is allocated to the participants based on the ratio that his/her compensation bears to the compensation of all eligible participants. Profit sharing contributions are invested into investment options in proportion to the participants’ investment selection for elective contributions. No profit sharing contributions were made for the years ended December 31, 2024 and 2023.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of Rizza Dealer Group's matching and profit sharing contributions, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested balance.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the employer contribution and profit sharing portion of their accounts ranges from 20% after two years to 100% after six years of credited service.

Participants automatically become 100% vested upon retirement (attainment of age 65), disability, or death. Participants who terminate for any other reason are entitled to the vested amount of their accounts.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account, have a maximum repayment period of 60 months, and currently bear interest at 4.25% to 9.50%, which is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Benefits under the Plan are payable to participants or their beneficiaries upon death, retirement, disability, proven financial hardship or severance of employment. Benefits are to be paid in either a lump-sum, or installments for a period not to exceed the participant's life expectancy. Vested balances that do not exceed \$7,000 must be distributed in a lump-sum.

The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

Forfeited Accounts

In event of termination of employment before full vesting, the non-vested portion is forfeited upon certain conditions as specified in the Plan document, with such forfeitures being used to reduce future employer contributions and the Plan's ordinary and necessary administrative expenses. In 2024 and 2023, forfeited non-vested accounts reduced plan expenses by \$1,515.47 and \$0, respectively.

Administrative Expenses

Administrative expenses are generally paid using the Plan's assets; however, Rizza Dealer Group, at its discretion, may pay certain administrative expenses of the Plan. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account and are included in other fees along with investment advisory fees.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation

Accompanying financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Risks and Uncertainties

The Plan holds various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investments securities, it is reasonable possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value, except for fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive investment contracts are reported at contract value because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on the trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment related expenses are included in net change in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Corrective Distributions

Corrective distributions are netted against contributions received.

Subsequent Events

The Plan has evaluated subsequent events through July 17, 2025 which is the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASURES

Financial Accounting Standards Board established a three-tier hierarchy to measure the fair value of an asset or liability. Level 1 inputs include unadjusted quoted prices in active markets for identical assets or liabilities. Level 2 inputs include market data that are directly or indirectly observable. Level 3 inputs are unobservable and corroborated by little or no market data.

Mutual funds are valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the United States Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are included in Level 1.

The valuation methodologies described above may produce a fair value calculation that may not be indicative of net realizable value or future fair values. While the Plan believes the valuation methodologies used are appropriate, the use of different methodologies or assumptions in calculating fair value could result in a different fair value measurement at the reporting date.

NOTE 4 – CERTIFIED INVESTMENTS

Participants direct the investment of their accounts, as listed on Schedule A-1. The Plan’s custodians, Delaware Charter Guarantee and Trust Company, doing business as Principal Trust Company provide a menu of investment options from which participants may select. Participants may modify or transfer existing balances each business day. The plan custodians execute all investment transactions and Schedule A-1 summarizes the fair value of investments at December 31, 2024.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company, doing business as Principal Trust Company.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan has entered into a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company (“Principal”). Principal maintains the investment in this contract in its general account. The account is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Principal is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Interest crediting rate is reset semi-annually. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Because the general account investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute. Contract value, as reported to the Plan by Principal, represents contributions made under the contracts, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal of their investment at contract value.

Generally, there are no restrictions on a participant’s ability to redeem their investment in the general account investment contract. Certain events, such as termination of the Plan, termination of the contract by the Plan or changes in laws or regulations, may limit the ability of the Plan to transact at contract value. Principal may assess 5% surrender charge upon termination of the contract by the Plan. The Company does not believe that any events that may limit the ability of the Plan to transact at contract value are probable.

Participant transfers are subject to an “Equity Wash.” Participants may not transfer amounts out of this investment and directly into a competing investment. Transfers must be invested in a non-competing investment for 90 days before amounts may be invested in a competing investment. Competing investments include other guaranteed investment options, stable value, money market or other short term fixed income investment option with durations of 3 years or less.

The group annuity contract does not permit the insurance company to terminate the agreement prior to scheduled maturity date.

NOTE 6 – RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

As the Plan sponsor, the Company is a party-in-interest with respect to the Plan. Certain administrative functions are performed by officers and employees of the Rizza Dealer Group. No officer or employee receives compensation from the Plan for these services.

As of December 31, 2024 and 2023, Plan investments included general account contract with Principal Life Insurance Company, and Principal Funds Inc acted as investment advisor and issuer for several of the Plan’s funds. Principal Life Insurance Company and Principal Funds Inc are parties in interest with respect to the Plan.

The Plan paid administrative fees of \$42,270 to Principal Life Insurance Company during 2024. Recordkeeping service fees of 0% of net assets available for benefits are included in net appreciation in the fair value of investments, rather than other administrative fees.

NOTE 7 – INCOME TAX STATUS

The Internal Revenue Service (“IRS”) has determined and informed the Plan sponsor by letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”). The Plan administrator and the Plan sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and the related trust is tax-exempt.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, Rizza Dealer Group has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
