NOTES TO THE FINANCIAL STATEMENTS  
December 31, 2024 and 2023

## NOTE A - DESCRIPTION OF PLAN

The following brief description of the Central States Health & Life Co. of Omaha (the Company) Progress Sharing & Savings Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

*General.* The Plan is a defined contribution plan. Employees who have attained age 19 and have completed 30 days of service are eligible to make participant contributions to the Plan on the first pay date he or she meets age and service requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan has also adopted the option to allow a withdrawal as much as \$5,000 from a participant's account in the year following the birth or adoption of a child without incurring the early withdrawal tax or being subject to a mandatory withholding, as part of the Setting Every Community Up for Retirement Enhancement (SECURE) Act.

*Participant Accounts.* Each eligible participant's investment account is credited with the eligible participant's contribution; the Company's matching contribution; an allocation of fund earnings; and investment management fees. In addition, each eligible participant's account is credited with an allocation of (a) the Company's discretionary contribution, if any, (b) Plan earnings on discretionary contributions, and (c) forfeitures of terminated eligible participants' nonvested accounts, if any. Employer discretionary contributions and forfeitures are allocated to eligible participants in the proportion that such eligible participant's compensation bears to the aggregate compensation of all eligible participants. The benefit to which an eligible participant is entitled is the benefit that can be provided from the eligible participant's vested account.

*Employee Contributions.* Each year, participants may contribute, as a pre-tax and/or Roth deferral, up to 50% of their eligible compensation, as defined by the Plan. Contributions are subject to certain dollar limitations, as imposed by the Internal Revenue Service (IRS). Participants also may rollover amounts representing distributions from other plans. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions, provided they also have maximized (or are on track to maximize) the IRS 402(g) annual dollar limit for the calendar year. Participants direct the investment of employee and employer matching contributions into various investment options offered by the Plan.

Effective January 1, 2015, employees are automatically enrolled in the Plan at a pre-tax deferral percentage equal to 6% of compensation. The employee shall be given notice of such deemed authorization and a reasonable opportunity to change the percentage of his or her compensation (including to zero percent) to be contributed as salary reduction contributions.

*Employer Contributions.* The Company provides a safe harbor matching contribution of 100% of each participant's contribution up to a maximum of 6% of their eligible compensation, as defined by the Plan. In addition, the Company may make additional contributions at the sole discretion of the Company's board of directors, subject to limitations established in the Internal Revenue Code. Participants must be employed on the last day of the Plan year and have completed 1,000 hours of service during the Plan year to receive the Company's discretionary contributions. For the years ended December 31, 2024 and 2023, the Company made a discretionary contribution of \$150,117 and \$145,256, respectively. Participant direction of the Company's discretionary profit-sharing contribution is permitted immediately.

*Investments.* Upon enrollment in the Plan, participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan.

**NOTE A - DESCRIPTION OF PLAN (CONTINUED)**

*Vesting.* Participants are immediately and fully vested in their voluntary contributions, employer matching contributions, and actual earnings (losses) thereon. Vesting in employer discretionary contributions, forfeitures and actual earnings thereon is based on years of service. Participants become 100% vested after three Plan years of service in which 1,000 hours are worked or the normal retirement age of 65, whichever occurs earlier.

*Forfeitures.* At December 31, 2024, the forfeited nonvested accounts totaled \$1,123. These accounts will first be used to reinstate the account balances of any participants who have been rehired and who have met the requirements of reinstatement of previously forfeited amounts and, at the election of the Company, to pay Plan expenses. Remaining forfeitures shall then be allocated to participants.

*Notes Receivable from Participants.* Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50% of the participant's vested account or \$50,000. The \$50,000 limit is reduced by the highest outstanding note balance during the preceding 12 months. The notes are secured by the balance in the participant's account and bear interest rates of regional prime plus 2% at the time of loan origination and bear interest at 5.25% - 10.5% at December 31, 2024. Principal and interest are paid ratably through bi-weekly payroll deductions over a period not to exceed five years, unless the purpose of the note is to acquire or construct the primary residence of the participant, in which case the repayment period shall not exceed ten years. The mature dates ranged between March 2025 to October 2029.

*Payment of Benefits.* Upon termination of service due to death, disability, retirement or termination of an employee, a participant is entitled to the vested percentage of the participant's share of the Plan. Distributions are made in a lump sum, partial distribution, or periodic installments over a period not to exceed the life expectancy of the participant and the participant's designated beneficiary. The nonvested amounts are forfeited by the terminated employee.

Upon death or permanent disability, a participant becomes fully vested in their employer discretionary contribution and forfeiture account, and the beneficiary of the participant is entitled to receive that participant's proportionate share of the Plan.

In addition, the Plan allows for withdrawals for employees over 59 ½ and hardship distributions if certain criteria are met.

*Plan Administration.* Administration of the Plan is vested in the Benefit Compensation & HR Committee appointed by the Company's board of directors.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

*Basis of Accounting.* The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

*Use of Estimates.* The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

*Investment Valuation and Income Recognition.* The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurement.

Purchases or sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

*Notes receivable from participants.* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

*Contributions.* Contributions from employees are recorded as they are withheld from the participant's wages.

*Payment of Benefits.* Benefits are recorded when paid.

*Expenses of the Plan.* Administrative fees and expenses of the Plan may be paid out of the Plan assets unless paid by the Company. Certain administrative fees are paid by the Company.

*Date of Management Review.* The Plan considered events occurring through July 9, 2025, for recognition or disclosure in the financial statements as subsequent events. That date is the date the financial statements were available to be issued.

**NOTE C – INFORMATION PREPARED AND CERTIFIED BY VANGUARD FIDUCIARY TRUST COMPANY**

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified, except for comparing such information certified by the Trust Company to information included in the Plan's financial statements and supplemental schedule.

**NOTE D - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to written notification of all parties concerned and subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their accounts.

**NOTE E - TAX STATUS**

The IRS has determined and informed the plan sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRS). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Management has evaluated the Plan's tax positions and concluded the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### NOTE F – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### NOTE G – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, Fair value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

*Level 1 Fair Value Measurements* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2 Fair Value Measurements* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3 Fair Value Measurements* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

*Mutual funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end.

*Exchange traded funds:* Valued at the closing price quoted in the active market in which the fund is traded.

*Common collective trust:* The Plan's interest in the collective trust is based on the fair value of the collective trust's underlying investments as based on information reported by the investment advisor using the audited financial statements of the collective trust at year end.

*Self-directed brokerage accounts* – Account consist primarily of mutual funds valued at the net asset value of shares held by the Plan at year end and common stocks and foreign ordinaries valued at the closing price reported on the active market on which the individual securities are traded. Accounts also include non-interest-bearing and interest-bearing cash whose cost approximates its fair value to the short-term nature and US Treasury bills valued at the market value of the bills.

**NOTE G – FAIR VALUE MEASUREMENTS (continued)**

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) This category invests in a tax exempt common/collective trust that intends to provide a stated rate of return to the buyer of the contract for a specified period of time. The common/collective trust invests primarily in investment contracts issued by insurance companies and commercial banks, and similar types of fixed-principal investments. The fund prohibits participants from making direct exchanges from the common/collective trust to a competing option. Instead, participants must first exchange assets to a non-competing fund (typically an equity fund) and remain in that fund for 90 days before exchanging into a competing option.

**NOTE I – PARTY-IN-INTEREST TRANSACTION:**

Certain Plan investments are shares of money market and mutual funds managed by Vanguard Fiduciary Trust Company. Vanguard Fiduciary Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rule. Fees paid by the Plan for investment management services provided by Vanguard Fiduciary Trust Company amounted to \$32,211 for the year ended December 31, 2024.
