### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Wisk Aero LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

## **Wisk Aero LLC 401(k) Plan Notes to Financial Statements**

---

### **Note 1 – Description of the Plan**

The following description of the Wisk Aero LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General** – The Plan is defined contribution 401(k) plan covering all eligible employees of Wisk Aero LLC (the Company). Employees who are not part of an excluded class become eligible to participate immediately upon attaining age 21 and completing three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Administration** – Fidelity Management Trust Company (Fidelity) is the custodian of the Plan.

**Contributions** – Contributions to the Plan are in the form of salary reductions, which participants have elected to defer in lieu of current compensation. Participants may elect to contribute, subject to statutory limitations, up to 50% of their eligible pay. Participants aged 50 or older are allowed to make catch-up contributions up to 100% of eligible pay. Participants may elect to change contribution percentages to be effective the next pay period after the request is received or as soon as administratively possible. The allocation of both their contributions and employer contributions to the funds may be changed at any time and become effective on the day of the change or the next business day based on the day and time the request for a change is made in relation to the stock market close of business. The Plan allows active employees to contribute to the Plan from pre-tax compensation, after-tax compensation, or a combination of both. The Plan also accepts certain rollover contributions.

Under the terms of the Plan, the Company may make discretionary matching or profit sharing contributions for eligible participants. The Plan makes discretionary match contributions equal to 50% of the employee's contributions for pre-tax and Roth deferrals. The discretionary matching contribution for the year ended December 31, 2024, was \$4,558,444, which was paid on a per-pay-period basis.

**Participant accounts** – Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions, the Company's contributions, and allocations of Plan earnings (losses) from the funds in which the account is invested and charged with an allocation of certain administrative and investment-related expenses and participant-specific charges, if applicable. Allocations are based on participant earnings or account balances, as defined by the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are fully vested in their contributions and employer contributions including accumulated earnings.

**Forfeitures** – Forfeitures are retained in the Plan and may be used to pay administrative expenses or reduce future Company contributions. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$1,470 and \$16,728, respectively. There were \$46,175 forfeitures used during the year ended December 31, 2024, to reduce employer contributions or pay administrative expense.

**Withdrawals** – Participants may elect to withdraw all or a portion of their accounts at any time on or after the day they attain age 59-1/2. If a participant is under age 59-1/2, withdrawals from their pre-tax contribution, Roth contribution, and employer matching accounts are subject to certain hardship rules as provided by the Plan. Employer contributions may be fully withdrawn upon termination of employment. Withdrawals of after-tax contributions and rollover contributions can be made at any time.

**Notes receivable from participants** – Participants are permitted to borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their total vested account balance at the time of the loan issuance and may have only one loan outstanding at any time. Loans may be further limited in accordance with Plan provisions. The interest rate on new loans is determined by plan administration to be a reasonable interest rate based on prevailing rates charged by lenders in the market as of the date of the loan. Interest rates on outstanding loans ranged from 4.25% to 9.50% at December 31, 2024, with loans maturing at various dates through December 2033.

Loan repayments are made through regular payroll deductions for a period of up to 60 months for general loans and over a longer period for loans used to finance the purchase of a principal residence. If a participant's employment terminates for any reason, and the loan balances are not paid in full by the termination date, the participant may continue to make monthly loan repayments until the loan is scheduled to be paid off. A loan will continue to be subject to default if a payment has not been made for 90 days, an outstanding loan balance remains 30 days after the scheduled payoff date, or the participant takes a full distribution of their account before the loan is paid off. If the loan defaults, the loan balance will become taxable income to the participant.

**Benefit payments** – On termination of service, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in their account, installment payments over the participant's life expectancy, roll their account balance to another company's qualified plan or an individual retirement account, or defer distribution until a later date (if the balance exceeds \$7,000).

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of estimates** – The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and uncertainties** – The Plan's investments are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

**Valuation of investments and income recognition** – The Plan’s investments are stated at fair value. The Plan’s custodian, Fidelity Management Trust Company, certifies the fair value of all investments. If available, quoted market prices are used to value investments. Fair value of the financial instrument is the price that would be received to sell an asset or paid to transfer a liability (exit price) in an orderly transaction between market participants at the measurement date. Investments in the Plan are valued as follows:

*Mutual funds* – The Plan’s investments in mutual funds are valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission.

*Collective investment fund* – Units held in the collective investment fund are valued using the NAV of the fund as reported by the fund manager. The NAV is based on the fair value of the underlying assets owned by the collective investment fund, minus its liabilities, and then divided by the number of units outstanding. The collective investment fund can be redeemed daily, and there are no redemption restrictions or notice requirements.

*Self-directed brokerage accounts* – The Plan’s investments in self-directed brokerage accounts may include stocks, mutual funds, exchange-traded funds and fixed income investments such as corporate and government bonds, and are valued using quoted market prices of the investments.

Purchases and sales of securities are recorded on a trade date basis and dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis of accounting. Net appreciation or depreciation in fair value of investments consists of gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

**Contributions** – Contributions from participants and corresponding matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Necessary and proper expenses of the Plan are paid from the Plan’s assets, except for those expenses the Company is required by law or chooses to pay.

**Subsequent events** – The Plan has evaluated subsequent events through July 28, 2025, the date the financial statements were available to be issued.

### Note 3 – Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements* (ASC 820) established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1** – Values are based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

**Level 2** – Values are based on (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in non-active markets; or (c) valuation models whose inputs are observable, directly or indirectly, for substantially the full term of the asset or liability.

**Level 3** – Values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement.

The methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth by level within the fair value hierarchy a summary of the Plan's investments by general types of assets measured at fair value on a recurring basis at December 31, 2024 and 2023. As required by ASC 820, assets are classified in their entirety based on the lowest level of input that is significant to the fair value measurement.

### Note 4 – Certified Investment Information

### Note 5 – Tax Status

The Plan is based on a non-standardized pre-approved defined contribution plan that received a favorable opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the pre-approved plan, as then designed, was compliant with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter; however, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan's tax-exempt status has not been affected, and no provision for income taxes has been included in the Plan's financial statements.

In accordance with guidance on accounting for uncertainty in income taxes, the Plan administrator has evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan and discontinue its contributions at any time, subject to the provisions of ERISA. If the Plan is terminated, amounts allocated to a participant's account become fully vested.

### **Note 7 – Party-In-Interest Transactions**

The Plan invests in shares of a mutual fund managed by affiliates of Fidelity Management Trust Company. Therefore, these transactions qualify as exempt party-in-interest transactions.

### **Note 8 – Delinquent Participant Contributions**

As disclosed in the accompanying supplemental schedule, certain employee deferrals were not remitted to the Plan within the timeframe required by the Department of Labor. The Company has determined the amount of related lost earnings and has remitted these amounts to participants' accounts subsequent to year end.
