Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Baylor Scott & White Health Retirement Savings Plan (Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Empower Trust Company, LLC, a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

For the Years Ended December 31, 2024 and 2023

1. DESCRIPTION OF THE PLAN

The following description of the Baylor Scott & White Health Retirement Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan sponsored by Baylor Scott & White Holdings (BSW Holdings), covering employees of BSW Holdings and certain affiliates (collectively, the “Company” or “BSWH”) who have completed one hour of service and are not covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Finance and Investment Committee of the BSW Holdings Board of Trustees determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

The Plan allows for plan-to-plan transfers between qualified plans of certain affiliates and subsidiaries of the Company due to changes in employment.

The Plan’s trustee is Empower Trust Company, LLC (also referred to as the “Trustee”).

Contributions

Participants may make salary deferrals from 1% to 50% of their eligible annual compensation, as defined by the Plan. The Plan allows for pre-tax and Roth contributions. The Plan also allows participants to make rollover contributions from other qualified plans.

The Plan allows for dollar-for-dollar Company matching contributions up to 5% of each participant’s eligible compensation, as defined by the Plan, that the participant contributes to the Plan. The Company may make an additional discretionary matching contribution for each Plan year in an amount determined by the Company. No additional discretionary matching contributions were authorized for 2024 or 2023. The Company may make qualified non-elective contributions for each Plan year in an amount determined by the Company. No qualified non-elective contributions were made for 2024 or 2023.

The Plan permits catch-up deferral contributions for participants who attain age 50 before the close of a Plan year. Catch-up deferrals are not eligible for matching contributions.

Contributions are subject to current Plan or Internal Revenue Service (IRS) limits. Participants are permitted to direct investments in their accounts by choosing among the funds the Plan makes available for investment.

Participant Investment Account Options

Investment account options available include various funds. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily with certain limitations relative to day trading regulations.

Participant Accounts

Each participant's account is credited with the participant's contributions, rollovers, Company contributions, and an allocation of earnings, and is charged with an allocation of any related expenses or charges, as defined by the Plan. Allocations are based on participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. All Company matching and discretionary contributions to the Plan, as well as earnings on these contributions, vest after three years of credited service. In the event of death, disability, or attainment of age 65 while employed by the Company, a participant's account becomes fully vested.

Benefits

Distribution of a participant's vested account is available to the participant upon retirement, age 59½, termination, or designated beneficiary upon participant's death. Vested account balances under \$5,000 will be forced out of the Plan unless the participant elects a lump-sum distribution or direct rollover to another plan within 90 days of their termination. If a participant fails to make an election within the stated timeframe, accounts with a vested balances under \$1,000 will automatically be issued as a lump-sum payment. Accounts with a vested balance between \$1,000 to \$5,000 will be automatically rolled over into an Individual Retirement Account (IRA) established in the participant's name. Effective April 1, 2024, forced out accounts with a vested balance between \$1,000 to \$7,000 in which the participant failed to make an election within the stated timeframe, will have their account balance automatically rolled over into an IRA established in the participant's name. Effective January 1, 2025, forced out accounts with a vested balance up to \$7,000 in which the participant failed to make an election within the stated

timeframe, will have their account balance automatically rolled over into an IRA established in the participant's name. Accounts with a vested balances greater than \$7,000 have the option to leave their account balance in the Plan, request a rollover to another employer's plan or IRA, receive a partial distribution, receive a lump-sum distribution, or receive monthly, quarterly, or annual calculated payments for a specified period of time (but not to exceed the expected life expectancy of the participant or the joint life expectancy of the participant and their beneficiary). Participants who satisfy certain conditions may elect a hardship withdrawal.

Notes Receivable From Participants

The Plan document includes provisions authorizing loans from the Plan to active eligible participants. Notes receivable from participants in the accompanying statements of net assets available for benefits represent participant loans. Participants may borrow from their fund accounts a minimum of \$1,000. The maximum amount of a participant's loan is determined by the available loan balance, restricted to the lesser of \$50,000 or 50% of the participant's vested account balance between the Plan, the Baylor Scott & White Health 403(b) Savings Plan, and the Baylor Affiliated Services Retirement Savings Plan (the "BAS Retirement Plan"), collectively, the "BSWH Plans". A participant may only have two loans outstanding (one residential and one general purpose) at any time between the BSWH Plans. All loans are secured by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholds, unless the participant is paying the loan in full. Effective January 1, 2022, the Plan was amended for all new loans to follow the repayment policies of the Trustee, which is a monthly ACH payment directly to the Trustee. Interest on the loans is based on the prime rate plus 1%. At December 31, 2024, loans outstanding bore interest at rates ranging from 4.25% to 9.50% with maturities through December 2034.

Forfeited Accounts and Unclaimed Distributions

Unallocated forfeitures are used to pay administrative expenses incurred by the Plan, and to reduce the Company matching contributions. The amount of unallocated forfeitures at December 31, 2024 and 2023, was approximately \$1,785,000 and \$8,246,000, respectively. For the years ended December 31, 2024 and 2023, forfeitures of approximately \$5,888,000 and \$1,851,000, respectively, were used to offset employer contributions and pay administrative expenses of the Plan. At December 31, 2024 and 2023, the Plan's net assets available for benefits included approximately \$1,399,000 and \$1,210,000, respectively, of unclaimed distributions to participants or former participants of the Plan. The unclaimed distributions are restricted and may not be used to pay certain administrative expenses or to reduce future employer contributions. The unclaimed distributions are not escheated, as escheatment is prohibited by ERISA.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants shall become fully vested, and payment of such vested amounts shall be distributed as soon as practicable.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on an accrual basis of accounting.

Use of Estimates

Preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risks associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will continue to occur in the near term, and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

Investments and Investment Income

Investments are reported at fair value. Accounting Standards Codification (ASC) 820, "*Fair Value Measurement*," provides a single definition of fair value, establishes a framework for measuring fair value, and requires expanded disclosures concerning fair value measurements.

See Note 4, “Fair Value Measurements,” for information about financial assets and liabilities measured at fair value.

Purchases and sales of securities are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date and expenses are accrued on a daily basis. Interest income is recorded on an accrual basis. The Plan presents, in the statements of changes in net assets available for benefits, the net appreciation in the fair value of investments, consisting of realized gains and losses, and the unrealized appreciation and depreciation on those investments, dividends, and interest.

Notes Receivable From Participants

Notes receivable from participants are measured at the unpaid principal balance, plus any accrued interest. Interest income is recorded on an accrual basis.

Related fees are recorded as administrative expenses and are expensed as incurred. No allowances for credit losses have been made as of December 31, 2024 or 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Benefit Payments

Benefit payments to participants are recorded when paid.

Transfers From (To) Qualified Plans, Net

Transfers from (to) qualified plans, net, primarily represents net transfers between the Plan and the BAS Retirement Plan. For the year ended December 31, 2024, there were approximately \$568,000 transfers into the Plan from the BAS Retirement Plan, and approximately \$154,000 transfers out of the Plan to the BAS Retirement Plan. For the year ended December 31, 2023, there were approximately \$12,000 transfers into the Plan from the BAS Retirement Plan, and approximately \$50,000 transfers out of the Plan to the BAS Retirement Plan.

3. CERTIFICATION OF PLAN TRUSTEE

BSW Holdings has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee, a qualified institution, has certified the following information included in the accompanying financial statements and ERISA-required supplemental schedules is complete and accurate:

- Investment income and interest income from notes receivable from participants as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investments and notes receivable from participants information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedules.

4. FAIR VALUE MEASUREMENTS

As defined in ASC 820, fair value is based on the prices that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In order to increase consistency and comparability in fair value measurements, ASC 820 establishes a three-tier fair value hierarchy for disclosure of fair value measurements. The valuation hierarchy is based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date. The three levels are defined as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that reflect the reporting entity's own assumptions about the assumptions market participants would use in pricing the asset or liability are unobservable and developed based on the best information available in the circumstances.

A financial instrument's categorization within the valuation hierarchy is based upon the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to

maximize the use of observable inputs and minimize the use of unobservable inputs. The carrying value of contributions receivable and total liabilities are reasonable estimates of their fair values due to the short-term nature of these financial instruments.

The following is a description of the valuation methodologies used by the Plan for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market fund: Valued at net asset value (NAV), which is determined using quoted prices in active markets for identical instruments at year-end.

Registered investment companies: Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective trust funds: Valued at NAV, which are provided by fund house or other investment provider based on underlying investments.

All investments held in registered investment companies, as of December 31, 2024 and 2023, totaling approximately \$810,660,000 and \$767,086,000 respectively, are classified as Level 1 within the fair value hierarchy, which are included in investments, at fair value, on the accompanying statements of net assets available for benefits.

All investments held in collective trust funds, as of December 31, 2024 and 2023, totaling approximately \$3,702,617,000 and \$3,227,019,000 respectively, are valued at NAV within the fair value hierarchy, which are included in investments, at fair value, on the accompanying statements of net assets available for benefits.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INCOME TAX STATUS

The Plan has received a determination letter from the IRS dated October 19, 2021, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code (the "Code") of 1986, as amended. Although the Plan has been amended since receiving the determination letter, the Plan

sponsor believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

Accounting principles generally accepted in the United States require the Plan sponsor to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan sponsor has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan sponsor believes it is no longer subject to income tax examinations for years prior to 2021.

6. RELATED PARTY TRANSACTIONS

Certain Plan investments in registered investment companies are managed by the Trustee. These transactions qualify as exempt party-in-interest transactions.

The Plan paid fees of approximately \$3,886,000 and \$3,375,000 to the Trustee during the years ended December 31, 2024 and 2023, respectively, which is included in administrative expenses on the accompanying statements of changes in net assets available for benefits. The Company provides certain administrative services at no cost to the Plan.

7. SUBSEQUENT EVENTS

BSW Holdings and Baylor Scott & White Health Merger

Effective January 1, 2025, BSW Holdings merged into Baylor Scott & White Health (BSW Health), a Texas nonprofit corporation. The primary purpose of this organizational change is to streamline the BSWH corporate structure. Effective on the same date, the Plan was amended for BSW Health to become the new Plan sponsor.

The Plan has evaluated subsequent events through June 6, 2025, which is the date the financial statements were issued. The Plan is not aware of any events or transactions occurring subsequent to the statements of net assets available for benefits date, but before the issuance of the financial statements, which may have a material effect on its financial condition.
