## Independent Auditors' Report

To the Trustees  
Dynabrade, Inc.

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of the Dynabrade, Inc. Employee Stock Ownership Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). **1. Description of the Plan**

The following description of the Dynabrade, Inc. Employee Stock Ownership Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**– Dynabrade, Inc. (“Plan Administrator”) established the Dynabrade, Inc. Employee Stock Ownership Plan effective as of January 1, 2001. The Plan operates as an employee stock ownership plan (“ESOP”) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (“Code”) and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Board of Trustees is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance. The Plan was established to provide employees with the opportunity to accumulate capital ownership in the Plan Administrator.

To establish the ESOP, the Plan purchased Company stock using two separate funding sources, and holds the stock in a trust established under the Plan. The amounts borrowed to purchase Company stock were completely repaid by Company contributions and/or the Plan’s dividends and investment earnings and the Company stock held by the Plan has been fully allocated to eligible employees’ accounts in accordance with applicable regulations under the Code.

Effective December 31, 2017, the Plan document was most recently amended to provide a continuing employee ownership benefit to eligible employees. The Plan consists of three main components which include a discretionary cash contribution, subject to annual Company Board of Directors approval; reshuffling of Company stock held in the accounts of terminated vested Plan participants in exchange for cash held in the account of current active Plan participants; and rebalancing of all current active Plan participants’ accounts so that all current active Plan participants will have the same proportion of Company stock and other Plan investments in their accounts.

**Eligibility**– Employees of the Plan Administrator are generally eligible to participate in the Plan on January 1 or July 1 following their completion of one year of service during which they completed at least 1,000 hours of service and are age 21 or older. Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Plan Administrator contributions for such year.

**Funding Policy** – The Plan Administrator may make discretionary contributions of cash. The contributions are then allocated to the participant accounts based on eligible compensation. The contributions are typically equal to the value of 117 shares of voting common stock. The Plan Administrator made contributions of \$1,796,418 and \$1,634,022 for the years ended December 31, 2024 and 2023, respectively. Employee contributions are not permitted.

**Participant Accounts** – The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of cash. The cash contribution is then used to purchase stock from terminated vested Plan participants during reshuffling of Company Stock. After reshuffling is completed, participants' individual accounts are rebalanced in order to maintain that each active participant has the same proportion of company stock as to other cash investments. Only those participants who are eligible employees of the Plan Administrator as of the last day of the Plan year will receive an allocation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance. Dividends on the investment of Dynabrade, Inc. common stock are allocated to participant accounts based upon the number of shares held by the shareholders of record on the date the dividends are declared. Participant investments are non-participant directed.

**Vesting** – If a participant's employment with the Plan Administrator ends for any reason other than retirement, permanent disability or death, he or she will vest in the balance of his or her account balance based on total years of service with the Plan Administrator. Participants become 100% vested after three years of service.

**Put Option** – Under federal income tax regulations, the employer stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trade limitations, includes a put option. The put option is a right to demand that the Plan Administrator buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

**Payment of Benefits** – Benefits are payable upon termination of employment, death, permanent disability or retirement for participants who have attained their normal retirement date, early retirement date or disability retirement date, as defined by the Plan. Benefits are distributed in the year following termination of employment as a lump sum payment of the participant's entire vested account balance.

**1. Description of the Plan (continued)**

Under the provisions of the Plan, the Plan Administrator is obligated to repurchase participant shares which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations.

***Benefits Payable*** – Net assets available for benefits include \$5,786,004 and \$7,341,331, respectively, due to participants who have withdrawn from participation in the Plan as of December 31, 2024 and 2023.

***Diversification*** – Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Plan Administrator stock into investments which are more diversified.

Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may elect annually to diversify or receive a cash distribution of up to 25 percent of his or her account, less any balance previously diversified. If a participant is at least 60 years of age, they may elect to diversify or receive a cash distribution of up to 50 percent of his or her account. At age 61 and older, a participant may solely diversify 50 percent of his or her account.

***Forfeitures*** – Forfeited accounts shall be allocated in the same manner as employer contributions. There were forfeitures available in the amount of \$17,232 and \$26,843 available for reallocation to participant accounts for the years ended December 31, 2024 and 2023, respectively.

***Voting Rights*** – For certain Plan Administrator matters, including a corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all of the assets, or such other transactions prescribed by law, each participant is entitled to exercise voting rights attributable to the shares allocated to his or her accounts. For all other Plan Administrator matters, including the elections of directors, the Plan Trustees will determine in what manner the shares of stock held by the Plan will be voted.

***Tax Status*** – The Internal Revenue Service has determined, and informed the Plan Administrator by a letter dated November 1, 2013, that the Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Code and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

***Plan Termination*** – Although it has not expressed any intent to do so, the Plan Administrator reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon such termination of the Plan, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the Code. Upon termination of the Plan, the Company shall direct the Plan Trustees to pay all liabilities and expenses of the trust fund.

***Commitment*** – If the ESOP acquires shares sufficient to give the ESOP voting control, the ESOP will be obligated to offer to purchase the balance of stock from certain shareholders under the provisions of the Share Purchase Agreement.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting*** – The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

***Valuation of Investments and Income Recognition*** – The investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends and interest are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains and losses on shares bought and sold as well as held during the year.

***Payment of Benefits*** – Benefits are recorded when paid.

***Administrative Expenses*** – Plan expenses are paid by the Plan Administrator.

***Risks and Uncertainties*** – The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

***Use of Estimates*** – The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Accounting Changes** – Management periodically assesses the applicability of new accounting pronouncements and technical guidance and the effect, if any, on the Plan’s financial statements.

**Subsequent Events** – The Plan has evaluated subsequent events, for recognition or disclosure, through July 23, 2025, the date the accompanying financial statements were available to be issued, and determined that no additional recognition or disclosure was required.

**3. Information Certified by the Custodian (Unaudited)**

As permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan has elected to utilize the certifications of certain financial information by Principal Life Insurance Company.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security. There were no assets of the Plan that utilized Level 2 in puts as its primary basis for calculating fair value as of December 31, 2024 and 2023.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity’s own assumptions about the assumptions that market participants would use in pricing the asset or liability.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value:

*Pooled Separate Accounts:* Valued at the NAV of units held by the account. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities.

*Dynabrade, Inc. Voting Common Stock:* The fair value of the Plan Administrator’s common stock held by the Plan is valued at fair value based upon an independent appraisal using a combination of the market and income valuation techniques.

There have been no changes in the methodology used at December 31, 2024 and 2023.
