We have performed audits of the accompanying financial statements of G & B Oil Company, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). (1) Summary of Significant Accounting Policies

(a) Basis of Presentation

The accompanying financial statements of the G & B Oil Company, Inc. 401(k) Profit Sharing Plan (the "Plan") have been prepared in accordance with accounting principles generally accepted in the United States of America and present the net assets available for plan benefits and changes in those net assets on an accrual basis.

(b) Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for plan benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Fair Value Measurements

For determining fair value measurements, fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. Management follows an established framework for measuring fair value. That framework provides a fair value hierarchy, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The three levels of inputs that may be used to measure fair value are described below:

Level 1: quoted prices (unadjusted) in active markets for identical assets or liabilities

Level 2: inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly

Level 3: one or more significant inputs or significant value drivers that are unobservable or based on market assumptions

(d) Investment Valuation and Income Recognition

Investments in mutual funds managed by the Plan's custodian are valued on the last business day of the year based on the current market values (quoted prices) of the funds.

(d) Investment Valuation and Income Recognition, Continued

The Galliard Stable Return Fund Core (the “Fund”) was established under the Allspring Collective Investment Trust (the “Trust”) which is governed by the Allspring Collective Investment Trust Declaration of Trust (“Declaration of Trust”) as amended and restated, dated December 19, 2022. The Fund is a collective investment fund managed by Galliard Capital Management, LLC and trustee by SEI Trust Company for retirement plans qualified under Section 401(a) and tax-exempt under Section 501(a) of the Internal Revenue Code of 1986, as amended. As trustee, SEI Trust Company may make certain amendments to the Declaration of Trust as it deems appropriate. The Fund seeks to provide investors with a moderate level of stable income without principal volatility. There is no assurance that the Fund will achieve its objective. As of December 31, 2024 and 2023, the contract value of the investment in the Galliard Stable Return Fund was \$3,037,069 and \$3,551,319 respectively.

The Plan presents in the statements of changes in net assets available for plan benefits the net appreciation (depreciation) in the value of its investments which consists of realized gains or losses and the unrealized appreciation (depreciation) on investments held at year-end. Certain investment fees are charged to the individual funds in the Plan and are included in the net appreciation (depreciation) in the fair value of investments.

Market value events may limit the ability of the Fund to transact at contract value with the issuer. Market value events are events or conditions that occur which are outside of the normal operation of the Fund and lead to any Fund disbursements which have or will have a material adverse effect on the operations of the Fund and a financial effect on the investment contract or wrap issuer’s interest hereunder. In the normal course of business, such events or conditions would not limit the ability of the Fund to transact at contract value with the participants in the Fund. The Fund is managed to maintain a certain amount of liquidity to provide for the day-to-day liquidity needs of participants as well as the occasional market value event.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. There are no unfunded commitments as of December 31, 2024 and 2023.

(e) Notes Receivable From Participants

Notes receivable from participants are valued at unpaid principal balance plus any accrued but unpaid interest.

(f) Payment of Benefits

Benefits are recorded as expense when paid.

(2) Description of Plan

The following description of the Plan provides only general information. Participants in the Plan should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan became effective on January 1, 1989 as a profit sharing 401(k) salary deferred thrift plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). The Plan is sponsored by G & B Oil Company, Inc. (the "Company"). The Plan covered all full-time employees of the Company who had attained one year of service and age twenty-one. Effective September 1, 2012, the eligibility conditions of the Plan were amended to permit elective deferrals and matching contributions upon completion of 250 hours of service within the 90-day time period following the date of hire. The Plan was also amended to include an automatic deferral feature equal to 4% of compensation. The automatic deferral amount will increase each plan year by 1%, up to a maximum of 12%. On June 1, 2017, the Plan added a Roth option for participants who are eligible to receive a discretionary matching contribution.

(b) Contributions

Each year, participants can elect to defer a percentage of their compensation into the Plan, not to exceed a dollar limit set by law. The Company has elected to contribute 50% of participating employees' contributions, not to exceed 6% of the participant's salary, for a maximum employer match of 3% of a participant's salary. This election is made annually.

The Company can also elect on an annual basis to make a special discretionary contribution equal to a percentage of each participant's compensation. During 2024 and 2023, the Company did not elect to make a discretionary contribution.

Participants can deposit "rollovers" (distributions from other qualified plans) into the Plan.

(c) Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution, plan earnings, and administrative expenses and, at the discretion of the Plan administrator, forfeitures of terminated participants' nonvested accounts. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are 100% vested in their salary reduction and rollover contributions to the Plan. Vesting in the Company's matching and discretionary contribution portion of their accounts is based on their years of continuous service. Effective January 1, 2002, vesting for matching contributions begins in the second year of service and vests at the rate of 20% per year so that participants are 100% vested after six years of service.

(e) Investment Options

Participants are able to select from numerous mutual funds and a stable value investment fund in which their contributions are invested. Investment options are periodically changed based on the performance of the investments.

(f) Payment of Benefits

Generally, participants become eligible to receive benefits on their normal retirement age (65), death, disability, termination of employment, or reasons of proven financial hardship. Participants may receive 100% of their vested account balance in a variety of annuity options or a lump sum.

Effective February 1, 2013, the Plan was amended to allow post-severance or minimum distributions in excess of \$5,000 to be distributed as a lump sum, in installments, on an ad-hoc basis or through an alternative annuity.

(g) Notes Receivable from Participants

Participants can borrow from their fund accounts limited to the lesser of: 1) \$50,000, reduced by the excess, if any, of the highest outstanding balance of notes from the Plan during the one-year period prior to the date of the note over the current outstanding balance of loans; or 2) 50% of their vested account balance. Notes receivable are treated as transfers between the investment fund and the note fund. Generally, note terms range from 5 to 10 years. The notes are secured by the balance in the participant's account. Interest rates ranged between 4.25% to 9.50% on loans outstanding as of December 31, 2024. Principal and interest are typically paid ratably through payroll deductions. Interest income on notes receivable from participants totaled \$13,588 and \$8,754 during 2024 and 2023, respectively.

(h) Forfeited Accounts

As of December 31, 2024 and 2023, there were \$1 and \$137, respectively, of forfeited nonvested accounts. These forfeitures will be used to reduce the Plan's ordinary and necessary administrative expenses or matching contributions. In 2024 and 2023, Plan expenses were reduced by \$606 and \$238, respectively, from forfeited nonvested accounts. During 2024 and 2023, employer matching contributions were reduced by \$35,478 and \$15,302, respectively, from forfeited non-vested accounts.

(3) Administrative Expenses

Administrative expenses include primarily trustee, agency and loan fees. The Company paid for various other administrative expenses on behalf of the Plan for 2024 and 2023, which are not included in the statements of changes in net assets available for plan benefits.

(4) Federal Income Taxes

The Plan's custodian has received a letter dated June 30, 2020, in which the Internal Revenue Service ("IRS") stated that the form of the prototype plan which the Company has adopted is acceptable under the applicable requirements of the Internal Revenue Code (the "Code") for use by employers for the benefit of their employees. The Plan administrator believes the Plan is currently designed and is being operated in compliance with the applicable provisions of the Code.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. No provision for income taxes has been included in the Plan's financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

(5) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

(6) Investments and Fair Value Measurements
