## Independent Auditors' Report

### The Pension and 401(k) Committee of Clarins USA, Inc. 401(k) Plan

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Supplemental Schedule Required by ERISA***

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### 1. Plan Description

The following description of Clarins USA, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Summary Plan Description or the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan that provides a cash or deferred feature covering all eligible employees of Clarins USA, Inc. (the "Company" or "Employer"). The Plan is intended to satisfy the applicable sections of the Internal Revenue Code ("IRC"). An employee becomes eligible to make elective contributions upon attainment of age 21 and completion of 3 months of service. An employee becomes eligible to receive Employer safe harbor matching contributions upon attainment of age 21 and completion of 3 months of service and enrollment in the Plan. Prior to May 15, 2020, the date the Plan was amended, an employee became eligible for all contributions upon attainment of age 21 and completion of 1,000 hours of service within a 12-month period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

#### **Contributions**

Each year, participants may contribute, on a pre-tax and Roth basis, from 1% to 100% of their eligible compensation, up to a maximum dollar amount in accordance with Section 402(g) and Section 415(c) of the IRC. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. The Plan currently offers various registered investment companies and collective trusts as investment options for participant contributions. Participant contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings.

The Company has a safe harbor matching contribution feature. The Company makes matching contributions equal to 100% of a participant's elective deferrals that do not exceed 4% of the participant's Plan eligible compensation plus 50% of a participant's elective deferrals that exceed 4% but do not exceed 6% of the participant's Plan eligible compensation.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer's contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Effective January 1, 2015, participants are immediately vested in their voluntary pre-tax contributions and Employer safe harbor matching contributions plus actual earnings thereon. Prior to January 1, 2015, participants were fully vested in their voluntary pre-tax contributions plus actual earnings thereon.

Prior to January 1, 2015, participants vested in their Employer matching contributions as follows:

#### *Forfeitures*

If a participant terminates their employment with the Company, the non-vested contribution plus allocated earnings thereon may be used to reduce future Employer contributions. Any remaining forfeitures not used to reduce Employer contributions may be used to reduce administrative expenses of the Plan. At December 31, 2024 and 2023, forfeited account balances held in non-participant directed accounts totaled \$4,873 and \$12,407. During 2024, \$7,899 of forfeitures were used to reduce Employer contributions and no forfeitures were used to reduce administrative expenses.

#### *Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum amount of \$1,000 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the participant's vested account balance and bear interest at a rate commensurate with local prevailing rates as determined by the plan administrator. Loan repayments must be made through payroll deductions over a term not to exceed 5 years unless the proceeds of the loan are used to purchase the participant's principal residence, in which case the plan administrator may permit a longer repayment period. Principal and interest is paid ratably through periodic payroll deductions.

#### *Plan Credit Account*

The Plan and Bank of America, N.A. have entered into a service based pricing arrangement whereby a portion of the revenue earned by the trustee is passed through to the Plan for payment of permitted Plan expenses. The Plan Credit Account is an account within the Plan. The Plan Credit Account balance was \$433 and \$158 at December 31, 2024 and 2023. During 2024, \$3,495 from the Plan Credit Account was used to reduce administrative expenses.

#### *Plan Assets*

Upon enrolling in the Plan, a participant may direct their contributions in any of the Plan's investment options.

#### ***Plan Assets (continued)***

Participants may transfer past investments and change the allocation of investments on future contributions among investment options at any time during participation. Transfers or changes become effective on the first business day following the date of transfer or change.

#### ***Withdrawals and Benefit Payments***

Upon termination of service due to death, disability, retirement or other reason, a participant is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. Under the terms of the Plan, a participant may make a withdrawal for reasons of economic hardship prior to attaining age 59½. Such hardship withdrawals are available for immediate and heavy financial need and only when other financial resources are exhausted. Upon attaining age 59½, participants may withdraw their entire vested account balance or a portion thereof, no more frequently than once every six months. Upon termination of employment prior to retirement, Plan participants with account balances greater than \$5,000, may elect to defer distributions to normal retirement age. Participants with account balances less than \$5,000 will receive a lump sum cash payment as soon as practicable following termination of employment.

#### ***Expenses***

As provided in the Plan document, administrative expenses are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments. The remaining expenses of maintaining the Plan are paid by the Company and excluded from these financial statements.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting and Use of Estimates***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Fair Value Measurements***

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

### 2. Summary of Significant Accounting Policies (*continued*)

#### ***Investment Valuation and Income Recognition***

The Plan's investments are stated at fair value. The mutual funds and money market fund held by the Plan are valued at fair value based on the daily closing price as reported by the funds. These funds are open-ended and are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price and are deemed actively traded. The common/collective trust is valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. A deemed distribution will only be recorded when a distributable event occurs; otherwise the loan will continue to accrue interest.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Subsequent Events Evaluation by Management***

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is July 29, 2025.

### 3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and the net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Bank of America, N.A., a qualified institution.

### 5. Common/Collective Trust

The Morley Stable Value Fund (the "MSV Fund") is an investment fund that is designed for retirement trusts that are exempt from federal income tax under the IRC. Principal Global Investors Trust Company is the trustee of the MSV Fund and Morley Capital Management, Inc. is the investment advisor of the MSV Fund. The objective of the MSV Fund is to provide preservation of capital, relatively stable returns consistent with its competitively low risk profile and liquidity for benefit responsive payments.

The MSV Fund seeks to achieve this objective by investing primarily in a variety of high quality stable value investment contracts (the performance of which may be predicated on underlying fixed income securities), as well as cash and cash equivalents.

The NAV of the MSV Fund is determined each business day. Contributions to the MSV Fund may be made daily at the current NAV. Withdrawals from the MSV Fund for benefit payments and participant transfers to noncompeting options may be made within 30 days after written notification has been received and are considered as made immediately after the next valuation date subsequent to the trustee's approval.

### 5. Common/Collective Trust (*continued*)

Market value events may limit the ability of the MSV Fund to transact at NAV with the issuer. Such events may include but are not limited to: MSV Fund administration amendments or changes, merger or consolidation of investors, group terminations or layoffs, implementation of an early retirement program, termination or partial termination of the MSV Fund, failure to meet certain tax qualifications, participant communication that is designed to influence participants not to invest in the MSV Fund, transfers to competing options without meeting the equity wash provisions of the MSV Fund, and plan sponsor withdrawals without the appropriate notice to the MSV Fund and /or issuer.

In the normal course of business, such events or conditions would not limit the ability of the MSV Fund to transact at NAV with the participants. The MSV Fund is managed to maintain a certain amount of liquidity to provide for the day to day liquidity needs of participants as well as the occasional market value event. The MSV Fund has no unfunded commitments.

### 6. Tax Status

The Internal Revenue Service (“IRS”) issued an opinion letter to the prototype plan document preparer dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

### 7. Party-in-Interest Transactions

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

### 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Employer contributions.

### 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
