## Independent Auditors' Report

To the Trustees of the  
Dynabrade, Inc. Profit Sharing/401(k) Savings and Retirement Plan

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the accompanying financial statements of Dynabrade, Inc. Profit Sharing/401(k) Savings and Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

**1. Description of the Plan**

The following description of the Dynabrade, Inc. Profit Sharing/401(k) Savings and Retirement Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

**General**– The Plan is a defined contribution profit sharing plan with a 401(k) feature covering substantially all employees of Dynabrade, Inc. (the “Plan Administrator”). An employee must complete ninety days of service and be of age 21 years or older to become a participant in the Plan and begin making elective deferrals. When eligible, employees are automatically enrolled with a 6% pre-tax deferral amount.

The Plan was established effective July 1, 1983 and restated to comply with statutory regulations effective November 1, 2021, to include Manth Mfg, Inc., a subsidiary of the Company, as an adopting employer. The plan was amended again effective May 1, 2023, to include Global Abrasives, Inc., a subsidiary of the Company, as an adopting employer. The Board of Trustees is responsible for oversight of the Plan, determining the appropriateness of the Plan’s investment offerings and monitoring investment performance.

**Contributions**– Participants may elect to contribute up to 100% of their eligible compensation on an after-tax basis, or if elected by the participant, on a pre-tax basis, limited by the amount imposed by law. Participants who are fifty years and older are eligible to make catch-up contributions. Participants may also make rollover contributions from other qualified plans.

The Plan Administrator also can make discretionary contributions based on the discretion of the Plan Administrator’s Board of Directors. To be eligible for discretionary contributions, participants must have completed at least twelve months of service and are age 21 or older. For the years ended December 31, 2024 and 2023, the Plan Administrator did not make discretionary contributions.

The Plan Administrator has amended the plan effective May 1, 2023 in order to provide for matching contributions for Global Abrasives, Inc. employees. The Plan Administrator contributes a matching contribution of 100% of the employee contribution, up to 4% of their compensation.

Participants direct the investment of contributions into various investment options offered by the Plan.

**1. Description of the Plan (continued)**

***Participant Accounts*** – Individual accounts are maintained for each Plan participant. Participant accounts are increased by participant contributions, Plan Administrator contributions, and the participant’s share of Plan earnings. Participant accounts are decreased by participant distributions, the participant’s share of Plan losses, and certain administrative expenses. The allocation of earnings and losses to participant accounts is based on the value of an individual account in relation to the total assets of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

***Vesting*** – Participants are immediately vested in their contributions and the actual earnings thereon. Participants vest in Plan Administrator discretionary contributions, matching contributions and actual earnings thereon at the rate of 20% per year after two years of service and become fully vested after six years of service, as defined in the Plan document.

***Notes Receivable from Participants*** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$49,999 or 50% of their vested account balance. Note terms range from 1 to 5 years and are secured by the balance in the participants account, bearing interest at the prime rate of interest prevailing as of the date of the loan. Principal and interest are repaid weekly through payroll deductions.

***Payment of Benefits*** – Upon termination of service due to retirement, death, disability, upon reaching age 55, or upon reaching age 59 ½ while employed with the Plan Sponsor, a participant may elect to receive an annuity or a lump-sum distribution in an amount equal to the vested value of their account. Hardship withdrawals, as defined by the Internal Revenue Code (the “Code”), are available to participants from all or part of the vested portion of their individual account, subject to the provisions specified in the Plan agreement.

***Forfeitures*** – Forfeitures arising under the Plan may first be used to pay administrative expenses of the Plan which would otherwise be paid by the Plan Administrator and then used to reduce the Plan Administrator’s discretionary contribution. There were forfeitures available in the amount of \$46 and \$1,016 as of December 31, 2024 and 2023, respectively.

***Plan Termination*** – Although it has not expressed intent to do so, the Plan Administrator has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

***Tax Status*** – The Plan Administrator obtained a letter dated June 30, 2020, in which the Internal Revenue Service (“IRS”) stated that the pre-approved plan document, sponsored by Principal Life Insurance Co., satisfies the applicable provisions of the Code. Although the

Plan has been amended since the pre-approved plan received the determination letter, the Plan Administrator and the Plan's tax counsel believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt. Accordingly, no tax provision for income taxes has been included in the accompanying financial statements.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting*** – The financial statements of the Plan are prepared on the accrual basis of accounting.

***Investment Valuation and Income Recognition*** – The Plan's investments are stated at fair value and are administered by the Plan's Custodian. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income and dividends are recorded on accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Payment of Benefits*** – Benefits are recorded when paid.

***Administrative Expenses*** – Certain expenses of maintaining the Plan are paid directly by the Plan Administrator and are excluded from these financial statements. Fees related to the administration requests for distributions and loans are charged directly to the participant's account. Investment-related expenses are included in the net appreciation/(depreciation) in fair value of the investments.

***Risks and Uncertainties*** – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

***Use of Estimates*** – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

***Party-In-Interest Transactions*** – Certain Plan investments are managed by Principal Life Insurance Company. Principal Life Insurance Company is the custodian and the recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

***Accounting Changes*** – Management periodically assesses the applicability of new accounting pronouncements and technical guidance and the effect, if any, on the Plan’s financial statements.

***Subsequent Events*** – The Plan has evaluated subsequent events, for recognition or disclosure, through July 23, 2025, the date the accompanying financial statements were available to be issued, and determined that no additional recognition or disclosure was required.

**3. Information Certified by the Custodian (Unaudited)**

As permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan has elected to utilize the certifications of certain financial information by Principal Life Insurance Company.

**4. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- **Level 1** – Unadjusted quoted prices in active markets for identical, unrestricted assets or liabilities that are accessible at the measurement date.
- **Level 2** – Quoted prices for similar assets or liabilities in active markets or quoted prices for identical or similar assets or liabilities in markets that are not active. This level also includes inputs other than quoted prices that are observable, either directly or indirectly, for substantially the full term through corroboration with observable, independent market data. This includes investments valued at quoted prices adjusted for legal or contractual restrictions specific to the security. There were no assets of the Plan that utilized Level 2 inputs as its primary basis for calculating fair value as of December 31, 2024 and 2023.
- **Level 3** – Pricing inputs are unobservable for the asset or liability. That is, inputs that reflect the reporting entity's own assumptions about the assumptions that market participants would use in pricing the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

*Pooled Separate Accounts:* Valued at the NAV of units held by the account. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liabilities.

*Common and Collective Investment Trusts:* Valued at the NAV of units of a common and collective investment trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily.

*Guaranteed Interest Accounts:* The guaranteed interest accounts are not fully benefit-responsive and are accordingly valued at fair value which represents contract value adjusted to reflect current market interest rates only to the extent such market rates exceed crediting rates.

Were the Plan to initiate a full redemption of the common and collective investment trusts, the investment adviser reserves the right to temporarily delay withdrawal from the trust for 6 months.

The preceding methods described may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
