### Note 1: Description of Plan

The following description of the Winona Foods, Inc. Savings & Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all eligible full-time employees of Winona Foods, Inc. (the "Company"). Employees are eligible to participate in the Plan upon attaining age 18 and following the completion of at least one hour of service during the first two months of employment or the completion of a year of service, if earlier, with entry dates on the first day of each month following meeting eligibility requirements. Seasonal and temporary employees must complete a year of service or effect January 1, 2024, complete three consecutive years of service where the employee completes at least 500 hours of service to become eligible to participate in the Plan. A year of service is defined as completing 1,000 hours of service during an eligibility computation period. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan, on a pre-tax or Roth basis, not to exceed the maximum allowable limits by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan after 60 days of service unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. Each year, automatically enrolled participants will have their deferral percentage increased by 1%, subject to a maximum rate of 15% of compensation, unless a different election is made by the participant.

The Company contributes a safe harbor matching contribution equal to 100% of the first 4% and 50% of the next 2% of compensation that a participant contributes to the Plan. Participants must have completed one hour of service during the first six months of employment or one year of service to be eligible to receive the Company's safe harbor matching contributions and are eligible to begin receiving Company matching contributions on the first day of the month following meeting service requirements. Rollover contributions are not matched. The Company also has the option to make additional discretionary contributions to the Plan. Participants must be employed on the last day of the plan year and have completed at least 1,000 hours of service during the plan year to be eligible to receive the Company's discretionary contribution. There were no discretionary contributions to the Plan during 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Company safe harbor matching contributions, and allocations of (a) the Company's discretionary contributions and (b) plan earnings or losses. Participant accounts are charged an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are vested immediately in their voluntary contributions and Company safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants vest at a rate of 20% per year, beginning with the second year of service. Participants become fully vested after six years of service, or upon death or disability.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 5.25% to 10.50%, which are commensurate with local prevailing rates as determined quarterly by the plan administrator. Traditionally, note terms range from one to five years, but may extend up to 15 years for the purchase of a primary residence. Participants may only have one note outstanding at any given time. Principal and interest are paid ratably through payroll deductions.

#### Payment of Benefits

On termination of service due to death, disability, retirement (age 65), or termination of employment, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The Plan also allows installment or partial payments. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2. Participants may withdraw their rollover contributions at any time.

#### Forfeitures

At December 31, 2024 and 2023, there were no forfeited nonvested accounts. Forfeiture balances are to be used at the discretion of the Company, in accordance with the Plan document, to reduce future Company contributions or to pay administrative expense of the Plan. During 2024, there were no amounts used from forfeited nonvested accounts to reduce Company contributions or to pay plan expenses.

#### **SECURE 2.0 Act**

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Principle areas of the act addressed participant saving assistance, required minimum distributions (RMD), catch-up contributions, and lost participants. There are provisions which are currently part of the plan design, including the provisions designed to assist with participant savings, automatic enrollment and automatic increases, and the RMD provisions required for 2023 which have already been adopted by the Plan. The catch-up contribution provisions that include an increased catch-up limit for participants aged 60-63 and limiting all catch-up contributions to ROTH for participants earning over \$145,000 in the prior year, are currently being evaluated and implemented in accordance with future guidance. All provisions of SECURE 2.0 will be evaluated and implemented in accordance with future regulations and guidance and the Plan will be amended as needed.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

#### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### **Notes Receivable From Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses and Investment Management Fees

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company, which include certain administrative expenses, are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment management fees paid directly by the Plan are allocated proportionately to plan participants based on their respective account balances and are included in net investment income in the accompanying statement of changes in net assets available for benefits. Certain fees incurred by the Plan for investment management services are allocated proportionately to plan participants based on their respective account balances and are included in net appreciation in fair value of investments, as they are paid through revenue sharing rather than direct payment. All other expenses paid directly by the Plan are allocated proportionately to plan participants based on their respective balances and are included in administrative expenses.

#### Subsequent Events

The Plan has evaluated subsequent events through July 24, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level; Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1); and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Money market fund:* Valued at \$1 per share.

### **Note 5: Party-in-Interest Transactions**

Alerus is the Plan trustee as of December 31, 2024, as defined by the plan document and, therefore, transactions with Alerus qualify as party-in-interest transactions. Fees incurred and paid directly by the Plan to Alerus for administrative expenses were \$8,943 for the year ended December 31, 2024. Nicolet National bank is the investment advisor of the plan and, therefore, qualifies as a party-in-interest. Fees incurred and paid directly by the Plan to Nicolet National Bank for investment management services were \$45,460 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

### **Note 6: Tax Status**

The Plan adopted a non-standardized pre-approved plan document sponsored by Alerus. Alerus received an IRS notification letter dated June 30, 2020, which states the non-standardized pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the notification letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 7: Plan Termination**

The Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company discretionary contributions.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
