Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hellmuth & Johnson, PLLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). NOTE 1 DESCRIPTION OF PLAN

The following description of Hellmuth & Johnson, PLLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established January 1, 2000, and has been amended and restated throughout the years to comply with tax legislation. The Plan was last restated effective February 1, 2021 as part of the Cyle 3 remedial amendment period and last amended effective January 1, 2024. The Plan covers all employees of Hellmuth & Johnson, PLLC (the Employer) who have completed one month of service and have attained age 18. The Plan excludes leased employees, nonresident aliens with no U.S. source income, and employees covered by a collective bargaining agreement. The Plan also excludes employees regularly scheduled to work less than 999 hours of service during the participation computation period, except, however, such employee shall cease being excluded upon the completion of one year of service. The Plan is subject to ERISA. The Plan administrator is responsible for the oversight of the Plan and along with the external investment advisor determines the appropriateness of the Plan's investment offerings and monitors investment performance and reports to the Board of Governors.

Contributions

The Plan includes a salary deferral arrangement allowed under Section 401(k) of the Internal Revenue Code (IRC). Eligible participants are permitted to elect to have a percentage, limited by Plan provisions, of their compensation contributed as pre-tax 401(k) or after-tax Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

The Employer will make a safe harbor matching contribution. For the year ended December 31, 2024, the Employer safe harbor matching contribution was equal to 100% of participant elective deferrals not exceeding 3% of eligible compensation plus 50% of participant elective deferrals in excess of 3% but not in excess of 5% of eligible compensation. Annually, the Employer may, at its discretion, authorize to make a profit sharing contribution to the Plan, as determined by the Board of Governors. For the year ended December 31, 2024, there was no profit sharing contribution authorized.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's deferral contributions, the Employer's safe harbor matching and profit sharing contributions and an allocation of Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined. Profit sharing contributions are allocated using a cross tested formula. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their deferral contributions and Employer safe harbor matching contributions, plus actual earnings thereon. Vesting in the Employer matching and Employer profit sharing portions of their accounts, plus actual earnings thereon, is based on periods of credited service using a graded vesting schedule. A participant is 100% vested after the completion of six years of credited service. Notwithstanding the above, a participant is fully vested upon reaching early retirement age (55 and six credited periods of service), death, or permanent disability.

Forfeitures

Forfeited nonvested accounts may be used to pay administrative expenses, used to reduce future Employer contributions or reallocated as an additional discretionary matching or nonelective contribution. Forfeited nonvested accounts as of December 31, 2024 and 2023 totaled \$718 and \$606, respectively. Forfeitures of \$972 were used to pay administrative expenses for the year ended December 31, 2024. Forfeitures of \$25,426 were used to reduce Employer contributions for the year ended December 31, 2024.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at prime rate plus 1%. Principal and interest is paid ratably through payroll deductions.

Benefit Payments

Upon termination of service, death, disability, or retirement, a participant may receive the value of the vested interest in their account in the form of a lump-sum distribution. The Plan allows for in-service distributions upon attainment of age 59 ½ and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account is not greater than \$5,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$0.01 and \$5,000, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name. Effective in 2024, the threshold was increased from \$5,000 to \$7,000 due to the SECURE 2.0 Act.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Investment income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make note repayments and the Plan administrator deems the participant note to be in default, the participant note balance is reduced and a benefit payment is recorded when there is a distributable event.

Benefit Payments

Benefit payments are recorded when paid.

Administrative Expenses

The Plan's expenses are paid either by the Plan or the Employer, as provided by the Plan document. Expenses paid directly by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account. Fees related to the administration of the Plan, recordkeeping and investment advisory fees are offset with revenue sharing credits and allocated to participant accounts. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through July 24, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

Ascensus Trust Company is the trustee of the Plan and is an affiliate of Ascensus, LLC (Ascensus). Ascensus, as agent for Ascensus Trust Company and Newport Trust Company, LLC, has supplied the Plan administrator with a certification as to the completeness and accuracy of all investment and notes receivable information presented in the accompanying statement of net assets available for benefits as of December 31, 2024, the statement of changes in net assets available for benefits for the period of April 18, 2024 to December 31, 2024, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Newport Trust Company, LLC, the custodian of the Plan, has supplied the Plan administrator with a certification as to the completeness and accuracy of the investment and notes receivable information presented in the accompanying statement of net assets available for benefits as of December 31, 2023 and the statement of changes in net assets available for benefit for the period of January 1, 2024 to April 17, 2024.

NOTE 4 FAIR VALUE OF INVESTMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

NOTE 4 FAIR VALUE OF INVESTMENTS (CONTINUED)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund: Valued at the NAV of shares held by the Plan at year-end.

NOTE 5 RISKS AND UNCERTAINTIES

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants will become 100% vested in their Employer accounts.

NOTE 7 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the IRS on the pre-approved plan indicating that the pre-approved plan is qualified under Section 401 of the IRC and is, therefore, not subject to tax under current income tax law. The pre-approved plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

Through April 17, 2024, the Plan investments were held by Newport Trust Company, the custodian of the Plan. Effective April 18, 2024, the Plan investments are held by Ascensus Trust Company, the trustee of the Plan. Transactions with these parties qualify as party-in-interest transactions.
