### Report on the Audit of the Financial Statements

#### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Tapestry Solutions, Inc., Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Tapestry Solutions, Inc., Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

#### **Opinion**

### Note 1 – Description of the Plan

The following description of the Tapestry Solutions, Inc. Retirement Plan (the Plan), provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

**General** – The Plan is a non-standardized defined contribution 401(k) profit-sharing plan, covering all eligible employees of Tapestry Solutions, Inc. (the Company), or of any affiliate of the Company who has adopted the Plan. An employee who is not part of an excluded class is eligible to participate in the Plan the first of the month following the date they attain age 18 and complete at least one hour of service within the 30-day period following the employee's employment commencement date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Administration** – Charles Schwab Trust Bank (Schwab) is the trustee of the Plan.

**Contributions** – Contributions to the Plan are in the form of salary reductions which participants have elected to defer in lieu of current compensation. Participants may elect to contribute, subject to statutory limitations, up to 100% of their eligible compensation. Participants age 50 or older are allowed to make catch-up contributions. Participants may elect to change contribution percentages and the allocations of their contributions to the funds to be effective as soon as administratively feasible after the request is received. The Plan allows participants to contribute to the Plan from pre-tax and after-tax compensation. The Plan also accepts certain rollover contributions from other tax-qualified retirement plans. Unless the participant makes a contrary election, each participant is automatically enrolled in the Plan with an automatic deferral rate of 3% of eligible compensation each payroll period. The automatic deferral rate increases 1% each year up to a maximum of 10% unless the participant makes an alternate election.

Each year the Company may make matching contributions up to 3% of an employee's annual eligible compensation for participants who make a salary reduction election. To receive matching contributions, the participant must be an eligible employee on the last day of the allocation period. The Company made matching contributions to the Plan in 2024.

**Participant accounts** – Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions, any Company contributions, allocations of plan earnings (losses) from the funds in which the account is invested and charged with an allocation of certain administrative and investment-related expenses, and participant-specific charges, if applicable. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** – Participants are fully vested in their rollover and elective contributions, and earnings thereon. Participants vest 50% in Company contributions and earnings thereon after one year of service and are 100% vested after two years of service. Full vesting in Company contributions and earnings thereon also occurs upon attainment of normal retirement age, death, or disability. Generally, a participant must work at least 1,000 hours during a plan year to earn a year of service for vesting purposes.

**Forfeitures** – Forfeitures are the non-vested portion of a participant’s account that is lost upon termination of employment. Forfeitures are retained in the Plan and may be used to pay administrative expenses or reduce future Company contributions. At December 31, 2024 and 2023, forfeited amounts held under the Plan totaled \$23,687 and \$5,983, respectively. In 2024, \$9,851 of forfeitures were used to reduce employer contributions.

**Withdrawals** – Participants may elect to withdraw all or a portion of their contributions, vested employer matching and non-elective contributions, at any time on or after the day they attain age 59½. If a participant is under age 59½, withdrawals from pre-tax contribution accounts, Roth contribution accounts, employer match contribution accounts and employer non-elective contribution accounts are subject to certain hardship rules as provided by the Plan. Certain assets that were merged into the Plan may be withdrawn upon attaining age 62. Withdrawals of after-tax contributions and rollover contributions can be made at any time.

**Notes receivable from participants** – Participants may borrow a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their total vested account balance at the time of the loan issuance. A participant may only have one loan outstanding at any time. The interest rate on new loans is equal to two percentage points above the prime interest rate as published at the time of the loan issuance in the Money section of USA Today. The interest rates on outstanding loans ranged from 5.25% to 10.50% at December 31, 2024, with loans maturing at various dates through May 2042.

**Benefit payments** – Upon termination of service, participants may elect to receive their vested account balance as a lump sum payment or roll it over to another qualified retirement plan or an individual retirement account. Certain assets that were merged into the Plan are distributed in the form of monthly annuity payments unless an alternative payment method is elected by the participant. Upon a participant’s death or retirement due to total and permanent disability, a participant’s account balance becomes fully vested and non-forfeitable and will be distributed in a lump sum as soon as administratively feasible.

### **Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting** – The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP), using the accrual method of accounting.

**Use of estimates** – The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and uncertainties** – The Plan’s investments are exposed to various risks such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the financial statements.

**Valuation of investments and income recognition** – The Plan’s investments are stated at fair value, except for the group annuity contract, which is stated at contract value. Fair value of the financial instrument is the price that would be received to sell an asset or paid to transfer a liability (an “exit price”) in an orderly transaction between market participants at the measurement date. The Plan’s investments are valued as follows:

*Mutual funds* – The Plan’s investments in mutual funds, which are registered investment companies, are valued at the net asset value (NAV) of shares held by the Plan at year end as quoted in an active market.

*Group annuity contract* – In 2017, the Plan entered into a fully benefit-responsive investment contract (FBRIC) with Standard Insurance Company (Standard). The contract meets the FBRIC criteria and therefore is reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The Plan’s ability to receive amounts due is dependent on Standard’s ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

The Standard Stable Asset Fund (SAF) is the Plan investment option available through the Plan’s group annuity contract with Standard. Standard maintains the contributions in a general account. The SAF is valued daily and is the sum of Plan contributions, transfers into the SAF from other Plan investment options, and daily interest credited to the SAF, less SAF expenses, transfers out of the SAF to other Plan investments and distributions from the SAF. The crediting interest rate for the SAF is determined quarterly but may not be less than the annual minimum guaranteed interest rate of 1%.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan Documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan’s prohibition on competing investment options, or (3) Plan sponsor events (for example, divestitures or spin-offs of a subsidiary, layoffs, retirement incentive programs) that cause a significant withdrawal from the Plan. No events are probable of occurring that might limit the Plan’s ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis of accounting. Net appreciation or depreciation in fair value of investments consists of gains and losses on investments bought and sold as well as held during the year.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost which represents unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis.

**Payment of benefits** – Benefits are recorded when paid.

**Expenses** – Necessary and proper expenses of the Plan are paid from the Plan's assets, except for those expenses the Company is required by law or chooses to pay.

**Subsequent events** – The Plan has evaluated subsequent events through July 16, 2025, the date the financial statements were available to be issued.

### **Note 3 – Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements* (ASC 820), established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 for financial assets and financial liabilities are described below:

**Level 1** – Values are based on unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities. An active market is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide pricing information on an ongoing basis.

**Level 2** – Values are based on (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in non-active markets; or (c) valuation models whose inputs are observable, directly or indirectly, for substantially the full term of the asset or liability.

**Level 3** – Values are based on prices or valuation techniques that require inputs that are both unobservable and significant to the overall fair value measurement.

The methods used by the Plan may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan has been amended since the date of the opinion letter; however, the Plan Administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6 – Plan Termination**

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of termination of the Plan, participants will become 100% vested in their accounts.

#### **Note 7 – Party-in-Interest Transactions**

The Plan invests in a mutual fund managed by an affiliate of Schwab. Therefore, these transactions qualify as exempt party-in-interest transactions.
