Independent Auditors' Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Love's and Affiliated Companies 401(k) Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. generally accepted accounting principles, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

1. Description of Plan

The following description of Love's and Affiliated Companies 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the plan document and the summary plan description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees who are at least age 21 of Love's Travel Stops & Country Stores, Inc. and related affiliates and adopting employers as defined in the plan document (the Company). Employees are eligible to participate the first day of the quarter coinciding with or following completion of three months of service, as defined by the Plan. The Plan is designed to provide for a deferred compensation arrangement of the type described in Section 401(k) of the Internal Revenue Code (IRC). The purpose of the Plan is to provide retirement benefits and permit employees to systematically save a portion of their compensation and defer income taxes on that portion. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Participants may contribute from 1% to 75% of their compensation, as defined in the Plan, and participants who have attained the age of 50 are allowed to make catch-up contributions in accordance with and subject to the IRC. Participants may also roll over amounts representing distributions from other qualified defined benefit or defined contribution plans. The Company matched 100% of the first 5% of compensation contributed by each participant during 2024. The Company may also make additional employer matching and profit-sharing contributions at its discretion, however no such additional contributions were made in 2024. All contributions are subject to certain limitations of the IRC.

Participants direct their elective contributions into various investment options offered by the Plan and can change their investment options on a daily basis. The Company's contributions are allocated in the same manner as that of the participants' elective contributions.

1. Description of Plan (continued)

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions, if any, and allocations of plan earnings. Allocations of plan earnings are based on the net earnings or losses of each participant's respective share of elected investment options or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their contributions, in the Company's matching contributions, and in the Company's discretionary contributions, adjusted for actual earnings or losses thereon.

Participant Loans

Participants may borrow from their fund accounts a minimum of \$1,000, up to a maximum of the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of prime plus 1% at inception of the loan. Principal and interest are paid ratably through payroll deductions. Loan terms range up to five years or, in the case of the purchase of a primary residence, up to ten years. If a participant terminates employment with the Company, the remaining loan balance is due immediately. If the loan is not repaid, it will automatically be treated as a distribution to the participant.

Payment of Benefits

Participants may elect a lump-sum or partial withdrawal of their account balance upon termination, death, retirement or disability. Participants may request a hardship withdrawal from their accounts to meet immediate and heavy financial needs, as defined by the Plan.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Expenses that are paid by the Company are excluded from the financial statements. Investment related expenses are included in net investment income. Participant accounts are charged with an allocation of administrative expenses paid by the Plan.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in conformity with U.S. generally accepted accounting principles.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of Benefits

Benefits paid to participants are recorded when paid.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

3. Investments

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, all investment information disclosed in the accompanying financial statements and supplemental schedule, including non-interest bearing cash, investments held at fair value and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by the Matrix Trust Company, the trustee of the Plan.

4. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1), and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.

Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets and liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in markets that are not active
- Observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumptions about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based the lowest level of input that is significant to the fair value measurement in its entirety.

4. Fair Value Measurements (continued)

Following is a description of the valuation techniques and inputs used for each general type of investment measured at fair value by the Plan:

Mutual funds – Mutual funds that are publicly traded are valued using published market prices at year end. Mutual funds that are not publicly traded are valued at the daily closing price as reported by the fund. These funds publish their daily Net Asset Value (NAV) and transact at that price. All mutual funds held by the plan are all deemed to be actively traded.

5. Income Tax Status

The Plan sponsor adopted an updated pre-approved plan effective November 1, 2021. The IRS informed the pre-approved plan provider in an opinion letter dated June 30, 2020, that the form of the plan is acceptable under the requirements of the IRC. An employer may rely on a favorable opinion letter issued to a prototype plan sponsor (or preapproved plan provider) as evidence that the plan is qualified under Code Section 401(a) as provided in Revenue Procedure 2017-41. The Plan administrator believes the Plan is designed and being operated in compliance with applicable requirements of the IRC so the Plan is qualified and the related trust is tax-exempt.

5. Income Tax Status (continued)

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS or DOL. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Related Party and Party-in-Interest Transactions

A party-in-interest is defined by ERISA; included in this definition are fiduciaries and employees of the Plan. The Investment Committee and Milliman, Inc. are parties-in-interest. Plan investments are managed by the Investment Committee which is made up of members of management. Milliman, Inc. provides recordkeeping and administrative services to the Plan, for which certain administrative fees are paid by the Plan. Certain plan transactions with parties-in-interest are prohibited under ERISA. The aforementioned transactions/activities are exempt from the prohibited transaction rules of ERISA.

7. Subsequent Events

Management has reviewed subsequent events through July 28, 2025, the date the financial statements were available to be issued.
