INDEPENDENT AUDITOR'S REPORT

To the Participants and Plan Administrator of the BlueRock Therapeutics US Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

1. Description of Plan

The following description of the BlueRock Therapeutics US Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan was established January 1, 2019, and was most recently amended and restated effective June 1, 2023. The Plan is a defined contribution Plan covering all employees, excluding residents of Puerto Rico and leased employees, of BlueRock Therapeutics LP (the “Company”, “Plan Sponsor” or “Employer”) on the first day of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. Fidelity Management Trust Company is the trustee of the Plan.

Contributions

Each year, participants may contribute up to 100 percent of their pre-tax annual compensation, as defined by the Plan and subject to limitations imposed by the Internal Revenue Code (“IRC”). Participants may designate contributions as Roth contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

At its discretion, the Company may make matching contributions to participants. For the year ended December 31, 2024, the Company approved a uniform percentage of participants' eligible compensation. Employer discretionary matching contributions were equal to 50 percent of the first 5 percent of participant elective deferrals, up to 2.5 percent of eligible compensation for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (“IRS”) limits. Participants direct their deferral contributions and Company contributions into various investment options offered by the Plan.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, discretionary matching contributions, if any, and Plan earnings. Participant accounts are charged with an allocation of certain administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100 percent vested immediately in their contributions, including their elective salary deferral contributions, rollover contributions, and discretionary employer matching contributions plus actual earnings thereon.

Forfeited Amounts

Forfeitures may arise from the results of compliance testing. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8 and \$17 respectively. Forfeitures may be applied to payment of administrative expenses and/or to reduce employer matching contributions. During the year ended December 31, 2024, \$2,904 of forfeitures were used to pay administrative expenses of the Plan.

Payment of Benefits

Upon termination of service, death, or retirement, a participant or their beneficiary will receive, in a lump-sum payment, an amount equal to the value of the participant's vested interest in his or her account. Participants may also elect partial withdrawals. If a distribution is not requested, the Plan will distribute balances of less than \$1,000 in lump-sum distributions. Balances over \$1,000 but less than \$7,000 (\$5,000 prior to modification allowed by the SECURE 2.0 Act of 2022), unless specified by the terminated participants, will be paid to the participants in a direct rollover to an individual retirement plan designated by the Plan administrator.

In-service withdrawals of all or a portion of a participant's vested accounts may be made by participants who have attained the age of 59-1/2. Participants are also permitted to take hardship withdrawals from their elective deferral accounts in certain cases of immediate and heavy financial need.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared using the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's investment policies utilizing information provided by the investment advisors and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is accrued when earned. Dividend income is recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants are recorded in the year in which the employee contributions are withheld from compensation. Any discretionary matching contributions from the Company are recorded in the year in which the related participant compensation was earned.

Payments of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to participant-specific transactions are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation in fair value of investments.

3. Information Certified by a Qualified Institution

The Plan administrator, having determined that it is permissible in the circumstances, elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) was obtained or derived from information obtained by the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company, a qualified institution, in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA:

- Investments, at fair value, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment activity, including net appreciation in fair value of investments and interest and dividend income, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- The information for all investments listed in the schedule of assets (held at end of year) as of December 31, 2024, as shown in the ERISA-required supplemental schedules.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the Financial Accounting Standards Board Accounting Standards Codification are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The shares of mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party and Party-In-Interest Transactions

Plan investments included mutual funds managed by affiliates of Fidelity Management Trust Company. Fidelity Management Trust Company serves as trustee of the Plan and an affiliate of Fidelity Management Trust Company serves as recordkeeper of the Plan. Therefore, transactions in these investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA. Administrative expenses paid by the Plan were \$7,328 for the year ended December 31, 2024.

During 2023, the Company failed to remit to the Plan certain employee contributions totaling \$752 within the period prescribed by the Department of Labor regulations. During 2024, the Company made contributions to the affected participants’ accounts to make the participants whole and to compensate those participants for potential lost income due to the 2023 processing delays. The Company believes that these transactions do not affect the tax status of the Plan and has taken action prescribed by the regulations to remedy such errors.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. Tax Status

Effective June 1, 2023, through the adoption of a Fidelity Pre-Approved Defined Contribution Plan, the Plan was amended and restated. The IRS issued an opinion letter dated June 30, 2020, stating that the pre-approved defined contribution plan document was designed in accordance with applicable IRC requirements as of that date. Although the Plan has been amended since receiving the opinion letter, management of the Plan believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan, as amended, is qualified and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

9. Operational Defects

During the Plan year ended December 31, 2023, 2022, 2021 and 2020, the Plan Sponsor failed to follow plan provisions and did not correctly withhold employee deferrals or calculate employer matching contributions for certain employees. The Plan Sponsor computed the missed withholdings and lost earnings on these deferrals and recorded an employer receivable of \$114,032 in the accompanying financial statements for the year ended December 31, 2023. These receivables were funded to the Plan in 2024.

10. Subsequent Events

Effective February 1, 2025, the Plan's eligibility provisions were modified to exclude interns and co-ops hired on or after February 1, 2025. The Plan has evaluated subsequent events through July 28, 2025, the date the financial statements were available to be issued.
