### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Brentwood Originals 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL's") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier ("qualified institution") in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("U.S. GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with U.S. GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

### 1. Description of Plan

The following description of Brentwood Originals 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### **General**

The Plan is a defined contribution plan sponsored by Brentwood Originals, Inc. (the “Company”). The Plan covers all employees of the Company who have at least 1 month of service and are age 18 or older, excluding employees whose conditions of employment are established by the terms of a collective bargaining agreement where retirement benefits are bargained for in good faith, non-resident aliens, and leased employees. The Plan entry dates are the first day of the calendar month. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is being administered by a committee that is appointed by management of the Company (the “Administrative Committee”).

#### **Contributions**

Participants may make pre-tax elective deferrals or Roth elective deferrals from their annual compensation as defined by the Plan, up to the maximum allowed by law. Participants who have attained age 50 before the end of the year are eligible to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. For participants who are making contributions, the Company contributes a safe harbor match in the amount of 100% of each participant’s contribution that does not exceed 4% of participant’s compensation. For the year ended December 31, 2024, the Company made matching contributions of \$420,899.

Additional discretionary contributions may be contributed at the option of the Company. Allocations of additional discretionary contributions are based on a percentage of the annual salary of each eligible participant who is employed by the Company as of December 31, 2024, and has worked at least 1,000 hours. There were no additional discretionary contributions made for the year ended December 31, 2024. Participants direct the investment of all contributions into various investment options offered by the Plan.

#### **Participant Accounts**

Each participant’s account is credited with the participant’s contributions, the Company’s matching contributions, an allocation of the Company’s additional discretionary contributions, if any, and an allocation of Plan earnings within the designated specified investment funds. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### **Vesting**

Participants are immediately vested in their own contributions to the Plan and employer safe harbor matching contributions, plus actual earnings thereon. Vesting in additional discretionary contributions plus actual earnings thereon is determined by length of employee service. A participant is 100% vested after six years of credited service or after attaining the age of 65, whichever occurs first. Participants who become totally disabled or die before normal retirement age become fully vested in their accrued benefits.

### 1. Description of Plan, continued

#### ***Payment of Benefits***

On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum distribution or transfer the vested balance to a qualified plan. The Plan provides in-service distributions for participants after attaining normal retirement age as defined in the Plan agreement. Distributions under the Plan shall generally be made as soon as possible after the date of retirement, date of death, or termination of employment. Effective January 1, 2024, mandatory distributions of account balances under \$7,000, per SECURE Act 2.0, will be made as soon as possible.

#### ***Hardship Withdrawals***

A participant may be permitted to withdraw a portion of their account balance, limited to certain restrictions described in the Plan's provisions, for the reasons specified by and to the extent permitted under regulations issued by the Internal Revenue Service ("IRS").

#### ***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable terms range from one to five years, or up to 15 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at rates determined by the Plan's administrator based on prevailing interest rates charged by other lenders for similar types of loans. Interest on notes receivable from participants was charged at rates ranging from 5.25% to 10.50% as of December 31, 2024. Principal and interest are paid ratably through weekly payroll deductions.

#### ***Forfeited Accounts***

Forfeited non-vested accounts of terminated participants are held for the participant's rehire or five years, whichever is sooner. If the former participant is not rehired within five years, then the non-vested portion of their account balance plus earnings attributable to this portion are forfeited and are first used to pay any administrative expenses of the Plan. Remaining forfeitures are used to reduce the employer's discretionary matching contributions. As of December 31, 2024 and 2023, there were no forfeited non-vested accounts.

#### ***SECURE Act 2.0***

On December 23, 2022, Congress passed the Consolidated Appropriations Act of 2023, which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since provisions of SECURE Act 2.0 include both required and optional elements, applicable provisions will be evaluated and implemented in accordance with accompanying regulations and guidance, and the Plan will be amended as required. Certain provisions became effective for 2024, including changes to long-term part-time eligibility and additional increases to the required minimum distribution age. These changes had no material impact to the Plan's financial statements as of December 31, 2024 and 2023, and for the year ended December 31, 2024.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments, as certified by John Hancock Life Insurance Company (U.S.A.) (the "Custodian") are stated at fair value, except for the benefit-responsive investment contract, which is reported at contract value (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Administrative Committee determines the Plan's valuation policies utilizing information provided by the Custodian. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded as reported by the Custodian. Dividends and interest income are reinvested. Net realized and unrealized appreciation includes the Plan's gains and losses on investments purchased and sold, as well as held during the year. Differences between the fair value of investments at the beginning of the year, or cost if acquired subsequently, and fair values at the end of the year are recorded as appreciation or depreciation in fair value of investments.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan's administrator deems the note receivable to be in default, the note receivable balance is reduced, and a benefit payment is recorded.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative and other expenses. Investment-related expenses are included in net realized and unrealized appreciation of investments.

### 3. Information Prepared and Certified by Custodian

The Plan's assets are held by the Custodian pursuant to the Trust Agreement, which provides that all funds received by the Custodian shall be held, administered, invested, and distributed by the Custodian, and that no part of the corpus or income shall be used for, or directed to, purposes other than for the exclusive benefit of participants or their beneficiaries.

The following information included in the accompanying financial statements and supplemental schedule was obtained or derived from data that has been supplied to the Plan's administrator and certified as complete and accurate by the Custodian as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

### 4. Investment Contract

The Plan holds a fully benefit-responsive guaranteed investment contract with the Custodian totaling \$128,477 and \$92,772 as of December 31, 2024 and 2023, respectively. The Custodian maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a monthly basis for resetting. The guaranteed investment contract does not permit the Custodian insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the Custodian, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value, such as:

1. An uncured violation of the Plan's investment guidelines.
2. A breach of a material obligation under the contract.
3. A material misrepresentation.
4. A material amendment to the agreement without the consent of the issuer.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. The Company does not believe that any events that may limit the ability of the Plan to transact at contract value or terminate the contract with the issuer are probable as of December 31, 2024, or the date these financial statements are available to be issued.

### 5. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access at the measurement date.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs that are unobservable inputs for the asset or liability.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

There were no Plan assets that fell within Levels 1, 2 or 3.

Investments in pooled separate accounts are valued at the net asset value ("NAV") of units held in a pooled separate account. The NAV is based on the fair value of the underlying investments held by the Custodian less its liabilities. The Plan has concluded that the NAVs as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the Custodian approximates the fair value of the investments.

### 6. Party-in-Interest Transactions

The Plan has investments in participation units held in pooled separate accounts and a benefit-responsive investment contract managed through sub-accounts of the Custodian. Therefore, these investments and transactions qualify as party-in-interest transactions. The fair value of investments managed by the Custodian and its affiliate amounted to \$8,191,203 and \$6,731,514 as of December 31, 2024 and 2023, respectively.

Fees paid by the Plan for administrative services provided by the Custodian and third-party administrator amounted to \$74,192 for the year ended December 31, 2024.

### 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, all participants will become fully vested in their accounts.

### 8. Tax Status of the Plan

The Plan has adopted a prototype plan prepared by the Custodian of the Plan. This prototype plan has obtained its latest determination letter on June 30, 2020, in which the IRS stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan's administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. There are no uncertain tax positions as of December 31, 2024 and 2023. The Plan is subject to routine audits by the IRS and/or Department of Labor; however, there are currently no audits for any tax periods in progress.

### 9. Risks and Uncertainties

The Plan provides for various investment options in pooled separate accounts sponsored by an insurance company. These investments are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with these investments and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

The Plan invests in pooled separate accounts that may in turn invest in securities of foreign companies, which involve special risks and considerations not typically associated with investing in U.S. companies. These risks include devaluation of currencies, less reliable information about issuers, different securities transaction clearance and settlement practices, and possible adverse political and economic developments. Moreover, securities of many foreign companies and their markets may be less liquid and their prices more volatile than securities of comparable U.S. companies.

As of December 31, 2024 and 2023, approximately 35% and 36%, respectively, of net assets were held across three mutual funds.
