Note 1 - Plan Description

The following description of the Fred Hutchinson Cancer Center Retirement Savings Plan (the Plan) is provided for general information purposes only. More complete information regarding the Plan's provisions may be found in the plan agreements.

General - The Plan is a defined contribution plan sponsored by Fred Hutchinson Cancer Center (Fred Hutch) under the provisions of Section 403(b) of the Internal Revenue Code (the IRC), which includes a qualified cash or deferred arrangement, for the benefit of eligible employees of Fred Hutch.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Administration - The Plan is administered by Fred Hutch's Benefits Director. The custodians and recordkeepers of the Plan includes Fidelity Management Trust Company and Fidelity Workplace Services (collectively referred to as Fidelity), Teachers Insurance and Annuity Association of America, College Retirement Equities Fund, and TIAA Trust, N.A. (collectively referred to as TIAA), and Voya Retirement Insurance and Annuity Company (Voya). Fred Hutch will remit ongoing contributions to Fidelity only.

Eligibility - Employees are eligible to make deferrals to the Plan on their date of hire. Eligible employees, as defined by the Plan, are entitled to employer contributions on the first day of the month following 12 months of service.

Contributions - Participants may elect to defer up to 80% of their eligible compensation as pre-tax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans (rollovers). The Plan includes a provision whereby all newly eligible employees are automatically enrolled at a 3% deferral rate unless they elect a different deferral rate or not to participate in the Plan. Automatically enrolled participants will have their deferral rate increase by 1% on November 1st of each year, up to a maximum of 10%, unless otherwise elected.

Eligible participants receive employer contributions of 7% of eligible compensation up to the Social Security wage base in effect on the first day of the plan year and 12% of compensation in excess thereof up to the IRC annual compensation limit. In addition, Fred Hutch may choose, but is not obligated, to contribute an additional 3% for full and associate professors and vice presidents and above. Fred Hutch elected to make this contribution for the year ended December 31, 2024.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts - Each participant's account is credited with the participant's contributions, allocations of Fred Hutch's nonelective contributions, as well as Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their account into various investment options offered by the Plan.

Vesting - Participants are immediately vested in all contributions and earnings thereon.

Note 1 - Continued

Payment of Benefits - Upon termination of service, retirement, death, or disability, a participant or beneficiary may elect to receive payment of benefits among the options provided under the Plan, including either a lump sum distribution equal to the value of the participant's interest in their account or an annuity to be paid in monthly installments over a fixed reasonable period of time, not exceeding the life expectancy of the participant or designated beneficiary. Effective March 15, 2024, the annuity distribution option was eliminated for distributions from Fidelity. Participants who have attained age 59½ may also elect to receive a distribution of all or any portion of their elective contributions and related earnings prior to termination of employment (in-service withdrawals). Additionally, participants who have attained age 59½ and are continuing in the service under the Fred Hutch phased retirement policy may elect to receive a distribution of all or any portion of their entire account, including nonelective employer contributions. The Plan allows for hardship withdrawals in accordance with provisions specified in the Plan document. Participants may also elect to receive in-service withdrawals from balances rolled into the Plan.

Notes Receivable From Participants - Participants may borrow from their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account. Loans are secured by the balance in the participant's account. Effective March 15, 2024, loans may only be made from accounts attributable to pre-tax and Roth elective deferrals and rollovers from other Plans. Interest rates are set at 1% above the prime rate, as defined. Principal and interest are paid directly to Fidelity and TIAA.

Plan Loans - A participant may borrow amounts from TIAA under a plan loan feature with the participant's account balance securitizing the plan loan. The maximum loan term is five years unless the loan term qualifies as a home loan, in which case the term of the loan is not to exceed ten years. Effective April 1, 2024, Plan Loans are no longer an option offered by Fidelity, the new custodian and recordkeeper for the Plan. Such loans are not recorded in the financial statements and total approximately \$1,400,000 and \$2,100,000 as of December 31, 2024, and 2023, respectively.

Note 2 - Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments are reported at fair value except for fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants - Notes receivable from participants are measured at their unpaid principal balance. Accrued but unpaid interest, if any, would not have a material impact on the Plan's financial statements. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the loan to be in default, the loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid. When a participant's accumulation in the TIAA Traditional Annuity is converted to a lifetime payout annuity, the present value of the stream of payments is equal to the accumulated balance, and the entire amount is recorded as a distribution in the statement of changes in net assets available for benefits.

Investment Management and Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by Fred Hutch. Expenses that are paid by Fred Hutch are excluded from these financial statements. Transaction based fees for notes receivable from participants and benefit payments are charged directly to participant accounts. Certain investment related expenses are charged directly against the fund's investment performance and, therefore, are not separately disclosed in the accompanying financial statements.

Subsequent Events - The Plan's management has evaluated subsequent events through July 11, 2025, the date the financial statements were available to be issued.

Note 3 - Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; or
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Registered Investment Company Funds - Valued at the closing price as reported by the fund. Registered investment company funds are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds publish their daily net asset value (NAV) and transact at that price. The registered investment company funds held by the Plan are deemed to be actively traded.

Self-Directed Brokerage Accounts - Accounts primarily consist of registered investment company funds which are valued as previously described.

Pooled and Separate Accounts - CREF is a registered investment company and consists of eight accounts which fund variable annuity contracts issued by CREF. The fair values of accumulation units are based on each account's daily published NAV. Except for the CREF Money Market Account, NAV is based on the market value of each account's holdings determined by market quotations or prices obtained from independent pricing sources. The CREF Money Market Account is valued at amortized cost, which approximates fair value. Accumulation units are available for transactions at the closing accumulation unit value on any day the New York Stock Exchange (NYSE) is open for business.

The TIAA Real Estate Account (REA) is a pooled separate account which funds variable annuity contracts issued by TIAA. The fair value of accumulation units is published daily and based on the market values of the underlying real estate properties determined by external appraisals, which are estimates of property based on a professional's opinion. The REA may also hold real estate-related marketable securities which are valued using independent pricing sources. Accumulation units are available for transactions at the closing accumulation unit value on any day the NYSE is open for business. Transfers out of the REA are limited to one per calendar quarter.

Non-Fully Benefit Responsive (Non-FBR) Insurance Contracts - Investments in Non-FBR insurance contracts are required to be reported at fair value; however, the Plan's financial statements reflect Non-FBR insurance contracts at their contract value. Contract value is the aggregation of contributions, plus interest, less any withdrawals. Reporting Non-FBR insurance contracts at contract value did not have a material effect on the Plan's financial statements as contract value approximates a discounted cash flow value (fair value) calculated using an appropriate risk-adjusted market discount rate which correlates closely with TIAA's Traditional Annuity's historical crediting rates. Fair value is determined annually for financial statement reporting purposes. In determining the reasonableness of the methodology, the Plan's management evaluates a variety of factors including review of existing contracts, historical returns, market conditions, and overall credit ratings. Certain unobservable inputs are substantiated utilizing available market data (e.g., Treasury yields).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5 - TIAA Traditional Annuity

The TIAA Traditional Annuity is an unallocated fixed annuity contract available as an investment option to plan participants. Each contract is fully and unconditionally guaranteed by TIAA. The Traditional Annuity is offered through a variety of contract types, including Retirement Annuities (RA), Group Retirement Annuities (GRA), Supplemental Retirement Annuities (SRA), Group Supplemental Retirement Annuities (GSRA), Retirement Choice Annuities (RC) and Retirement Choice Plus Annuities (RCP). The type of contract through which a participant invests in the TIAA Traditional Annuity determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional interest declarations, the degree of liquidity of the participant's account, and the options for receiving income upon retirement.

The TIAA Traditional Annuity is segregated into non-fully benefit and fully benefit responsive categories.

Investments in fully benefit responsive TIAA Traditional Annuity contracts are reported at contract value. Contract value is the aggregation of contributions, plus interest, less withdrawals and administrative expenses, if any. The SRA, GSRA, and RCP are considered fully benefit responsive. There are no liquidity restrictions for these contracts. Lump sum withdrawals and transfers from RCP contracts can occur without surrender charges but a 90-day equity wash rule may be required if investments are transferred to competing funds. There are no events that would limit the Plan from transacting at contract value with the issuer or that would allow issuers to terminate these fully benefit responsive investment contracts with the Plan and settle at an amount different from contract value. The contract value of the fully benefit responsive TIAA Traditional Annuity contracts is \$14,224,651 and \$14,856,150 as of December 31, 2024 and 2023, respectively.

As of May 1, 2012, new accounts were established for all active participants, which only include the RC. All participants in the pre-May 2012 legacy accounts are able to maintain their accumulations in that account, which includes the following annuity options: RA, GRA, SRA, and GSRA. While participants may reallocate accumulations among the available investment options including these annuities, they cannot make new contributions to the pre May 2012 legacy accounts.

When participants choose to allocate a portion of their retirement savings to the TIAA Traditional Annuity during the accumulation phase of the contract, their contributions purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time the premium is paid. The participant's principal, plus a specified minimum rate of interest, are guaranteed by TIAA's claims paying ability. The TIAA Traditional Annuity also provides the potential for additional interest if declared by TIAA's Board of Trustees. Additional interest, when declared, remains in effect for the declaration year, which begins each March 1 for accumulating annuities, and January 1 for lifetime payout annuities. Additional interest is not guaranteed for future years. Together, the guaranteed minimum and additional amounts make up the crediting interest rate.

The RA contract does not allow lump sum cash withdrawals and transfers must be spread over ten annual installments. With the GRA and RC contracts, lump sum withdrawals are available within 120 days of termination of employment and are subject to a 2.5% surrender charge. All other withdrawal and transfers from GRA contracts must be spread over ten annual installments and RC withdrawals and transfers must be spread over an 84 month period (seven years) in monthly systematic payments.

Note 6 - Tax Status

Management has adopted a Fidelity Workplace Services LLC pre-approved 403(b) plan document. Fidelity Workplace Services LLC received an approval letter from the IRS dated August 7, 2017, which states that the form of the plan document satisfies the applicable provisions of Section 403(b) of the Internal Revenue Code (IRC). The Plan itself has not received a determination letter from the IRS; however, the Plan's management believes that the Plan is designed, and is currently being operated, in a manner that would not jeopardize the tax benefits associated with these arrangements. The Plan is subject to audits by the IRS; however, there are currently no audits for any tax periods in progress.

Note 7 - Plan Termination

Although it has not expressed any intent to do so, Fred Hutch has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 8 - Certified Investments

Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024 and 2023, and investment income or loss for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Teachers Insurance and Annuity Association of America ("TIAA") and College Retirement Equities Fund ("CREF"), qualified institutions. TIAA has been authorized by TIAA Trust, N.A. to certify investments for which TIAA Trust, N.A. is the directed custodian. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Effective March 14, 2024, Fidelity Management Trust Company became a custodian for the Plan. Certain information in the accompanying financial statements and supplementary information related to investments held as of December 31, 2024, investment income or loss for the period March 14, 2024 through December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company. The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplementary information.

Note 9 - Party-in-Interest Transactions

Certain Plan investments are managed by Fidelity, TIAA, and CREF. Fidelity, TIAA, and CREF are custodians for the Plan and, therefore, transactions with such investments are party-in-interest transactions. The Plan pays certain expenses related to plan operations to various service providers and also issues loans to participants. These transactions are party-in-interest transactions.

Note 10 - Concentrations

Financial instruments that potentially subject the Plan to concentrations of credit risk consist principally of the fixed annuity contracts issued by TIAA. These investments represent approximately 8% and 9% of total plan investments at December 31, 2024 and 2023, respectively. The Plan's management seeks to limit its credit exposure by working with high credit quality institutions.
