Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of NACHRI Defined Contribution Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal controls-related matters that we identified during the audit.

1. DESCRIPTION OF THE PLAN

The following brief description of the NACHRI Defined Contribution Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution 403(b) plan covering substantially all full-time employees who work over 20 hours at National Association of Children's Hospitals and Related Institutions, Inc. (the Association). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was most recently amended and restated January 1, 2019.

Recent Legislation

The Setting Every Community Up for Retirement Enhancement (SECURE) Act 2.0 was signed into the 2023 Consolidations Appropriations Act under the Securing a Strong Retirement Act on December 29, 2022, with retirement provisions designed to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and lower employers' cost of offering and funding retirement plans. The Plan's management and those charged with governance have a policy to incorporate these legislative changes in its Plan document by the prescribed deadlines.

Contributions

Prior to August 1, 2024, an eligible employee became a participant in the Plan for purposes of receiving matching contributions or an allocation of any employer non-elective contributions after completing one year of eligibility service, as defined in the Plan document.

Effective August 1, 2024, the Plan was amended to change eligibility requirements for employer contributions. Employees hired on or after August 1, 2024 are eligible to receive matching and non-elective contributions immediately upon reaching their Entry Date. Employees hired before August 1, 2024, remain subject to the previous eligibility rule and will become eligible for matching and non-elective contributions in the month following their one-year anniversary.

Under terms of the Plan, the Association contributes up to 5% of eligible compensation to employees who elect to make contributions to the NACHRI Tax Deferred Annuity Plan (TDA Plan), a Section 403(b) plan, subject to certain limitations. The matching contributions are typically funded bi-weekly. Additional contributions to the Plan by the Association are discretionary and are determined on an annual basis by the Plan's Board of Trustees.

Notes to the Financial Statements For the Year Ended December 31, 2024 and 2023

1. DESCRIPTION OF THE PLAN (continued)

Contributions (continued)

For the year ended December 31, 2024, the Association made matching contributions totaling \$749,549 on the employees' behalf. For the year ended December 31, 2024, the Association made \$679,703 in discretionary contributions.

Participant Accounts

Each participant's account is credited with the employer contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or by the Plan participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100 percent vested in non-elective and matching contributions plus actual earnings after completing 3 years of service for those hired after August 1, 2024. Prior to August 1, 2024 participants were 100 percent in matching contributions after completing one year of service.

Payment of Benefits

Upon termination of service, a participant can elect to receive the value of the participant's vested account balance in the form of lump sum, partial, installment and annuity payment, as defined in the Plan document.

Forfeited Accounts

Forfeited nonvested accounts are first used to reduce future employer contributions and then are used to reduce administrative expenses. As of December 31, 2024, there were no forfeited nonvested.

Plan Termination

Although it has not expressed any intent to do so, the Association has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would be 100 percent vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Contributions

Employer matching contributions are typically recorded in the period that the Plan makes payroll deductions from the participant's earnings. The discretionary match is recorded in the period the Board of Trustees approves the annual contribution.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Plan Servicing Credits

Periodically, certain revenue sharing payments (e.g., 12b-1 fees, etc.) received from certain of the Plan's investment options. The revenue sharing payments may be recorded as plan servicing credits in the Plan's dedicated administrative budget account or reallocated directly to participant accounts. Amounts deposited in the administrative budget account are used to pay on-going administrative expenses of the Plan or reallocated directly to participant accounts in accordance with ERISA and guidance issued by the U.S. Department of Labor.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Plan Servicing Credits (continued)

For the year ended December 31, 2024, \$29,781 was used to pay administrative expenses of the Plan, while \$10,528 of plan servicing credits were received by the Plan and reallocated directly to participant accounts. The dedicated administrative budget account gained \$1,591 in investment returns for the year ended December 31, 2024. As of December 31, 2024 and 2023, the dedicated administrative budget account balance was \$1,182 and \$29,372, respectively.

Subsequent Events

The Plan Administrator evaluated subsequent events and transactions through July 22, 2025, the date these financial statements were available for issue, and has determined that no material subsequent events, have occurred that would affect the information presented or require additional disclosure.

3. CERTIFIED INVESTMENTS

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held as of December 31, 2024 and 2023, and net appreciation/(depreciation) in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by TIAA and CREF, the custodians of the Plan.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the entity has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

4. FAIR VALUE MEASUREMENTS (continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Registered Investment Companies: Valued at the closing prices of shares held by the Plan at year end.

Insurance Company General Contract: The account is mainly invested in TIAA Traditional Annuity. The value of the TIAA Traditional Annuity equals the accumulated cash contributions, interest credited to the Plan's contract, and transfers, if any, less any withdrawals and transfers, if any. The TIAA Traditional Annuity is not available for sale or transfer on any securities exchange. Accordingly, transactions in similar investment instruments are not observable.

Pooled Separate Account (Investments Valued at Net Asset Value): The pooled separate account is a registered investment company that invests in real estate properties and real estate related investments. The account's value is principally derived from the market value of the underlying real estate holdings (REA) or other real estate-related investments. REA are valued principally using external appraisals, which are estimates of property values based on a professional's opinion.

The REA sometimes holds securities as well. These are generally priced using values obtained from independent pricing sources. Unit values are calculated each day and reported at Net Asset Value (NAV).

7. TAX STATUS

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated August 7, 2017, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes the Plan is qualified.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
