### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Celia Corporation 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Celia Corporation 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. ### **1. Description of the Plan and Significant Accounting Policies**

The following description of the Celia Corporation 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution retirement plan covering substantially all employees of Celia Corporation, Spartan Graphics, Inc., and iGraphics, LLC (Companies) who have completed three months of service and are age 18 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On November 9, 2022, the Plan was amended to increase the automatic participant deferral amount for employees hired on or after January 1, 2023 from 3% of eligible compensation to 5%. On January 16, 2023, the Plan was amended to modify the Plan's definition of compensation to include bonus pay, effective February 1, 2023.

#### **Trust**

A trust has been established under the Plan to hold the Plan's assets. The Companies have appointed three individuals as trustees.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and allocations of the Companies' contributions and Plan earnings and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Investment Options**

Upon enrollment in the Plan, a participant may direct contributions into a number of investment options. Participants may change their investment options at any time.

### **1. Description of the Plan and Significant Accounting Policies (continued)**

#### **Contributions**

Subject to certain limitations, the Companies' employees participating in the Plan may make voluntary pre-tax and/or Roth contributions to the Plan through a salary reduction program. Total annual pay deferrals are not to exceed the maximum annual amount allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Upon attaining eligibility requirements, participants who do not affirmatively make a deferral election will be automatically enrolled in the Plan at a pre-tax deferral rate of 5% of eligible compensation. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Companies may provide discretionary matching contributions to the Plan as determined by the Companies' Boards of Directors. The Plan allows for regular employer contributions paid each payroll period to all eligible participants in the Plan. In 2023 and 2024, regular employer contributions were paid out as 25% of employee deferrals, up to 15% of each participant's eligible compensation. The Plan also allows for additional employer contributions paid at the end of the year to participants who are employed on the last day of the Plan year. In 2023 and 2024, there was an additional employer contribution of 25% of employee deferrals, up to 15% of each participant's eligible compensation.

#### **Payments of Benefits**

Distributions from the Plan may be made in lump-sum payments and are payable in cash. Distributions may be made once a participant reaches the minimum retirement age and begins voluntary in-service distributions, retires, dies (in which case, payment shall be made to his or her beneficiary or, if none is designated, his or her legal representatives), becomes disabled, or otherwise terminates employment. The Plan agreement does not allow for hardship distributions or participant loans to be made from Plan funds. Benefits are recorded when paid.

#### **Administrative Expenses**

Certain administrative expenses are paid by the Plan. Expenses are paid to Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodians of the Plan, from participant accounts related to asset management and certain participant-initiated transactions. Certain expenses related to the overall administration of the Plan are paid by the Companies and are therefore excluded from these financial statements.

### **1. Description of the Plan and Significant Accounting Policies (continued)**

#### **Termination of the Plan**

Although they have not expressed an intent to do so, the Companies have the right to amend or terminate the Plan at any time. In the event the Plan is terminated, all participant account balances become fully vested and nonforfeitable. In the event of partial termination, only those who separate from service shall be fully vested.

#### **Vesting**

Each participant is vested in his or her account balance based on years of service as defined in the Plan document. Vesting percentages for employer contributions and allocations of net investment earnings on these funds range from 20% after two years of service to 100% after six years of service. All participant contributions along with allocations of net investment earnings on these funds are fully vested and nonforfeitable.

#### **Forfeitures**

Accounts of nonvested participants are forfeited in the year of termination. Forfeited balances are used to pay Plan expenses or to reduce employer contributions. During the year ended December 31, 2024, there was \$29,888 in forfeitures used to reduce employer contributions or to pay expenses (\$68,191 for the year ended December 31, 2023). In addition, there was a balance of \$34,830 of forfeitures as of December 31, 2024 (\$14,345 as of December 31, 2023).

#### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, results could differ from those estimates.

#### **Basis of Accounting**

The financial statements have been presented on the accrual basis of accounting in accordance with U.S. GAAP.

#### Valuation of Investments

The fair values of the investments held in mutual funds are determined using quoted market values as of the last business day of the Plan years. Investments held in fixed annuities are stated at contract value, determined based on methods disclosed in the annuity contracts as calculated by the annuity provider.

The difference between fair value and the cost of investments held is combined with realized gains and losses on the sale of investments and reported in the statements of changes in net assets available for benefits as net appreciation or depreciation in the fair value of investments. Realized gains and losses on the sale of investments represent the difference between the proceeds received and the original cost of investments sold.

#### Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs. Based on the observability of the inputs used in the valuation techniques, the Plan is required to provide the following information according to the fair value hierarchy. The fair value hierarchy ranks the quality and reliability of the information used to determine fair values.

Financial assets and liabilities carried at fair value will be classified and disclosed in one of the following three categories:

- Level 1 – Quoted prices (unadjusted) for identical assets or liabilities in active markets that the entity has the ability to access as of the measurement date.
- Level 2 – Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.
- Level 3 – Significant unobservable inputs that reflect an entity's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

#### **Fair Value Measurements (continued)**

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- Mutual funds: Valued using quoted market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Subsequent Events**

Plan management has evaluated subsequent events for potential recognition and disclosure in the financial statements through July 24, 2025, which is the date the financial statements were available to be issued.

### **2. Federal Income Taxes**

The Plan utilizes a non-standardized pre-approved profit sharing plan adopted through a third-party provider. The Plan obtained its latest determination letter from the Internal Revenue Service dated April 29, 2022, stating that the Plan qualified under Section 401 of the IRC. The Plan is required to operate in conformity with the IRC to maintain its qualification. Although the Plan has been amended since the date of the determination letter, the Companies believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and that the Plan is tax exempt. Therefore, there is no provision for income taxes in the Plan's financial statements.

Generally, tax years 2021 through the current year remain open to examination. The Plan administrator does not believe that the results from any examination of these open years would have a material adverse effect on the Plan.

### 3. Information Certified by the Custodian (Unaudited)

Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the custodians of the Plan, held the investment assets and executed related transactions as of and for the years ended December 31, 2024 and 2023. Substantially all information pertaining to the Plan's investment balances and investment income included in the financial statements and supplemental schedule has been certified by them. This certified investment information has not been audited by independent accountants.

### 5. Fixed Annuity Contract

The Plan has a fixed annuity contract with Empower Annuity Insurance Company of America (formerly Great-West Life & Annuity Insurance Company) that invests contributions in the Key Guaranteed Portfolio Fund with a contract value of \$1,447,916 as of December 31, 2024 (\$1,746,203 as of December 31, 2023). The Key Guaranteed Portfolio Fund is a general account product. The fixed annuity contract credits interest daily to the contract holder on a portfolio basis. The credited interest rate may change or stay the same each quarter. The quarterly credited rate applies to all money deposited in the account, regardless of when it was deposited. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract plus earnings less participant withdrawals and administrative expenses.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. These amounts may be restricted for up to 30 days in the event of excessive participant trading. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

#### **6. Transactions with Parties-in-Interest**

Certain administrative functions related to the Plan are performed by officers and employees of the Companies. No such officer or employee receives compensation from the Plan. Administrative expenses paid by the Companies include payments to the Plan's third-party administrator (Doeren Mayhew), investment advisors (Robert W. Baird & Co. Inc.), and auditor for services to the Plan. The Companies do not expect reimbursement from the Plan for these expenses; therefore, such expenses are excluded from these financial statements. These administrative expenses are considered party-in-interest transactions.

Plan investments include fixed annuities that are managed by the custodian or its affiliates with a contract value of \$1,447,916 as of December 31, 2024 and \$1,746,203 as of December 31, 2023.

#### **7. Risks and Uncertainties**

The Plan's investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the financial statements.



