Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### 1. DESCRIPTION OF PLAN

The following description of the Aeon 403 (b) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

The Plan's Sponsor and Plan Administrator is Aeon (the Organization) and the Plan's Custodian is Alerus Financial, N.A. (the Custodian). Aeon Management, LLC is a participating employer in the Plan. The Plan excludes collective bargaining (union) employees and non-resident aliens. Investments are held in mutual funds and a money market fund.

**General** - The Plan is a defined contribution plan covering all eligible employees of the Organization. Employees qualify for salary reduction (deferral) contributions beginning on the date of employment. Employees who have one year of service, which is defined as the completion of 1,000 hours of service within a Plan year; are age 19 or older as of the available Plan entry dates; and are employed on the last day of the Plan year are eligible for employer contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

**Contributions** - Participants are allowed to make elective, pretax (traditional 403(b)) deferral contributions or elective after-tax (Roth 403(b)) deferral contributions up to IRS limits and not to exceed 100% of pretax annual compensation, as defined in the Plan Agreement. Participants who have attained the age of 50 are allowed to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Organization may make a discretionary matching contribution equal to a uniform percentage or dollar amount of the employee's elective deferrals. No discretionary matching contributions were made for the plan years ended December 31, 2024 or December 31, 2023. The Organization contributed up to 3% of base compensation that a participant contributed to the Plan for eligible employees for the plan year ended December 31, 2024. These contributions were included with employer contributions receivable at December 31, 2024. The Plan allows for additional non-elective contributions in amounts determined at the sole discretion of the employer. No non-elective contributions were made in 2024.

**Vesting** - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Organization's contributions is based on years of credited service. A participant is 100% vested after six years of credited service. Notwithstanding the above, a participant's account becomes fully vested upon death, disability, or retirement.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and allocations of the Organization's discretionary matching contributions and non-elective contributions, if any, and Plan earnings and increases and decreases in the value of investments, net of expenses. Allocations of the Organization's discretionary matching contributions are based on elective participant contributions and participant compensation; allocations of non-elective contributions are based on participant compensation; and allocations of plan earnings are based on account balances, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Notes Receivable from Participants** - Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at fixed rates of prime plus 1% determined at inception of the loan. The interest rate on the notes outstanding at December 31, 2024 ranges from 4.25% to 9.50%. Principal and interest is paid through payroll deductions.

**Payment of Benefits** - On termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of the participant's account in either a lump-sum amount, or in annual installment options as specified in the Plan. For termination of service due to other reasons, participants with vested accounts of less than \$5,000 will have their vested balance distributed as soon as administratively possible. Participants with vested accounts greater than \$5,000 may receive the value of the vested interest in his or her account as a lump-sum distribution or minimum required distributions. The Plan also allows for in-service withdrawals and hardship withdrawals subject to Plan provisions.

**Forfeited Accounts** - Forfeitures can be used to pay administrative expenses of the Plan or reduce employer non-elective contributions. Forfeited non-vested accounts totaled \$71,011 and \$24,990 at December 31, 2024 and 2023, respectively. In 2024, \$17,676 of forfeitures were used to pay administrative expenses. In July 2025, forfeitures applied to the 2024 employer contributions receivable totaled \$93,424.

**Investment Options** - Participants are allowed to direct the investment of their contributions among the various investment options offered by the Plan. Employer contributions are allocated on the same basis as employee contributions.

### 1. DESCRIPTION OF PLAN (Continued)

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The accompanying financial statements for the Plan have been prepared on the accrual basis of accounting.

**Estimates** - The preparation of any financial statements in accordance with U.S. generally accepted accounting principles may require management to make estimates and assumptions that affect certain amounts reported and disclosed in the financial statements. Actual results could differ from such estimates.

**Valuation of Investments** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded (deemed distribution).

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - The Organization pays certain administrative expenses on behalf of the Plan. Expenses that are paid from Plan assets are reflected in the statement of changes in net assets available for benefits.

#### 4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means; and Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement and have the lowest priority.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the methodologies used to measure the fair value of the Plan's investments. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Money market fund:** Valued at the daily closing price as reported by the fund. The money market fund held by the Plan is registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The money market fund held by the Plan is deemed to be actively traded.

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although Plan management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan Agreement to terminate the Plan at any time subject to the provisions of ERISA. In the event of Plan termination, all of the assets will be distributed to the participants based on the balances in their respective accounts.

### 6. INCOME TAX STATUS

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the Code). The volume submitter plan document adopted by the Plan obtained its latest advisory letter on March 31, 2017, in which the Internal Revenue Service stated that the volume submitter, as then designed, was in compliance with the applicable requirements of the Code. The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the advisory letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected.
