### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Karr Tuttle Campbell Retirement Savings Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Karr Tuttle Campbell Retirement Savings Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

#### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Karr Tuttle Campbell Retirement Savings Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. ### ***Responsibilities of Management for the Financial Statements***

### Note 1 – Description of Plan

**General** – The following description of the Karr Tuttle Campbell Retirement Savings Plan and Trust (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions. The Plan is a defined contribution plan offered to eligible employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**Plan Termination** – Karr Tuttle Campbell P.S. (the Employer) adopted a resolution effective July 1, 2025, to terminate the Plan. Effective with the Plan's termination, all participants with an account balance remaining in the Plan became fully vested in all contribution sources, regardless of status or years of vested service. Upon the resolution date, the Plan ceased accepting employee and employer contributions as well as new participant notes receivable. All Plan assets will be liquidated and distributed in accordance with the Plan provisions under ERISA in 2025.

**Eligibility and vesting** – All salaried employees of the Employer may participate in the 401(k) portion of the Plan on the first of the month following 60 days of continuous employment. All salaried employees, except associates, legal secretaries and paralegals, become eligible to share in the non-elective employer contribution on January 1 or July 1 following the completion of two years of service. A year of service for eligibility purposes is defined as the completion of 1,000 hours of service during an employment anniversary year. Participants are 100% vested in their entire plan balance at all times. Participants must be actively employed on the last day of the Plan year to receive employer contributions (except in the case of death, disability, or retirement).

**Contributions** – Participants designate how their contributions and earnings will be invested in a variety of investment funds. The Plan provides for two types of contributions:

*Employer contributions* – The Employer may make non-elective employer contributions which consist of 10.5% of defined compensation of eligible participants plus an additional contribution of 5.7% of compensation paid in excess of the Social Security taxable wage base up to the maximum allowed by law. Contribution percentages may be adjusted by the Board of Directors of the Employer. The Plan has been deemed "top heavy" as defined by the Internal Revenue Code (IRC). As a result of the Plan's top heavy status, the Employer makes a minimum top-heavy contribution of not less than 3% of compensation paid to all eligible participants. The employer contributions are remitted to the Plan on an annual basis and are recorded in the year in which the employee contributions are withheld from compensation.

*Participant contributions* – Participants may make pre-tax salary deferrals up to 100% of their total compensation, not to exceed the IRC maximum limits. Participants may elect to make all or a portion of their salary deferrals as Roth contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Contributions from participants are recorded the year in which employee contributions are withheld from compensation. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated fund until elected otherwise by the participant. Unless elected otherwise by the participant, deferrals are automatically increased annually by 1%, up to a maximum auto-deferral of 10%.

**Participant accounts** – Each participant’s account is credited with the participant’s contribution and an allocation of the Employer’s contribution and earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

The Plan allows for participants to invest in funds approved by the Plan’s retirement committee.

**Notes receivable from participants** – Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balances. Each loan includes interest at a current prevailing rate. All loans are to be repaid through payroll deductions in equal monthly installments with interest and principal amortized over a period not to exceed five years. However, if the loan is for purchase of a primary residence, the administrator may permit longer repayment terms. As of December 31, 2024, the interest rate for all participant loans was between 4.25% and 9.50% with various maturities through July 2029.

**Payment of benefits** – On termination of service, a participant (or beneficiary) may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments over a period of not less than two years.

### Note 2 – Summary of Significant Accounting Policies

**Basis of accounting** – The accompanying financial statements have been prepared on the accrual basis of accounting.

**Use of estimates** – The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan’s management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

**Investment valuation** – Investments are stated at fair value. The Plan’s trustee, Matrix Trust Company (the Trustee) certifies the fair value of all investments, if available, quoted market values are used to value investments.

Fair value is the price that would be received to sell an asset or paid to transfer a liability (the exit price) in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

**Income recognition** – Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. The net appreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

**Notes receivable from participants** – Notes receivable from participants are measured at amortized cost, which represents the unpaid principal balance plus accrued but unpaid interest and are classified as notes receivable. Delinquent notes receivable from participants are recorded as distributions based on the terms of the plan document.

**Payment of benefits** – Benefits are recorded when paid.

**Administrative expenses** – Administrative expenses of the Plan are allocated to participants using a flat fee for participants with investments in excess of \$5,000 plus a pro rata charge based on total assets in the participant's account. Certain costs to administer the Plan are paid by the Employer and are not reflected in the accompanying financial statements.

**Subsequent events** – Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued. The Plan recognizes in the financial statements the effects of all subsequent events that provide additional evidence about conditions that existed at the date of the statement of net assets available for benefits, including the estimates inherent in the process of preparing the financial statements. The Plan's financial statements do not recognize subsequent events that provide evidence about conditions that did not exist at the date of the statement of net assets available for benefits, but arose after the statement of net assets available for benefits date and before the financial statements are available to be issued. The Plan has evaluated subsequent events through July 29, 2025, which is the date the financial statements were available to be issued.

### Note 3 – Tax Status

The Plan document is a volume submitter defined contribution plan that received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which stated that the volume submitter plan, as designed, was in accordance with applicable sections of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

In accordance with guidance on accounting for uncertainty in income taxes, management evaluated the Plan's tax positions and does not believe the Plan has any uncertain tax positions that require disclosure or adjustment to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1** – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds)* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective trust* – Units held in collective trusts (CT) are valued using the NAV practical expedient of the CT as reported by the CT managers. The NAV practical expedient is based on the fair value of the underlying assets owned by the CT, minus its liabilities, and then divided by the number of units outstanding. CTs held in the Plan do not have redemption restrictions.

### Note 7 – Party-in-Interest Transactions

The Plan paid expenses related to the Plan's operations and investment management to various service providers. Transactions with these entities qualify as exempt party-in-interest transactions.
