Opinion

Note 1 - Description of Plan

The following brief description of the Ohnward Bancshares, Inc. Employee Stock Ownership Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

Ohnward Bancshares, Inc. (the Company), established the Ohnward Bancshares, Inc. Employee Stock Ownership Plan and Trust effective as of January 1, 1987. The Plan was amended and restated effective January 1, 2022, and operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (Code) of 1986. Additionally, the Plan is subject to applicable provisions of the Employee Retirement Income Security Act of 1974 (the ERISA). The Plan is administered by management of the Company. The trust department of a Company-related bank is the Plan's trustee.

Effective for the 2018 plan year, the Company froze the Plan. As of July 1, 2018, no new employees shall enter the Plan on or hereafter, and no further contributions will be required or permitted.

Eligibility

Employees were eligible to participate in the Plan if they had completed one year of service and were 18 years of age. A year of service for purposes of eligibility was a consecutive 12-month period during which the employee had 1,000 or more hours of service. Employees who maintained 1,000 hours of service during the 12-month period beginning on the date of eligibility and were employed on the last day of the Plan year were eligible to receive an employer contribution, allocation of forfeitures, and repurchased shares.

Entry Date

Employees could enter the Plan on the first day of January or July coinciding with or following the date they satisfied the Plan's eligibility requirements.

Participant Accounts

The Plan is a defined contribution plan under which a separate individual account was established for each participant. Each participant's account is credited with an allocation of shares of the Company's common stock repurchased from terminated participants' accounts and forfeitures of terminated participants' non-vested accounts. Only those participants who were eligible employees of the Company as of December 31, 2017 will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings and losses are allocated to each participant's account based on the number of shares held in the participant's account.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All active participant accounts are non-participant directed aside from the segregated accounts administered through Nationwide Trust Company.

Terminated participants who still have an account with the Plan may have their non-participant directed funds moved into a segregated, participant directed account. For purposes of this provision, "terminated participant" means any ESOP participant who has terminated employment, except those participants who have terminated employment due to death, disability, or retirement.

Vesting

The Plan was previously amended to allow all participants to become 100% vested effective on December 31, 2020.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 years of age with at least ten years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify can transfer funds to participant directed, segregated accounts administered through Nationwide Trust Company.

Voting Rights

The trustee will vote all Company stock held by the Plan. Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee will vote any allocated share for which instructions have not been given timely by a participant.

Put Option

Under Federal income tax regulations, the employer stock that is held by the Plan and its participants is not readily tradable on an established market, or is subject to trading limitations, including a put option. The put option is a right to demand that the Company buys any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's account or monthly, quarterly, or annual installments over a fixed reasonable period of time, generally up to five years, provided the participant's vested balance exceeds \$1,000. A participant's payout on account balances in excess of \$800,000, attributable to Company stock, may be extended beyond five years based on terms in the plan document. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in cash or, if a participant elects, in the form of Company stock. Participants with an account balance less than \$1,000 receive a lump-sum amount upon termination of service.

Plan Termination

The Company has the right under the Plan to terminate the Plan subject to the provisions set forth in the ERISA.

Note 2 - Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

The classification of investment earnings reported in the statement of changes in net assets available for benefits may differ from the classification of earnings on Form 5500 due to different reporting requirements on Form 5500.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net asset available for benefits. In addition, certain investment related expenses are included in net appreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent Events

The Plan sponsor has evaluated subsequent events through July 23, 2025, the date which the financial statements were available to be issued.

Note 3 - Administration of Plan Assets

The Plan’s assets, which consist of Ohnward Bancshares, Inc. common stock, shares of exchange traded funds, and money market accounts are held by the trustee of the Plan, Maquoketa State Bank, or at a third party in a commingled trust account.

Certain segregated accounts, as described in Note 1, are participant directed and are administered through Nationwide Trust Company, which provides several investment options with varying degrees of risk.

Certain administrative functions are performed by officers or employees of the Company or its subsidiaries. No such officer or employee received compensation from the Plan.

Note 4 - Investment in Company Common Stock

The Plan’s investment in Ohnward Bancshares, Inc. common stock is as follows:

During the year ended December 31, 2024, 14 shares of Company common stock were distributed as benefits paid to participants in the amount of \$418,978.

Note 5 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market deposit accounts - Valued at carrying value, which approximates fair value, based on the amount of net contributions plus any investment earnings allocated to the account.

Exchange Traded Funds - Valued at the closing price reported on the active market in which the individual funds are traded. Exchange traded funds (ETF) held by the Plan are registered with the Securities and Exchange Commission.

Pooled separate accounts - Valued at fair value based upon the net asset value (NAV) of units as determined by the insurance company. The NAV is based on the observable market prices of the underlying assets within the account less liabilities. The NAV for the underlying assets of the account is a readily determinable measure of their value and is the basis for current transactions.

Company Common Stock - The fair value of the Ohnward Bancshares, Inc. Company common stock held by the Plan is valued at estimated fair value based upon an independent appraisal. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. The appraiser took into account historical and projected cash flow and net income, return on assets, return on equity, market comparables, and estimated fair value of Company assets and liabilities, including a discount for lack of marketability and lack of control.

Note 7 - Tax Status

The IRS has determined and informed the Company by an opinion dated June 30, 2020, that the pre-approved plan and related trust were designed in accordance with the applicable regulations of the IRC. Since the issuance of the opinion, the Plan was amended to conform to the pre-approved plan covered under the subject opinion. The Company and Plan management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 - Related Parties and Party-In-Interest Transactions

The stock certificates for the sponsor Company common stock, which had a fair value of \$11,656,400 and \$11,432,114 at December 31, 2024 and 2023, respectively, are held in the Plan sponsor's vault. This transaction qualifies as a related party transaction.

The Plan earned dividends on its sponsor Company common stock of \$105,000 and \$104,760 during the years ended December 31, 2024 and 2023, respectively. This transaction qualifies as a related party transaction.

The Plan had \$116,033 and \$193,454 of cash in money market funds at the Plan sponsor and its subsidiaries as of December 31, 2024 and 2023, respectively. This transaction qualifies as a related party transaction.

Certain Plan investments are shares of exchange traded funds totaling \$588,550 and \$460,802 at December 31, 2024 and 2023, respectively, that are held at Fifth-Third Bank, an unrelated party, in a commingled account which is administrated through the Plan sponsor's trust department.

Certain Plan investments are shares of mutual funds managed by Nationwide Trust Company. Nationwide Trust Company is a custodian as defined by the Plan document and, therefore, these transactions qualify as exempt party-in-interest transactions.

Total administrative expenses paid to service providers was \$24,001.

These transactions qualify as exempt party-in-interest transactions.

Note 9 - Risks and Uncertainties

The Plan's investments consist primarily of the investment securities and the Company's common stock, which are exposed to various risks such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Market risks include global events which could impact the value of investments, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities and the investment in the common stock and to uncertainties inherent in the estimations and assumptions, it is at least reasonably possible that changes in the values of the investment securities and the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
