We have performed audits of the financial statements of Nebraska Plastics, Inc. 401(k) (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### 1. Plan Description

---

The following brief description of the Nebraska Plastics, Inc. 401(k) (the Plan) is provided for general informational purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***General***

The Plan sponsors (the Company) include the following adopting employers within the Nebraska Plastics Companies: Nebraska Plastics, Inc. and NP East, LLC.

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of the Company.

Employees are eligible to make salary deferral contributions and receive safe harbor matching contributions after attaining age 18 and completing five months of service. Eligible employees become participants on the first day of the following month coinciding with the date on which entry requirements were fulfilled. Additionally, discretionary matching and profit-sharing contributions can be made by the Company to employees after attaining age 18 and completing one year of service.

#### ***Contributions***

Participants are permitted to make voluntary pre-tax salary deferral contributions up to 100% of their eligible compensation as provided by the Plan, up to the maximum deferral dollar amounts allowed by law. Employees are automatically enrolled in the Plan with an initial salary deferral of 3% unless the Company is informed otherwise. At any time, a participant can elect to not contribute or may increase or decrease their deferral rate to any rate allowed under the Plan. A participant may also stop deferrals at any time. Participants may also contribute amounts representing distributions from other qualified plans. Eligible participants reaching the applicable age may make catch-up contributions up to the amounts allowed by law.

Safe harbor matching contributions will be made equal to 100% of elective deferrals that are not in excess of 3% of eligible compensation plus 50% of deferrals between 3% up to 5% eligible compensation. Discretionary matching contributions may be contributed at the option of the Company's Board of Directors with no additional requirements for employees. The Company also has the option to make discretionary profit-sharing contributions, which are subject to annual allocation conditions that require that employees be employed on the last day of the plan year and complete 1,000 hours of service during the applicable plan year.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contribution and an allocation of a) the Company safe harbor matching contributions, b) Company discretionary matching contributions and discretionary profit-sharing contributions, and c) Plan earnings or losses. The Company's safe harbor

matching and discretionary matching contributions are allocated among participants based upon each participant's elected deferral. The Company's discretionary profit-sharing contributions are allocated among participants based on the eligible compensation of participants. Plan earnings or losses are allocated on the basis of actual results of the investments selected by each participant. Investments are currently maintained in individual member accounts managed by John Hancock Life Insurance Company (John Hancock).

### ***Vesting***

Participants are immediately vested in their elective deferrals plus actual earnings thereon, as well as Company safe harbor matching contributions. The Company's discretionary matching and profit-sharing contributions credited to participants' accounts are vested based on years of continuous service. A participant is 20% vested after two years of credited service and vesting increases 20% per year until a participant is 100% vested after six years of credited service.

### ***Payment of Benefits***

Upon termination, retirement, disability, or death, the participant or beneficiary may elect to receive either a lump-sum or installment payments equal to the value of the vested funds allocated to the participant's account. Hardship withdrawals and in-service distributions are also permitted by the Plan. Distribution payments under \$7,000 (\$5,000 prior to January 1, 2024) are directly rolled over to an individual retirement account designated by the plan administrator in the event the participant does not elect otherwise. Benefits are recorded when paid.

### ***Forfeitures***

Upon a participant's termination of employment before normal retirement, disability, or death, the portion of their Company discretionary contributions not then vested shall be forfeited. The forfeitures account will be used to pay plan expenses or will be allocated to participants eligible for discretionary contributions. For the years ended December 31, 2024 and 2023, no forfeitures were used. There were no forfeited non-vested accounts at December 31, 2024 and 2023.

### ***Notes Receivable from Participants***

Participants currently employed by the Company may borrow from their fund accounts any amount up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes may not exceed five years unless it is a qualified home loan, and two notes are allowed at any one time. The notes are secured by the vested balance in the participant's account and bear interest at a commercially reasonable rate. Principal and interest are paid ratably through weekly payroll deductions.

### 2. Summary of Significant Accounting Policies

---

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

#### ***Basis of Presentation***

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

#### ***Presentation of Participant-Directed Funds***

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, *Plan Accounting – Defined Contribution Pension Plans*.

#### ***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 4 for further discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### ***Other***

Certain expenses of the Plan are paid directly by the Company and are excluded from these financial statements. Audit fees and fees related to administrative activities are paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments. Recordkeeping expenses and the fidelity bond premium are paid by the Company on behalf of the Plan.

#### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any interest that is earned at the end of each calendar year. Participant notes receivable are deemed past due

and in default after a scheduled payment remains unpaid beyond the last day of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment.

#### *Risks and Uncertainties*

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statements of net assets available for benefits.

#### *Subsequent Events*

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. The Plan and the Company have considered such events or transactions through July 28, 2025, noting no items for disclosure.

### 3. Information Certified by John Hancock

---

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by John Hancock except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

#### 4. Fair Value Measurements

---

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Pooled Separate Accounts:* Valued by calculating a unit value for each separate account investment based on the underlying assets, which include a mix of mutual funds, collective trusts and managed accounts. All underlying investment options are valued daily. This daily price is considered the selling price for transfers and withdrawals, and is calculated each day the principal market is open. The investment options are available for trading each day the principal market is open, and are available to any participation in the Plan, unless restricted by the plan administrator.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 5. Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested. Distribution to participants of the account balances would be made as soon as practicable after the termination date.

### 6. Tax Status

---

The Plan is qualified as a profit-sharing plan under Section 401(a) of the Internal Revenue Code and is exempt from federal income taxation under Section 501(a) of the Internal Revenue Code of 1986, as amended.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2020.

#### **7. Related Party Transactions**

---

Certain Plan investments are pooled separate accounts managed by John Hancock. John Hancock is the custodian as defined by the Plan and therefore, these transactions qualify as party-in-interest.
