We have performed audits of the accompanying financial statements of GCON 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Year Ended December 31, 2024

1. Description of plan:

The following description of the GCON 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. The Plan was established in January of 2015, and has been amended several times since that date.

General:

The Plan covers substantially all full-time employees, excluding collectively bargained employees, of GCON Management Company, LLC and Grand Island Commercial, which are collectively referred to as the Sponsor.

The Plan is a defined contribution retirement plan with 401(k) provisions consisting of a salary reduction arrangement. The Plan covers all employees of the Sponsor on the date of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participants' contributions:

Under the 401(k) provisions of the Plan, the participants may elect to defer up to 100% of their annual compensation, subject to current statutory limits determined annually and prescribed by the Internal Revenue Service (IRS). Participants are able to designate salary deferrals as Roth deferrals. Upon satisfying eligibility requirements, participants who do not affirmatively elect otherwise are automatically enrolled in the Plan with a pre-tax deferral of 3%.

Participants may elect to make catch-up contributions to the Plan. The Plan also permits participants to make additional voluntary contributions of qualified rollovers from other retirement plans.

Employer contributions:

Under the safe harbor provisions of the plan, the employer will contribute and allocate to each participants account an amount equal to 3% of the participants compensation. The Plan also allows for a discretionary employer match. Employees must be an eligible participant during the payroll period in order to receive the discretionary employer matching contribution. The Plan also allows for discretionary profit sharing contributions. Employees must have worked 500 hours or be employed on the last day of the plan year to be eligible for a profit sharing contribution. Employer contributions are invested in the same funds and increments as directed by the participant for the participant's contributions. There were no discretionary employer match contributions made during the current Plan year.

Participant accounts:

Each participant's account is credited with the participant's elective deferral and rollover contributions, allocations of the employer's contributions, plus actual earnings thereon, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements (continued)

Year Ended December 31, 2024

1. Description of plan (continued):

Vesting:

Participants are immediately vested in their elective deferral contributions, any rollover contributions made to the Plan, and safe harbor contributions plus actual earnings thereon. Vesting in the employer's discretionary match and contribution portion of the participants' accounts, plus actual earnings thereon, is based on years of credited service. Participants vest over two years of credited service and are fully vested with the completion of their second year, or upon the normal retirement date. The Plan defines a year of credited service to be 1,000 hours of service during the Plan year. Upon death or total disability of a participant prior to retirement, the participant's account balance shall become fully vested.

Participants' loans:

The Plan allows for participants to obtain loans from the Plan. All loans cannot exceed 50% of the vested portion of the participant's account (or \$50,000 if less). The loan must be repaid within five years unless the entire proceeds are used to purchase the participant's primary residence, in which case the loan may be repaid over a ten-year period. All loans will provide for the repayment of interest at a rate comparable to rates available at commercial lending institutions (prime rate plus two percent). The participant's individual account serves as collateral for the loan and, in the event of default, death, disability or termination of employment, the entire outstanding principal and accrued interest shall be immediately due and payable. Because the participant's account collateralizes the loan in its entirety, the credit quality of the participant is not assessed by the Plan Administrator. Unpaid loans will be treated as a taxable distribution from the Plan.

For financial reporting purposes, participants' loans are included in the statements of net assets available for benefits as notes receivable from participants.

Investment options:

Upon enrollment in the Plan, a participant may direct contributions in any increments into any of several investment options. Participants may change their investment options inside the platform at any time.

Payment of benefits:

On termination of service due to death, disability, retirement or other reasons, a participant whose vested account balance exceeds \$5,000 may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account. Participants with account balances less than \$5,000 must take a lump-sum distribution as soon as practicable following termination. Mandatory distributions under the Plan may be automatically rolled over to an IRA established on behalf of participants who do not affirmatively consent to receive their distributions. In-service distributions are permitted as provided for in the Plan document for participants age 59 1/2 or older.

Forfeited accounts:

The Plan allocates participant forfeitures to reduce Sponsor contributions, or to pay Plan expenses. During 2024, \$34,034 of forfeitures was used to reduce Sponsor contributions.

1. Description of plan (continued):

Hardship withdrawals:

If approved by the Plan Administrator, a participant may withdraw the portion of their elective deferral account balance to satisfy any of the following immediate and heavy financial needs: unreimbursed medical expenses for qualified persons, purchase of a principal residence, to prevent eviction from or foreclosure on a principal residence, to pay for post-secondary education expenses for qualified persons, funeral expenses or for expenses that qualify as a casualty deduction under the Internal Revenue Code (IRC).

2. Summary of significant accounting policies:

Basis of accounting:

The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates:

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition:

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of the fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Net appreciation in the fair value of investments includes both realized and unrealized gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants:

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payments of benefits:

Benefits paid to participants are recorded when paid.

2. Summary of significant accounting policies (continued):

Expenses:

Certain expenses of maintaining the Plan are paid by the Plan unless otherwise paid for by the Sponsor. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent event:

The Plan has evaluated the events that have occurred subsequent to December 31, 2024 through July 25, 2025, the date that the financial statements were available to be issued. The Plan has no responsibility to update these financial statements for events and circumstances occurring after this date.

3. Federal income tax status:

The Sponsor adopted a non-standardized pre-approved profit sharing plan, as published by Enterprise Pensions Inc, who obtained its latest opinion letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Sponsor believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, they believe that the Plan is qualified and the related trust is tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

4. Fair value measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets or active markets that the Plan does not have access to;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The assets in the preceding tables were measured primarily using the market approach. Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled separate accounts: These accounts' assets are invested and reinvested primarily in mutual funds. Investments are valued using pricing data provided by outside valuation service providers. Each account is valued at its net asset value, which is used as a practical expedient to estimate fair value. The net asset value of the accounts' units is determined daily and includes adjustments for investment fees.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Fixed income funds: These funds consist of professionally managed investment products primarily invested in debt instruments with the objective of generating income.

Target date funds: These funds consist of a blend of investments that are re-balanced over time to address retirement goals. Funds with longer horizons are invested more aggressively to achieve growth objectives while shorter-term funds are invested in more conservative securities with the objective of generating income.

5. Investments:

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by John Hancock Life Insurance Company (John Hancock). John Hancock served as recordkeeper and provided a certification as of December 31, 2024 and for the year then ended.

6. Related party and party in interest transactions:

Plan investments were managed by John Hancock. The Plan paid certain expenses to John Hancock, and other service providers during 2024 related to Plan administration and investment activity. These transactions qualify as exempt party in interest transactions under ERISA.

Expenses that are paid directly by the Sponsor are excluded from these financial statements. Employees of the Sponsor perform certain accounting and administrative functions for the Plan, however, no such officer or employee receives compensation from the Plan.

7. Plan termination:

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

8. Reconciliation of financial statements to Form 5500:

The Plan's investments in pooled separate accounts are reported on the Form 5500, Schedule H, as registered investment companies because a DFE Form 5500 has not been filed by the sponsor of the pooled separate accounts.

9. Risks and uncertainties:

The Plan invests in various investment securities that are exposed to risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
