### Note 1 – Plan Description

---

The following description of the Shentel Management Company 401(k) Retirement Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### *General*

The Plan is a defined contribution retirement plan covering substantially all employees of Shentel Management Company (the “Company”) and its affiliates. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### *Eligibility*

All full and part-time employees not in specifically excluded categories are eligible to participate in the Plan upon completion of 60 days of service. Participation begins on the first day of the month following the date the eligibility condition is satisfied. After sixty days of service, participants receive the Company’s Safe Harbor Nonelective and Qualified Nonelective contributions. Participants are eligible for the matching contributions after one year of service with at least 1,000 hours.

#### *Contributions*

Each year, participants may contribute up to 100% of annual compensation as pre-tax or Roth deferrals, as defined by the Plan, up to the maximum allowed by law. Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. Employees are automatically enrolled at an initial 4% of compensation deferral rate. In addition, the initial automatic deferral amount shall increase by 1% of compensation per year up to a maximum of 10% of compensation. All voluntary contributions are made by payroll deductions.

The Company matches employee contributions in amounts equal to 100% of each employee’s contributions on the first 2% of plan compensation and 50% on the next 2% of plan compensation. The Company also makes a safe harbor contribution of 3% of employees’ plan compensation each year. In addition, the Company made discretionary contributions of 2% of employees’ plan compensation in 2024 and 2023.

#### *Participant Accounts*

Each participant’s account is credited with the participant’s contributions, the Company’s matching and additional contributions, and allocations of Plan earnings and charged with an allocation of administrative fees. Allocations are based on participant account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

#### *Vesting*

Participants are immediately vested in their contributions and employer safe harbor contributions plus actual earnings thereon. A participant is 100% vested in employer matching and profit-sharing contributions after three years of continuous employment with at least 1,000 hours of service per year.

### *Payment of Benefits*

Upon termination of service, attainment of retirement age, or in the case of death or disability, participants may receive their accrued benefits in a single lump sum that can be rolled over into another qualified plan or paid in cash to the participant. Participants age 59½ or older may receive in-service withdrawals from their deferral and employer funded accounts. Hardship withdrawals are also permitted, subject to provisions described in the Plan document.

### *Notes from Participants*

Participants may borrow from their accounts an amount greater than \$1,000 but not to exceed the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one year to five years or a longer period established when the loan is negotiated for the purchase of a primary residence. Notes are secured by the balance in the participant's account and bear interest at a rate commensurate with market rates for similar notes as defined in the Plan. For the year ended December 31, 2024, interest rates ranged from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

### *Forfeited Accounts*

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$134,502 and \$174,273, respectively. Forfeitures can be used to reduce employer contributions and pay plan expenses. In 2024, forfeitures of \$65,502 were used to reduce employer contributions.

## **Note 2 – Significant Accounting Policies**

---

### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual method of accounting.

### *Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### *Investment Valuation and Income Recognition*

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset, or paid to transfer a liability, in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Notes from Participants*

Notes from participants are valued at the principal amount outstanding plus accrued interest.

*Administrative Expenses*

Plan fees and administrative expenses are paid by the Plan and Company on a discretionary basis.

*Benefit Payments*

Benefits are recorded when paid.

---

**Note 3 – Fair Value Measurements**

---

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with those of other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are used only when Level 1 or Level 2 inputs are not available.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

### *Level 1 Fair Value Measurements*

The fair values of the mutual funds are based on quoted net asset values of the shares held by the Plan at year-end.

### *Level 2 Fair Value Measurements*

The fair values of common investment trust funds are based on inputs that are observable for valuing the asset or liability, either directly or indirectly (i.e., interest rate and yield curves observable at commonly quoted intervals, default rates, etc.). Observable inputs include quoted prices for similar assets or liabilities in active or non-active markets. Level 2 inputs may also include insignificant adjustments to market observable inputs.

The common investment trust funds invest in securities that have observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets. While the underlying asset values are publicly quoted prices, the net asset value (NAV) of a unit in these funds is not publicly quoted. Units can be issued and redeemed on any business day at the NAV. All earnings and losses are reflected in the computation of the NAV and are realized by the participant upon withdrawal.

## **Note 4 – Related Party Transactions**

---

Certain administrative functions are performed by employees of the Company. These employees are also Plan participants. No such employee receives compensation from the Plan.

Plan participants invest in funds held or managed by the Plan Trustee, as well as other investment management companies. Investments in funds issued and managed by the Trustee are considered related-party transactions. Fees paid to the Trustee by the Plan for administrative services were \$100,318 for the year ended December 31, 2024, and are presented net of revenue credits used. Revenue credits generally represent the return of excess revenue generated by the Plan based upon the terms of the Service Agreement. Revenue credits are deposited to the Plan's revenue credit account and may be used to pay reasonable and necessary Plan expenses. Revenue credits totaling \$13,568 were used to pay Plan expenses for the year ended December 31, 2024. The Plan Sponsor may make a payment to T. Rowe Price Trust Company for administrative expenses not covered by revenue credits. Administrative expenses are presented as net of revenue credits.

---

#### Note 5 – Plan Termination

---

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

---

#### Note 6 – Tax Status

---

The Plan was restated and amended effective January 1, 2021 to an approved prototype plan sponsored by T. Rowe Price Retirement Plan Services, Inc. The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated August 19, 2020, that the Plan and related trust are designed in accordance with applicable sections of the *Internal Revenue Code (IRC)*. The Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the *IRC* and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.
