### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of Austin Hardware & Supply, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

## **Note 1. Description of the Plan**

### **General**

The following description of Austin Hardware & Supply, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the Plan Administrator.

The Plan is a defined contribution plan sponsored by Austin Hardware & Supply, Inc. (the Company) for the benefit of its employees who have satisfied the eligibility requirements and reached the defined entry date. An employee is eligible to participate for purposes of elective deferrals beginning the first day of the month following the completion of three months of service. For non-elective contributions and safe harbor employer matching contributions, an employee is eligible to participate upon the completion of one year of service (at least 1,000 hours of service) at the next available entry date. The Plan has two entry dates per year: the first day of the plan year (January 1) or the first day of the seventh month of the plan year (July 1). An employee's entry date is determined based on the nearest entry date following the date upon which eligibility requirements are met. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Alerus Financial, N.A. serves as plan custodian. Charles Schwab Bank serves as sub-custodian for the plan assets on behalf of Alerus Financial, N.A.

### **Contributions**

The Plan permits eligible employees, through a salary deferral election, to have the Company make annual contributions of up to 80% of eligible compensation and permits catch-up deferrals. Employee rollover contributions are also permitted. The Plan Document also allows for the Company to make profit sharing contributions. Company profit sharing contributions are discretionary as determined by the Company's board of directors. For the 2024 and 2023 plan years, the Company approved a discretionary profit sharing contribution equal to 7.5% and 10%, respectively, of eligible employee's gross compensation. The Company also makes a safe harbor matching contribution equal to 100% of the first 5% of employees' salary deferrals. Contributions are subject to certain limitations. Forfeitures are allocated as additional discretionary non-elective contributions at the end of each plan year based on compensation.

### **Participant Investment Account Options**

Investment account options available include various mutual funds and a guaranteed investment contract. Each participant has the option of directing his or her contributions into any of the separate investment accounts and may change the allocation daily.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Company's contribution, plan earnings and forfeitures of terminated participants' nonvested accounts and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their voluntary and any safe harbor contributions plus earnings thereon. Vesting in the Company's non-elective contribution portion (profit sharing contributions) of their accounts plus earnings thereon is based on years of continuous service. A participant receives graded vesting over six years and is fully vested in their non-elective contributions after six years of continuous service. The nonvested balance is forfeited upon termination of service. Forfeitures are allocated among active participants based upon compensation at the end of the plan year when forfeitures are realized (when a participant removes his/her balance from the Plan).

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to receive an immediate distribution of participant contributions and employer safe harbor matching contributions. Non-elective profit sharing contributions are subject to a \$25,000 annual distribution limit in years one and two following a participant's termination of service. The remainder of the non-elective balance is available for distribution the first day of the third quarter of the third plan year following termination. Accounts with less than \$5,000 will be distributed on termination of service. The participant can also elect a joint and survivor annuity distribution option.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$8,846 and \$11,448, respectively. These accounts will be reallocated to participants in the same manner as discretionary employer contributions.

***Notes Receivable from Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of the participants deferral account balance, \$50,000, or 50% of the participant's vested total account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is the prime rate of interest plus 1%. Participants can only have one outstanding loan at a time.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

The Plan's interest in the collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

See *Note 5* for a discussion of fair value measurements.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Custodian**

The Company has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Alerus Financial, N.A., a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Company provides certain administrative services at no cost to the Plan. The Plan paid \$90,000 and \$71,997 of recordkeeping and investment fees to Charles Schwab Bank, Alerus Financial, N.A., and a separate investment advisor during 2024 and 2023, respectively.

**Note 5. Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. Level 1 securities include mutual funds. If quoted market prices are not available, then fair values are estimated by using pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projection and cash flows. Such securities are classified in Level 2 of the valuation hierarchy and include a collective investment trust. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3. The Plan does not have any Level 3 securities.

**Note 6. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

**Note 8. Tax Status**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 9. Subsequent Events**

Subsequent events have been evaluated through July 29, 2025, which is the date the financial statements were available to be issued.
